The Economic Impact of Manufacturing in South Carolina





When viewed as one aggregate industrial sector, South Carolina's manufacturing sector represents the <u>largest industry cluster</u> in the State's economy.

Overview of Manufacturing

- Represents 4.5% of all establishments in the State
- Sector paid more than 20% of all wages in SC
- Represented more than 15% of all jobs

Recent Trends in Employment

Since 1998, the sector has lost more than 151,000 jobs.

During this same period, the state's local employment has grown by roughly 70,000 jobs

Manufacturing Wages

- The manufacturing sector pays wages well above that of the average industry in the state
- The average manufacturing wage of \$46,192 is more than 27% above the statewide average.

The manufacturing sector pays almost 13% of all property taxes in South Carolina although it represents only about 5% of all establishments in the state.

Summary

- The importance of manufacturing varies across the state.
 - * In some counties, the sector represents more than 20%
- Pays 13% of all property taxes more than 50% in some counties.
- Total Impact is \$141 billion a year
- Supports over 585,000 jobs directly and indirectly
