This is done as a precautionary measure due to the uncertainty of expenses that may be incurred by the employee health insurance program as a result of COVID-19.

- 20 SECTION 1. (A) The General Assembly hereby finds and declares that in light of the uncertainty regarding the expenses that 21 may be incurred by the State's employee health insurance program as a result of the public health emergency associated with the 2019 24 Novel Coronavirus (COVID-19), the provisions of Section 25 1-11-705(I)(2) of the 1976 Code are suspended for Fiscal Year 26 2020-2021.
- 27 (B) Notwithstanding any other provision of law, during Fiscal 28 Year 2020-2021, funds that would otherwise have been transferred to the South Carolina Retiree Health Insurance Trust Fund from the operating account for the State's employee health insurance program pursuant to Section 1-11-705(I)(2) may remain in the 31 32 operating account for the State's employee health insurance 33 program.
- (C) Upon the effective date of this joint resolution, if the 34 35 operating account for the State's employee health insurance 36 program has already made the transfer that subsection (A) suspends, 37 then, within ten days, the South Carolina Retiree Health Insurance 38 Trust Fund must reimburse the operating account for the amount of 39 the transfer.
