Summary of Bill:

Implements recommendations from the House Legislative Oversight Committee's 2018 study of the Department of Parks, Recreation and Tourism.

Seeks to modernize statutes relating to PRT's involvement with the Fort Watson Revolutionary War Memorial, which is on the shores of Lake Marion and is surrounded by the Santee National Wildlife Refuge. This was an old directive to instruct the agency to acquire the land and maintain it, but a number of years ago the property was deeded to the State Public Service Authority, which has managed the memorial for more than a decade.

SC Family Week and SC Family of the Year designations have not been observed in more than two decades. The agency views all 52 weeks as family weeks for South Carolina. No current agency personnel are aware of how it started or why it stopped.
