

## Current Law

(IN State- Residents)

### **Antlerless Deer (Bag limits to include doe days and doe tags) All game zones 1 per day**

- Game Zone 1 - Doe Days **3**; Archery dates (Oct. 1-10) **2**; Can use **1** doe tag= **6** total including archery and gun hunts. **4** total for gun hunts only
- Game Zone 2- Doe Days **6**; Archery dates (Sept. 15-30) **2**; Primitive Weapons dates (Oct. 3<sup>rd</sup> and 10<sup>th</sup>) **2**; Can use all **4** doe tags= Gun season **5 doe** limit. **9** does total (including archery, primitive weapons and gun season)
- Game Zone 3- Doe Days **8**; Can use all **4** doe tag= **12** total
- Game Zone 4- Doe Days **8**; Can use all **4** doe tag= **12** total

### **Antlered Buck Bag Limit**

Game Zone 1- 2 per day and 5 per season

Game Zone 2- 2 per day and 5 per season

Game Zone 3- No limit

Game Zone 4- No limit

### **Cost**

- Must purchase SC hunting license plus purchase of big game permit
- No charge to kill antlered bucks or does (on doe days) Option to purchase up to 4 additional doe tags at \$5 each

## H.4943

(IN State-Residents)

With the Purchase of SC hunting license and big game permit you will receive:

- 8 doe day specific tags
- 3 buck tags

Hunters (including youth and gratis licensees) have the option to purchase the following:

- 2 additional buck tags (with 4 pts on 1 side or a minimum 12-inch antler spread) at **\$5 each** 100% OF THE MONEY COLLECTED WILL GO TOWARDS COYOTE MANAGEMENT PROGRAM
- 4 additional doe tags at **\$5 each**

### **Antlerless and Antlered Deer Limits per day:**

- 2 doe taken/ day
- 2 bucks taken/ day

### **Antlerless BAG limits are set in REGS:**

- Game Zone 1: **11** deer total; **6** does all seasons combined; **4** does gun hunts only; **5** bucks
- Game Zone 2: **12** deer total; **7** does all season combined; **5** does gun hunts only; **5** bucks
- Game Zones 3 & 4: **17** deer total; **12** does; **5** bucks

**\*\*\*\*You can only use 1 doe date specific tag per day; if you choose to kill 2 does in 1 day you would have to use your individual doe tags that you purchase for \$5 each. You can only use your purchased individual doe day tags after Sept. 15<sup>th</sup>.**

(Non-Residents)

Purchase of Hunting license and big game permit

**Tags**

Can purchase up to **4** additional doe tags at **\$5** each

**H.4943**

(Non-Residents)

Purchase of Hunting license and big game permit

Cost:

**Tags**

- **\$50** for the first purchased **antlered** tag and **\$20** for each purchased **antlered** tag thereafter ( maximum purchase of 4; 2 of which must have size restriction)
- **\$10** for each **antlerless** tag purchased
- Total revenue from tags **could** generate **up to \$150/out-of-state hunter**

**Antlerless BAG limits are set in REGULATIONS**
