## HOUSE ETHICS COMMITTEE MAY 22, 2019 ADVISORY OPINION IN THE MATTER OF ANNIE E. MCDANIEL COMPLAINT NO. C2019-013

This is in response to the State Ethics Commission's (herein "SEC") Recommendation and Investigative Report (herein "Report") dated May 17, 2019. The House Legislative Ethics Committee (herein "Committee") met on Wednesday, May 22, 2019 and issues the following advisory opinion pursuant to S.C. Code Section 8-13-540(a).

## **BACKGROUND**

On August 23, 2018, the SEC received a complaint filed by MaryGail Douglas against Respondent Annie E. McDaniel, then candidate in the June 18, 2018 primary election and the November 6, 2018 general election for House of Representatives District 41. Said complaint alleged Respondent reported a reimbursement for gas instead of mileage, paid a family member more than fair market value, made questionable payments to campaign staff, and mailed a communication within 45 days of the primary election to influence the election. The SEC performed a thorough investigation, which did not reveal any evidence to support the allegation of overpayment to Respondent's mother or any evidence of improper payments to campaign workers. Further, the investigation did not reveal any evidence to support an actionable offense related to the mailer in question. However, review of the Respondent's personal and campaign bank records and campaign disclosure reports did reveal evidence to support offenses. As such, the SEC recommends that the Committee find probable cause is present and charge Respondent with four (4) counts of violation of § 8-13-1308(F)(2) for failing to disclose campaign contributions; thirteen

(13) counts of violation of § 8-13-1312 for failure to pay campaign expenditures from a campaign account; and three (3) counts of violation of § 8-13-1308(F)(4) for failing to disclose campaign expenditures. On May 22, 2019, the Committee met to consider, *inter alia*, this matter.

## **FINDINGS**

Upon review of the SEC's recommendation and relevant evidence, the Committee makes the following findings:

## I. S.C. Code § 8-13-1308(F)(2)

S.C. Code Ann. Section 8-13-1308(F)(2) provides that certified campaign reports detailing campaign contributions and expenditures must contain the name and address of each person making a contribution of more than one hundred dollars and the amount and date of receipt of each contribution.

A review of Respondent's campaign bank records and filings revealed that Respondent failed to identify on her campaign disclosure reports four campaign contributions, which were deposited in her campaign bank account. Those specific contributions are shown below in Table 1.

Therefore, the Committee finds probable cause is present and charges Respondent with four (4) counts of violation of § 8-13-1308(F)(2) for failing to disclose campaign contributions.

## II. S.C. Code § 8-13-1312

## S.C. Code Ann. Section 8-13-1312 provides:

Except as is required for the separation of funds and expenditures under the provisions of Section 8-13-1300(7), a candidate shall not establish more than one campaign checking account and one campaign savings account for each office sought, and a committee shall not establish more than one checking account and one savings account unless federal or state law requires additional accounts. For purposes of this article, certificates of deposit or other interest bearing instruments are not considered separate accounts. A candidate's accounts must be established in a financial institution that conducts business within the State and in an office located within the State that conducts business with the general public. The candidate or a duly authorized officer of a committee must maintain the accounts

in the name of the candidate or committee. An acronym must not be used in the case of a candidate's accounts. An acronym or abbreviation may be used in the case of a committee's accounts if the acronym or abbreviation commonly is known or clearly recognized by the general public. Except as otherwise provided under Section 8-13-1348(C), expenses paid on behalf of a candidate or committee must be drawn from the campaign account and issued on a check signed by the candidate or a duly authorized officer of a committee. All contributions received by the candidate or committee, directly or indirectly, must be deposited in the campaign account by the candidate or committee within ten days after receipt. All contributions received by an agent of a candidate or committee must be forwarded to the candidate or committee not later than five days after receipt. A contribution must not be deposited until the candidate or committee receives information regarding the name and address of the contributor. If the name and address cannot be determined within seven days after receipt, the contribution must be remitted to the Children's Trust Fund.

A review of Respondent's personal bank records revealed thirteen campaign expenditures paid for using Respondent's personal credit card. The Committee notes that these expenditures were disclosed as expenditures on the Respondent's campaign disclosure reports. Because these expenditures were reported on the Respondent's campaign disclosure reports, the Committee finds no violation of South Carolina Code Section 8-13-1312. Use of personal funds to pay campaign expenditures is permissible; however, this type of payment must be disclosed as an in-kind contribution with a corresponding in-kind expenditure. The specific expenditures at issue are shown below in Table 2.

Therefore, the Committee finds there is not competent and substantial evidence that a violation of § 8-13-1312 has occurred.

## III. S.C. Code § 8-13-1308(F)(4)

S.C. Code Ann. Section 8-13-1308(F)(4) provides that certified campaign reports detailing campaign contributions and expenditures must contain the name and address of each person to whom an expenditure is made from campaign funds, including the date, amount, purpose, and beneficiary of the expenditure.

A review of Respondent's campaign bank records and filings revealed that Respondent failed to identify on her campaign disclosure reports three campaign expenditures. Those specific expenditures are shown below in Table 3.

Therefore, the Committee finds probable cause is present and charges Respondent with three (3) counts of violation of § 8-13-1308(F)(4) for failing to disclose campaign expenditures.

## CONCLUSION

Accordingly, the Committee hereby **CONCURS** in part with the SEC's recommendation and finds probable cause is present to charge Respondent with four (4) counts of violation of § 8-13-1308(F)(2) for failing to disclose campaign contributions; and three (3) counts of violation of § 8-13-1308(F)(4) for failing to disclose campaign expenditures. (See Findings Sections I and III).

The Committee hereby **NONCONCURS** in part with the SEC's recommendation and finds there is not competent and substantial evidence that a violation of § 8-13-1312 has occurred. (See Findings Section II).

The Committee additionally **FINDS** that Respondent must pay a penalty of \$100.00 (One Hundred Dollars and 00/100) within thirty (30) days of the date of this Advisory Opinion.

The Committee **ORDERS** Respondent to submit campaign bank account records to the House Ethics Committee with the July 2019 and October 2019 quarterly campaign disclosure filing for an audit by HEC staff.

Finally, the Committee **NOTES** that there are no findings to suggest that the Respondent engaged in intentional misconduct nor did Respondent attempt to procure any personal gains.

Please find attached a formal complaint form and supporting documentation to look-into-possible-violations-as-they-pertain-to-recent-campaign-activity-leading-up-to the Democratic Primary of June 12, 2018.

There are a number of issues in question. They are among the following:

- Per campaign disclosure report: 6/5/18 is an expense for mileage at a Circle K in the amount of \$25,00
- Per campaign disclosure report: 6/12/18 is an expense to Ms. McDaniel's mother for phone calls in the amount of \$100. Question payment to family.
- Earl Stringfellow is listed as a campaign contractor. He is a minister in Chester, S. C. and the question is raised as to whether he can legitimately receive the pay as a campaign manager; and the second part is if this amount is reported as income to DOR/IRS. This amount represents \$3500.00 as of the July 10, 2018 report. In early announcements of Ms. McDaniel's campaign, Sam Broome announced in a public meeting that he was the campaign manager. Campaign disclosure report: June 12, 2018, Mr. Broome received \$112.00 and that is the only entry for him. Description of this expenditure was for poles and sign supplies.
- A mailer went into boxes in District 41 5 days before the primary. Per campaign disclosure report: June 5 and 6: Expenditures for printing postcard and mailing in the amount of \$1544.96. These expenditures were to Columbia Printing and Graphics and to Campaign Research Strategies.

Referencing Section 8-13-1300 (31)(C). This states, "Any communication made, not more than forty-five days before and election, which promotes or supports a candidate or attacks or opposes a candidate, regardless of whether the communication expressly advocates a vote for or against a candidate..."

This postcard clearly violates that part of the ethics rules.

I appreciate your interest and assistance into this matter and will be available to answer any additional information that may help in resolving these issues. I will continue to pursue this until the proper attention is given to these types of practices. If we do not hold public officials accountable for wrongful behavior, we will be hard pressed to find decent and honorable people to serve the people of our state. Please know how much I appreciate the job you have and what it means to hold people responsible for inappropriate behaviors in our political world.




