Supplemental Sheet to Complaint Complainant: S.C. House Legislative Ethics Committee (HEC) Respondent: Former House Candidate Kathryn Roberts (Roberts) February 10, 2022

On or about September 2021, HEC staff identified Roberts as a potential candidate for the administrate closure of her campaign account due to a number of factors, including lack of activity, failure to file Campaign Disclosure, and failure to respond to written and oral correspondences from HEC staff. She failed to pay ethics fines owed that total \$26,950.00 as of February 10, 2022. Following Administrative Closure Protocol adopted by the HEC, The Bancorp Bank was served a Subpoena Ducas Tecum dated October 5, 2021 to obtain relevant bank records from the campaign account of Roberts. NIC South Carolina identified Fisher's campaign bank account as "Chime - The Bancorp Bank" at 409 Silverside Rd, Wilmington, DE 29809 and provided the bank account number Fisher listed. Bancorp Subpoena Analyst Alyssa Barkley responded that the account number listed does not appear to be a valid Bancorp number but the card recovered was a PayPal Business Debit Mastercard. HEC staff contacted Ms. Barkley who explained that Chime is separate from Bancorp and the bank could be Stride Bank NA. On November 8, 2021, a second Subpoena Duces Tecum was sent to Stride Bank, NA to obtain the campaign bank account records of Roberts. On December 3, 2021, Stride Bank sent documents in response to the subpoena and stated "please note that this is a Chime Financial Deposit Account not a traditional bank account. This is an online bank only and there are no branches. Stride Bank is the card issuer for Chime Financial." The Account Information sheet indicated Roberts opened up a Personalized Visa on April 14, 2020. (Exhibit A, Chime account records). The Chime account appears to be Roberts' personal account upon HEC staff's review of the documents provided. S.C. Code Ann. Section 8-13-1312 requires "A candidate's accounts must be established in a financial institution that conducts business within the State and in an office located within the State that conducts business with the general public."

Roberts filed four campaign disclosure reports, three of which were late. She has not filed her last four required campaign disclosure reports. Her Initial Campaign Disclosure Report indicated she made a \$100 contribution on April 14, 2020. Her

last report indicated negative contributions on hand at period end. (Exhibit B, Campaign Disclosure Reports and 2020 Statement of Economic Interests). HEC staff sent fine letters on the following dates for late or not filed reports: April 7, 2020, July 17, 2020, January 21, 2021, April 19, 2021, May 11, 2021, July 19, 2021, October 19, 2021, and January 19, 2022. (Exhibit C, fine letters). Staff tried to contact her by phone on April 15, 2020, July 15, 2020, July 22, 2020, August 6, 2020, August 7, 2020, September 2, 2020, January 15, 2021, February 3, 2021, April 13, 2021, April 22, 2021, July 7, 2021, and July 22, 2021. E-mails were also sent by staff on June 28, 2021, July 26, 2021, August 3, 2021, January 12, 2022, and January 14, 2022. Letter sent on December 21, 2021. (Exhibit D, Entries from the House Ethics Committee's master excel log sheets for 2020 - 2022 on Roberts and e-mails). Thus, the HEC cannot confirm the proper use of campaign funds by Roberts as she did not set up a campaign bank account and she failed to file required Campaign Disclosure Reports. Thus, the HEC has identified potential violations resulting from the subpoena duces tecum of Cannon's campaign bank account records. Therefore, the HEC is referring the Committee's complaint regarding Cannon to the State Ethics Commission for investigation as to whether violations of Section 8-13-100 et seq of the Ethics, Government Accountability, and Campaign Reform Act of 1991 occurred.







"A candidate's accounts must be established in a financial institution that conducts business within the State and in an office located within the State that conducts business with the general public." S.C. Code Ann. Section 8-13-1312.

We request that within thirty days of the date of this letter that you migrate your ethics account to the new filing system. The link is copied below with instructions.

COMMISSION RECOMMENDATION

The State Ethics Commission recommends that the House Ethics Committee find probable cause is present and charge Respondent with the following:

- Six (6) counts of violating Section 8-13-1308(B) for failing to file the following Campaign Disclosures (CD): Quarter 1, 2021; Quarter 2, 2021; Quarter 3, 2021; Quarter 4, 2021; Quarter 1, 2022; and Quarter 2, 2022;
- 2. One (1) count of violating Section 8-13-1312 for failing to open a campaign bank account;

- 3. One (1) count of violating Section 8-13-1308(F)(1) for failing to disclose three (3) campaign contributions totaling \$135.00;
- 4. One (1) count of violating Section 8-13-1308(F)(3) for failing to disclose an expenditure of \$208.00;
- 5. Seven (7) counts of violating Section 8-13-1312 for failing to timely deposit seven (7) campaign contributions into a campaign bank account;
- 6. Two (2) counts of violating Section 8-13-1302 for failing to maintain records related to expenditures.

This is in response to the State Ethics Commission's (herein "SEC") Recommendation for Probable Cause dated July 22, 2022. The House Legislative Ethics Committee (herein "Committee") met on Monday, August 29, 2022 and issues the following advisory opinion pursuant to S.C. Code Section 8-13-540(a).

BACKGROUND

Kathryn Roberts (Respondent) was a former candidate for House District 48 in the general election held on November 3, 2020. On or about September 2021, Committee staff identified Respondent as a potential candidate for the administrate closure of her campaign account due to a number of factors, including lack of activity, failure to file campaign disclosures, and failure to respond to written and oral correspondences from Committee staff. As of August 29, 2022, she failed to pay ethics fines owed that total \$38,250.00.

Respondent filed four campaign disclosure reports, three of which were late. She has not filed her last five required campaign disclosure reports. Her Initial Campaign Disclosure Report (CDR) indicated she made a \$100 contribution on April 14, 2020. Her last report indicated negative contributions on hand at period end.

The Committee met on February 10, 2022 and referred the complaint to the SEC as to whether violations of Section 8-13-100 *et seq* of the Ethics, Government Accountability, and Campaign Reform Act of 1991 occurred. Specifically, the Committee could not confirm the proper

use of campaign funds by Respondent as she did not set up a campaign bank account and she failed to file required campaign disclosure reports (CDRS). On February 14, 2022, Executive Director of the SEC, Meghan L. Walker, reviewed the complaint, determined it contained facts sufficient, and ordered an investigation. On July 22, 2022, the SEC having met, considered, and duly investigated the Complaint against Respondent, issued a recommendation to the Committee for a finding of probable cause. Specifically, the SEC recommended that the Committee find probable cause is present and charge Respondent with the following ethics violations:

- 1. 6 counts of violating Section 8-13-1308(B) for failing to file the following CDRS: Quarter 1, 2021; Quarter 2, 2021; Quarter 3, 2021; Quarter 4, 2021; Quarter 1, 2022; and Quarter 2, 2022;
- 2. I count of violating Section 8-13-1312 for failing to open a campaign bank account;
- 3. 1 count of violating Section 8-13-1308(F)(1) for failing to disclose three (3) campaign contributions totaling \$135.00;
- 4. I count of violating Section 8-13-1308(F)(3) for failing to disclose an expenditure of \$208,00;
- 5. 7 counts of violating Section 8-13-1312 for failing to timely deposit seven (7) campaign contributions into a campaign bank account;
- 6. 2 counts of violating Section 8-13-1302 for failing to maintain records related to expenditures.

Total Ethics Violations: 18.

On August 29, 2022, the Committee met to consider, inter alia, this matter.

FINDINGS

Upon review of the SEC's recommendation and relevant evidence, the Committee makes the following findings:

I. S.C. Code § 8-13-1308 Violations

Failure to File Campaign Disclosures, Failure to disclose three (3) campaign contributions totaling \$135.00, and Failure to Disclose an Expenditure of \$208.00 for the Filing Fee

- S.C. Code Section 8-13-1308 provides, in relevant part:
 - (B) Following the filing of an initial certified campaign report, additional certified campaign reports must be filed within ten days following the end of each calendar quarter in which contributions are received or expenditures are made, whether before or after an election until the campaign account undergoes final disbursement pursuant to the provisions of Section 8-13-1370
 - (F)(1) certified campaign reports detailing campaign contributions and expenditures must contain: the total of contributions accepted by the candidate or committee; the name and address of each person

making a contribution of more than one hundred dollars and the amount and date of receipt of each contribution

(F)(3) the total expenditures made by or on behalf of the candidate or committee.

SC Code Ann § 8-13-1308(B), (F)(1), and (F)(3) (2019).

The investigation of Respondent's campaign disclosure reports and bank statements indicated that there were 6 counts of violating Section 8-13-1308(B) for failing to file the Quarter 1, 2021, Quarter 2, 2021, Quarter 3, 2021, Quarter 4, 2021, Quarter 1, 2022, and Quarter 2, 2022 CDRS. The investigation further revealed that if Respondent amended her reports to include contributions and expenditures not reported, she will have a \$12.14 balance on her CDR, rather than the current negative balance of \$117.52. See Chart, Total Contributions and Expenditures, which is attached hereto and made a part hereof.

The investigation also revealed that Respondent did not document three contributions totaling \$135.00 received from ActBlue on her Campaign Disclosure Reports (CDRS) as follows:

\$25.00 contributed on 7/5/20 by Albert Rogat, \$100.00 contributed on 9/6/20 by John Dodd, and \$10.00 contributed on 10/25/20 by Barbara Koller.

Finally, the investigation revealed that Respondent paid her \$208.00 filing fee to run in the 2020 election from her personal bank account. The investigation further revealed that Respondent did not document on her CDR, her April 14, 2020 expenditure of \$208.00 to the SC Democratic Party.

Therefore, the Committee finds probable cause is present and charges Respondent with one violation of § 8-13-1308 for failure to file CDRS and failure to disclose three contributions on her CDRS. The Committee does not find probable cause is present to charge Respondent with one violation of § 8-13-1308(F)(3) for paying her filing fee from her personal bank account.

II. S.C. Code § 8-13-1312

Failure to Open a Campaign Bank Account and Failure to Timely Deposit Seven Campaign Contributions into a Campaign Bank Account

S.C. Code Section 8-13-1312 provides, *inter alia*, that "Except as is required for the separation of funds and expenditures under the provisions of Section 8-13-1300(7), a candidate shall not establish more than one campaign checking account and one campaign savings account for each office sought, . . . A candidate's accounts must be established in a financial institution that conducts business within the State and in an office located within the State that conducts business with the general public. The candidate or a duly authorized officer of a committee must maintain the accounts in the name of the candidate or committee . . . All contributions received by the candidate or committee, directly or indirectly, must be deposited in the campaign account by the candidate or committee within ten days after receipt. All contributions received by an agent of a

candidate or committee must be forwarded to the candidate or committee not later than five days after receipt. \dots "

S.C. Code Ann § 8-13-1312 (2019).

The investigation revealed that Respondent did not open a campaign bank account. It also revealed that Respondent deposited five contribution checks that she received from ActBlue into her personal bank account at Wells Fargo.

The investigation also revealed that there was an ATM deposit of \$206.49 on October 28, 2020, of 5 checks from ActBlue made out to "Friends of Kathryn Roberts," into Respondent's personal bank account as follows:

\$24.01 dated 7/5/20; \$96.05 dated 8/16/29; \$48.02 dated 8/13/20; \$28.81 dated 9/27/20; and \$9.06 dated 10/11/20.

Therefore, the Committee finds probable cause is present and charges Respondent with one violation of § 8-13-1312 for failure to open a campaign bank account. However, the Committee does not find probable cause to charge Respondent with one violation of § 8-13-1312 for failing to timely deposit five contributions as the investigation did not determine the <u>date of receipt</u> of the ActBlue checks by Respondent; rather the date on the checks were used in recommending probable cause.

III. S.C. Code § 8-13-1302(A) Failure to Maintain Records Related to Expenditures

S.C. Code Section 8-13-1302(A)(5) provides "A candidate, committee, or ballot measure committee must maintain and preserve an account of: . . . all receipted bills, canceled checks, or other proof of payment for each expenditure,

The investigation revealed that Respondent did not maintain the expenditure records for her \$150.00 expenditure to Sticker Mule on September 26, 2020 for magnets (disclosed on her CDR) and her ActBlue maintenance fees of \$12.86 (not disclosed on her CDRS).

Therefore, the Committee finds probable cause is present and charges Respondent with one violation of § 8-13-1302 for failure to maintain records related to expenditures.

CONCLUSION

Accordingly, the Committee hereby CONCURS with the SEC's recommendation and finds probable cause is present to charge Respondent with the following ethics violations:

1. One violation of Section 8-13-1308 for: failing to file the following CDRS: Quarter 1, 2021; Quarter 2, 2021; Quarter 3, 2021; Quarter 4, 2021; Quarter 1, 2022; and Quarter 2, 2022; and failing to disclose three (3) campaign contributions totaling \$135,00.

- 2. One violation of Section 8-13-1312 for falling to open a campaign bank account; and
- 3. One violation of Section 8-13-1302 for failing to maintain records related to expenditures.

The Committee NONCONCURS with the SEC's recommendation of probable cause on the following:

- 1. One violation of Section 8-13-1308(F)(3) for failing to disclose the filing fee of \$208.00; and
- 2. One violation of Section 8-13-1312 for failing to timely deposit campaign contributions into a campaign bank account.

The Committee additionally FINDS that Respondent currently owes \$38,250.00 in fines for late ethics fillings. Thus, this should be considered the penalty owed by Respondent and it should be paid within thirty (30) days of the date of this Advisory Opinion.

The Committee **ORDERS** Respondent, with the assistance of Committee staff, to file the CDRS not yet filed, amend her CDRS as noted in the SEC's investigation, and to file her Final CD report within thirty (30) days of the date of this Advisory Opinion. The Committee notes that Staff is permitted to file a technical accounting error correction for the Final CDR, if necessary.
