This letter informed you that if the matter was not rectified, it would result in a public reprimand being issued against you by the Committee.

Therefore, the Committee makes the following findings:

- 1) A fine in the amount of \$100 is due and owing from you.
- 2) This fine is for not filing your April 2018 Campaign Disclosure Report.
- 3) At least one attempt by letter was made on behalf of the Committee to notify you of the fine.
- 4) As of November 8, 2018, the fine was not paid.

Because of the foregoing findings, the Committee hereby issues a **public reprimand** for your failure to comply with the South Carolina Ethics Act and, further, for your failure to comply with the direction from the House Legislative Ethics Committee.

Further, you are ordered to make immediate payment of the fine detailed in this reprimand to the House Legislative Ethics Committee.
