In State Grand Jury cases, the clerk of court is supported by our office but is answerable to the court, so our ability to quantify results potentially creates over-reach. Performance measures could create undue influence on prosecution decisions as outlined by the ABA rules of conduct for solicitors as to the decision to charge, relations with the grand jury, and disposition decisions. The mere establishment of such bench marks may undermine individual cases and lead to litigation from defense attorneys.

As with criminal prosecution, post-conviction case flow is largely out of our control. The number and type of cases are out of our control and dependent upon criminal conviction rates in the 16 circuits. Once received, a further limitation is placed upon the terms of court and the docketing process of the Court of Appeals and Supreme Court. The cases and issues literally differ in each case and quantifiable measures cannot equally be placed on simple possession and murder cases. This office also handles federal appeals Habeas Corpus cases, and we have even less ability to influence the flow of dockets.

Securities and civil litigation have a similar problem as criminal prosecution and litigation. Securities fines cannot be subject to a quota or pre-determined process goals without potentially violating individual rights to due process. Civil matters are dependent upon several factors, and any decision to pursue cases is based upon the impact to the state and its citizens, not the potential recovery.

For the reasons outlined herein, applying performance measures to the OAG potentially undermines professional conduct issues of the legal profession. As we operate like a law office, without the profit incentive, indicators as requested have adverse consequences. There are 50 different Attorney General Office structures, so there is no ready comparison available. Therefore, we request this office be recognized as a professional organization under limiting rules and the key performance measures not be applied.
