The Executive Subcommittee appreciates the agency's partnership in the oversight process. As follow up from the meeting on November 20, 2017, the Subcommittee seeks additional information from the agency. Please provide this information by Monday, December 11, 2017.

Employee Satisfaction/Morale Surveys

1. The agency mentioned it is utilizing a climate survey of its military personnel to develop a similar survey for state civilian personnel. When the agency finishes developing this survey, would it share the format and process with other state agencies who may wish to utilize a similar format for their agency personnel?

Youth Challenge

2. Please provide options for potential deadlines for school districts to submit necessary documents related to students who drop out of the school, which may enable Youth Challenge (YC) to run more efficiently.
3. Please provide the following information for each of the last three years:
 - a. Number of students, by county, in YC;
 - b. Number of students, by county, referred to YC as an alternative sentence;

- c. Number of students referred to YC as an alternative sentence that did not complete or were otherwise removed from the program resulting in a referral back to the juvenile justice system; and
 - d. Base student cost that is transferred from the students' current school district, to the school district in which YC operates.
4. Please provide the data YC submits to the federal government related to the program's performance.

SC Emergency Management Division (EMD)

- 5. Please provide a list of "off the shelf" contracts currently available to EMD.
- 6. Please provide a list of events (e.g., nuclear, hurricane, etc.) for which EMD currently has plans available.
- 7. For each of the disasters during the last four years in which the agency assisted, please provide a list of the stand-by contracts triggered, amounts spent, and services provided.

In responding to these questions, please remember the Committee's expectations which are provided in the Committee's Standard Practice 9.

The Subcommittee looks forward to working collaboratively with the agency during the oversight process. Thank you and your team for your service to the citizens of South Carolina.
