Meetings Regarding the Agency

The Committee meets with, or about, the agency on two occasions, and the Subcommittee meets with, or about, the agency on two occasions. All meetings are open to the public and stream live online; also, the videos are archived and the minutes are available online. A timeline of meetings and other actions is set forth in Figure 3, followed by a description of each meeting.

December 9, 2019	At Meeting 1, the Committee selects SC Arts Commission as the next agency for the Education and Cultural Subcommittee to study.
January 15, 2020	The Committee provides the agency with <u>notice</u> about the oversight process.
February 28 – April 1, 2020	The Committee solicits input from the public about the agency in the form of an online public survey .
March 13, 2020	SC Arts Commission submits its Program Evaluation Report.
April 8, 2021	At Meeting 2 the Committee receives public input about the agency.
April 15, 2021	The Subcommittee holds Meeting 3 with the agency to discuss an overview of its mission, history, resources, major programs, successes, challenges, and emerging issues.
May 18, 2021	The Subcommittee holds Meeting 4 with the agency to discuss Agency Finances; Compliance and Risk Management; Agency Successes, Challenges and Emerging Issues; Organizational units; and Deliverable Group 1.
June 15, 2021	The Subcommittee holds Meeting 5 with the agency to discuss Deliverable Groups 2-6.
October 1, 2021	The Subcommittee holds Meeting 6 with the agency to discuss Deliverable Groups 4-6; and collaboration with the Department of Education and the receipt of Elementary and Secondary School Emergency Relief Fund support.
October 25, 2021	The Subcommittee holds Meeting 7 with the agency to discuss the legislative declaration creating the agency, its understanding or interpretation of the declaration's legislative intent, and provide further clarification regarding the Arts Education Data Project.

SECTION 60-15-10. Legislative Declaration of Policy

It is hereby declared to be the policy of the State to join with private patrons and with institutions and professional organizations concerned with the arts to ensure that the role of the arts in the life of our communities will continue to grow and play an ever more significant part in the welfare and educational experience of our citizens.

It is further declared that all activities undertaken by the State in carrying out this policy shall be directed toward encouraging and assisting rather than limiting the freedom of artistic expression that is essential for the well-being of the arts.

Community Engagement and Creative Placemaking

- Creative Placemaking: A process where community members, artists, community developers, and other stakeholders use arts and cultural strategies to implement community-led change.
- The Arts Commission is committed to serving all South Carolinians. The encouragement of community engagement and connection is about growing healthy vibrant communities. Arts and culture are a vital component of healthy communities and our goal is to work with citizens throughout our state to support those communities.
- SCAC has a long history of broad support from the General Assembly in fostering "the role of the arts in the life of our communities" and improving "the welfare and educational experience of our citizens."

Upstate and Lowcountry Brought Together

Through arts education programming at the **Newberry** Arts Center, adults, students and children have the opportunity to try their hands at painting, pottery, drawing, printmaking, felting and storytelling in classes, camps and local events.

Summer arts programming and afternoon arts classes for K-7 emphasized literacy by asking students to write about their experiences creating art and learning from the weekly guest artists.

Gullah Artist of **Beaufort**, Anita Singleton-Prather – aka 'Aunt Pearlie Sue' – shown with Newberry Fire Department members, introduced children at Newberry Art Center's Summer Art Camps to the culture and cuisine of the Lowcountry through storytelling, and by preparing for them a large batch of Gullah Gumbo.

SC Arts Alliance's Arts Advocacy Day

Arts Advocacy Day is an annual day for statewide arts advocacy hosted by the SC Arts Alliance, a nonprofit organization.

- The mission of the SC Arts Alliance is to advance the arts for all South Carolinians through advocacy, leadership development, and public awareness. The Arts Alliance represents South Carolina as part of a network of state arts advocacy alliances.
- Examples of Arts Alliance programs: nonprofit board development, public awareness of legislation that impacts the arts and arts education (both at the state and national levels), professional learning opportunities for arts leaders, Arts Grow SC arts industry certification for high school students.

SC Arts Alliance's Arts Advocacy Day

Arts Advocacy Day is an annual day for statewide arts advocacy hosted by the SC Arts Alliance, a nonprofit organization.

- Advocacy is a process by which members of the general public work together to educate, inform, and raise awareness of arts and culture-related issues.
- The Alliance has designed Arts Advocacy Day to celebrate and advocate for the arts across South Carolina. Activities have included a legislative meal, student performances, and individual/group citizen meetings with legislators. Attendees often include individuals from local arts organizations, artists, community leaders, students, and the general public.
- Role of Arts Commission: Executive Director is invited to share updates about the state of the arts in South Carolina.

Arts Education Data Project

- Adopting a systemic, data-driven approach to understanding the current condition of arts education in the United States serves as the catalyst to increase student participation in arts education in all schools across the country.
- Known as the Arts Education Data Project, this initiative is accomplished by taking data gathered by each state department of education, standardizing the data and then transforming it into a publicly available interactive dashboard, updated annually to reflect the true status of arts education in every school and grade level.
- By 2022, thirty (30) states will be working on this project, including Virginia, Tennessee, North Carolina, and Georgia.
