These laws were certainly meant to increase incarceration in an attempt to crack down on crime, but its implementation doesn't prove to have done much in fixing the drug epidemic. It's only led to more and longer prison sentences, more prison cells, and more aggressive policing. Does the 1980s and '90s laws still make sense?
