## Discussion of the S.C. Department of Corrections

- I. Ad hoc subcommittee Chairman Tallon explains the purpose of today's meeting is to receive public testimony, continue discussion of the agency's legal and compliance unit, and discuss the agency's administration unit.
- II. Ad hoc subcommittee Chairman Tallon explains that all testimony given to this subcommittee, which is an investigating committee, must be under oath. He reminds agency personnel previously sworn in that they remain under oath. Ad hoc subcommittee Chairman Tallon swears in the following individuals:

- III. Ad hoc subcommittee Chairman Tallon recognizes Ms. Christa Williams to provide public testimony. Ms. Williams provides testimony and members ask questions. Ms. Williams and agency personnel answer member questions.
- IV. Ad hoc subcommittee Chairman Tallon recognizes Dr. Pamela Crawford to provide public testimony. Dr. Crawford provides testimony and members ask questions. Dr. Crawford and agency personnel answer member questions.

- VII. Dr. James Austin, SCDC Classification consultant, provides information on the new inmate classification system and progress related to implementing the new system. Members ask questions which Dr. Austin answers.

SCDC Director Bryan Stirling provides information related to the mental health lawsuit, including events prior to the lawsuit, his actions to resolve the lawsuit once he became director, and agency actions to make changes related to mental health since settlement of the lawsuit. Members ask questions which Director Stirling answers.
  - IX. Members make a motion during the meeting, which is listed on the next page. A roll call vote is held for the motion, and, among the members present, the motion passes unanimously.

Rep. Clary moves that the Subcommittee Study include recommendations that SCDC do the following:  (1) Randomly test employee knowledge of agency policies and procedures, Random testing should include both written tests and hands-on strategies to gauge employee knowledge.  (2) Use the data from the random tests of employee knowledge of agency policies and procedures to implement a method to determine which of the trainings it offers are effective or may be in need of revision. and (3) Review the current ways in which agency employees may share health, safety, and welfare concerns, including anonymously, and implement any changes necessary to improve these reporting mechanisms.
