The two most significant issues for many of us who have incarcerated loved ones are lack of information and communication. In the current technological age which we live, there is no excuse for not providing information to the public. Cancellation of visits, changes in visitations or check in procedures should be readily available. Most importantly, there is no excuse for having only one officer patrolling two or four dorms at a time. NO EXCUSE. This is a common occurrence at some prisons, resulting in serious medical issues and deaths for inmates and liability for the state taxpayers. In addition, the administrative staff at the prison refuses to answer phone calls, voice messages, or emails. IF you can get through to the main line, your calls are forwarded to ring forever or back to the switchboard. Again, they refuse to answer messages left by voice or email. If you call the Columbia offices, you are referred back to the prison. If you reach out to the legislators, they refer you back to Columbia and then back to the prison, where you started. A leader should be able to stop this endless cycle and make decisions that result in positive changes. Be that leader.
