Allowing more pens paper and envelopes to the indigent as well as lockup inmates. More free or lower cost phone options. Also remote video visits at all facilities. Hi, I am writing you out of concern for a Loved one that I have at Tyger River Correctional Institution. Tyger River has a total of 4 confirmed cases among offenders in the past two days! Three of these men worked in the kitchen. The kitchen is still open, which could potentially be a hotspot for other men on the same yard. One of these men was recently transferred to Tyger River from Livingston. He was not quarantined before he was brought there and put into a dorm among the other men. Due to the pandemic, there are not suppose to be any kind of transferring or movement of any kind between prisons. The only exception is for medical reasons. This places the men at Tyger River at a greater risk. My loved one, in particular, along with many other men are set to come home on the next few months. I, along with many others, are afraid for their safety. There safety seems to be of no concern for the people in charge. They have no way to have their voices heard about the situations that they are facing. Something needs to be done about this ASAP and I am hoping you can help spread the word. Thank you for taking the time to acknowledge my concerns.

The inmates are being told that the A/C will not be repaired until July because of the fiscal year end. Do you know what happens to a germ, a virus in hot weather? These inmates have no chance to practice social distancing; they don't even have proper cleaning supplies to clean their surroundings. This is an open dorm type building and if someone in this building contracts Covid-19 it will spread like wildfire throughout the inmates. Very few inmates deserve to be treated like animals. Would work in a large room, with no A/C, in the SC heat with the threat of Covid-19? No, you would go home. They can't do that. This committee needs to pass the sentencing reform bill ASAP and make it retroactive. This would reduce the number of inmates in SC and maybe give SCDC a fighting chance to support a better run corrections system. SC correctional facilities are lagging behind in many areas compared to other states. SCDC claims to rehabilitate criminals before they are returned to society. That is a lie. Rehabilitation comes in many forms, treating inmates like animals, with no rights, doesn't even come close.

I get that it's prison but those men & women that are behind those walls is our love ones!! They say no one's being transferred in and out but they but they still transfer people in!! Like my husband he worked his tail off to get his level 1 back n can't be transferred out!! He is a diabetic that is taking medicine but not getting his sugar check daily like he supposed or should be!! They're not getting canteen so he has to live off their food into they get it back!! I will break it down to you like he called me this pass Thursday & I ask him what have they been feeding him!! This is a 210 lb man at 6feet tells me they feed him one piece of sausage some black eyed peas and a piece of bread!! How do SCDC & yall think that is right!!! That's why I make sure he has canteen to where he won't starve to death!! SCDC & [Mr Bryan] tells y'all what they wants yall hear not the real truth!!! SCDC is joke with alot are people lying & keeping the real truth about what's going on behind those walls from us as family members and everyone else is South Carolina!! Them men & women need help & y'all are the only one that can help us help them!! I'm begging yall to please help these men and women in SCDC!!!
