



The South Carolina Department of Juvenile Justice (DJJ) is a state cabinet agency, and by law, it is also a treatment and rehabilitative agency for the state's juveniles.

DJJ is responsible for providing custodial care and rehabilitation for the state's children who are incarcerated, on probation or parole, or in community placement for a criminal or status offense.

Our goal at DJJ is to protect the public and reclaim juveniles through prevention, community programs, education, and rehabilitative services in the least restrictive environment possible.





DJJ emphasizes a Restorative, rather than a merely punitive approach to juvenile justice

Recent Community Restoration Projects



Youth under DJJ care are encouraged to restore their community and their victims, to make amends for their offenses. This is the Balanced and Restorative Justice (BARJ) model.



DJJ has about 1,400 employees and has help from about 3,000 volunteers each year.

DJJ operates one long-term secure facility (the Broad River Road Complex in Columbia), one Detention Center, three regional Evaluation Centers, and 43 county offices.

The average daily population of DJJ youth in all hardware and staff secure facilities is 866.

About 16,500 juveniles are referred to DJJ each year.

DJJ also operates its own school district, a Job Readiness Training Center (JRTC) and the "Store of Hope," a retail store which sells youth-made items. The agency also helps fund several regional Teen After School Centers and Job Readiness Training sites.

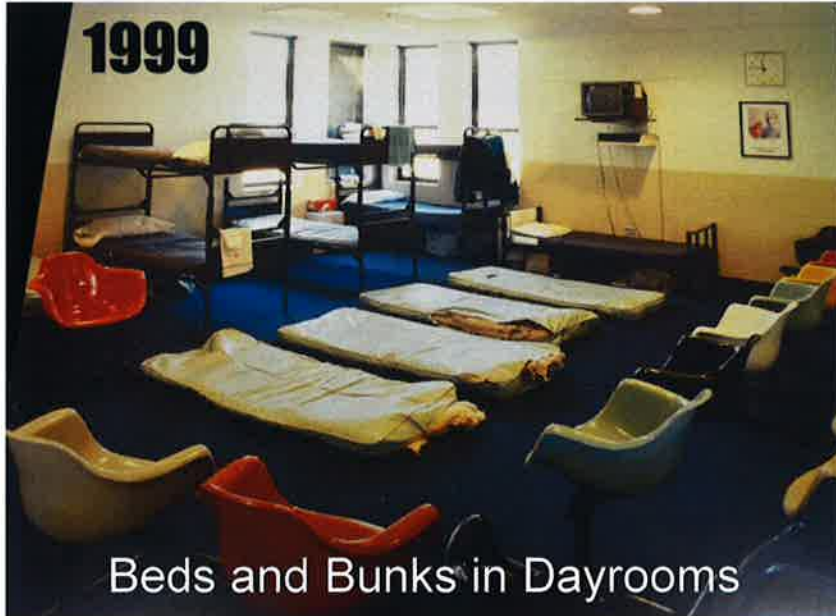

Last year, only 47% of cases referred to solicitors ended up being heard in Family Court. And of those juveniles whose cases did go to court, 62% received dispositions of probation.



Only about 10% of cases referred to solicitors ultimately resulted in commitment to DJJ

Yesterday's DJJ

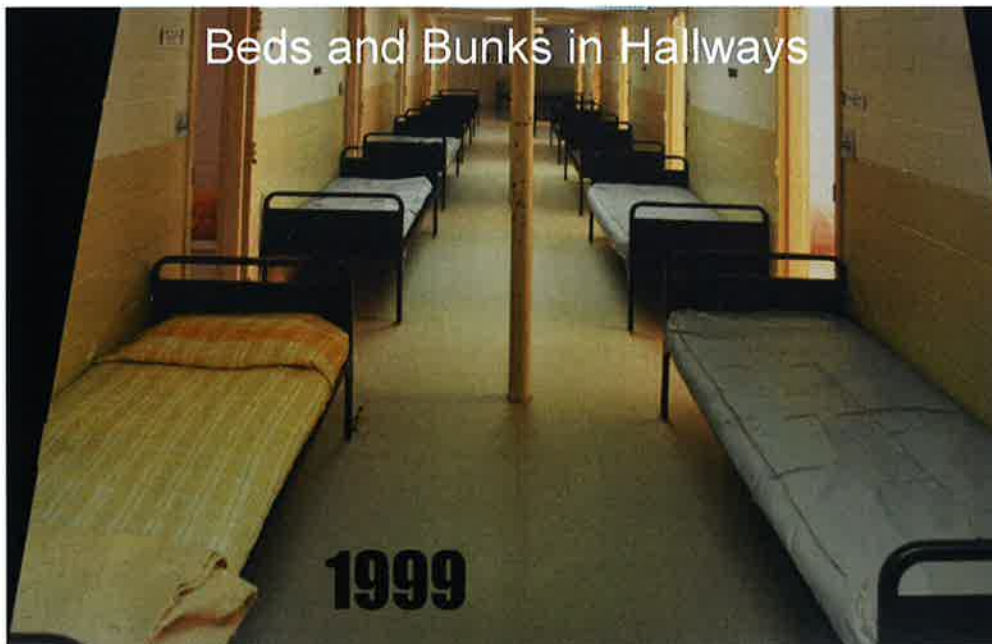


A 1991 federal lawsuit that hung over DJJ for thirteen years

77%**

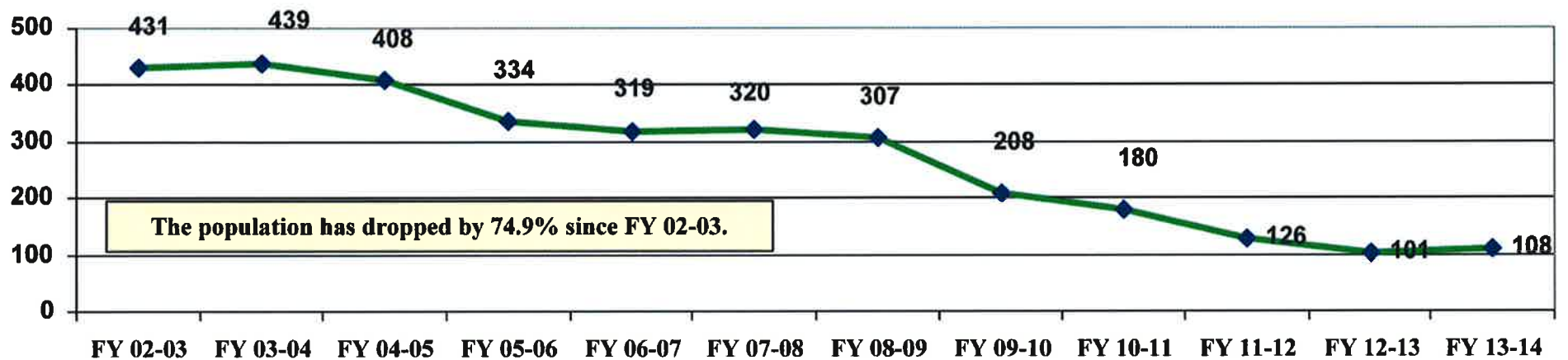

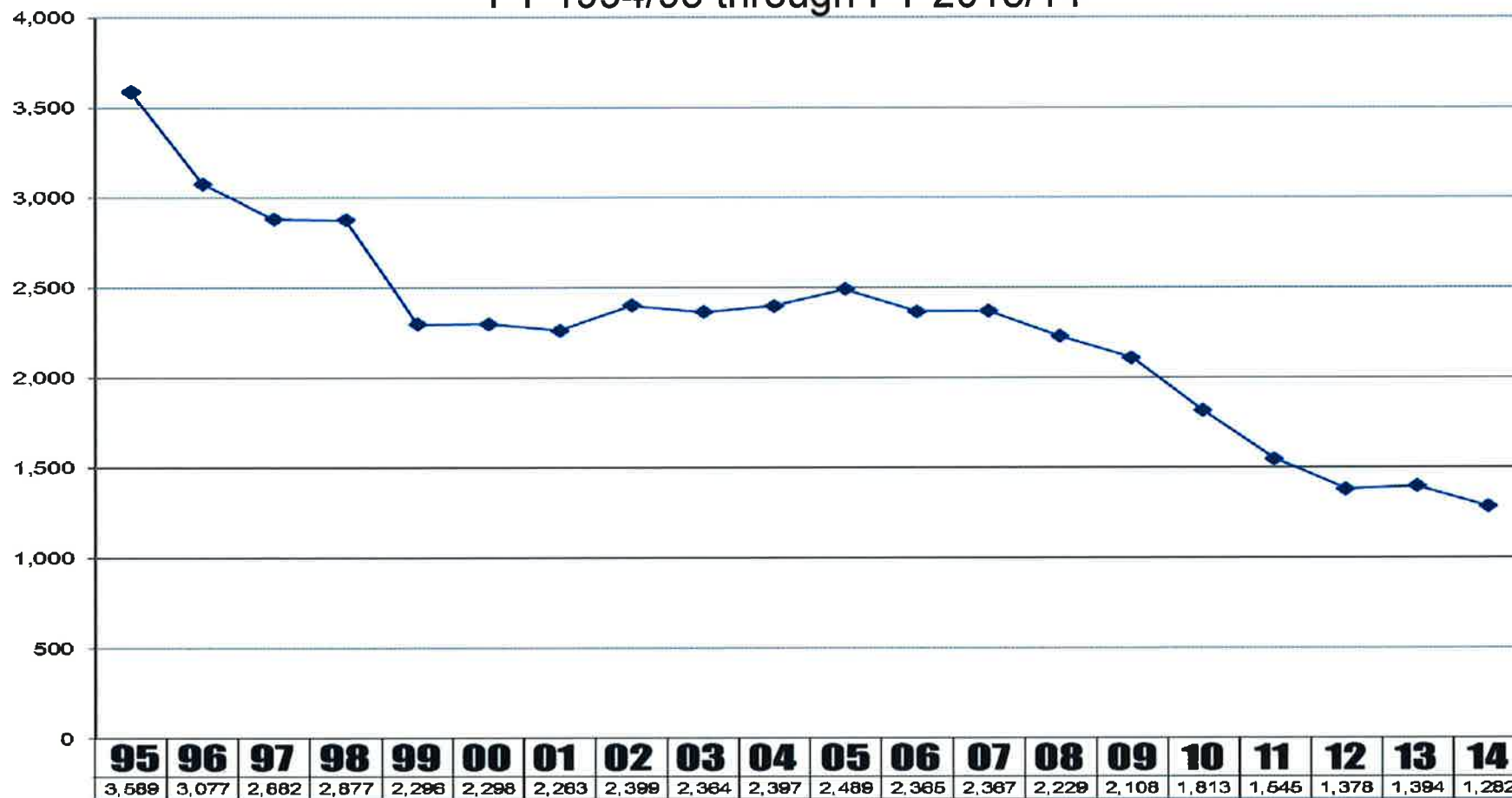
IV. Decline of Population within DJJ Secure Long-Term Facilities

How We Changed

Repositioned our facility clinicians to front-end of the system (in the communities).

Lowered caseloads for probation officers, and began an Intensive Supervision Officer (ISO) program to ensure that parole officers had a caseload with a limit of 20 supervised juveniles.

Improved family services and counseling at the county level.

Created extensive job training, anti-gang, and afterschool programs both behind the fence and in the community.

Created and expanded diversion and alternative placement programs, such as Juvenile Arbitration, to give Family Court judges more options with young offenders who may not belong in secure facilities.

The Mission of the JRTC is to **Equip, Expose and Assist** young students throughout the State of South Carolina with Job Readiness Training and Skills.

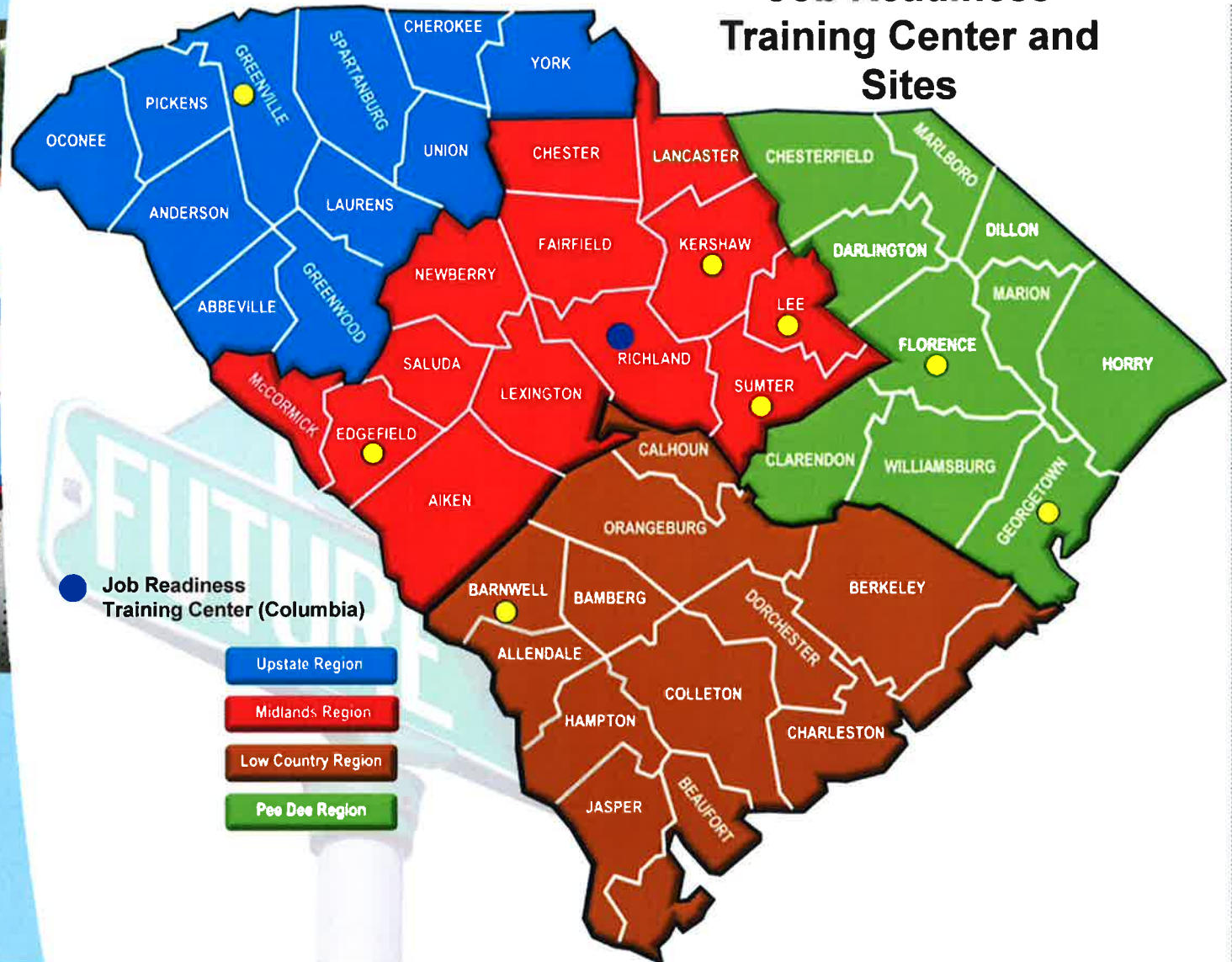
Equip – them with the hard and soft skills needed to get jobs.

Expose- them to the difference occupations, professions, higher education and other learning opportunities.

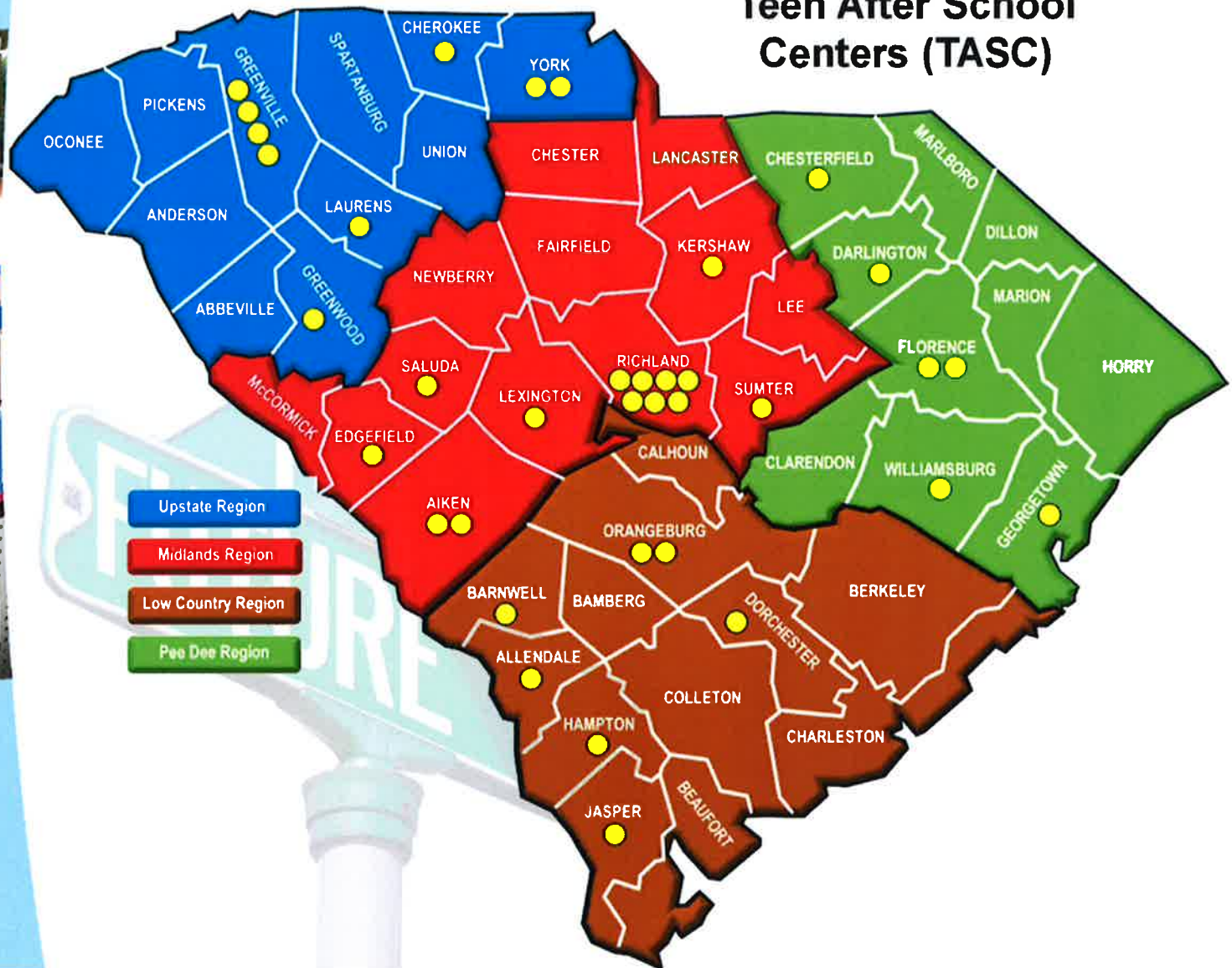
Assist – them with maintaining employment and continued education.
