Dear Chairman Newton:

I am in receipt of your letter of March 27, 2018, requesting information from the SC Department of Juvenile Justice (Department or DJJ) related to monthly statistical reports that the Department provided to the House Legislative Oversight Committee (Committee). These reports contain data that the Committee has requested concerning youth who have been committed to or placed under the supervision of the Department by the Family Court and reside in secure facilities or community residential placements. Please allow this letter and enclosures to serve as responses to your questions.

Your first inquiry concerns youth who are housed in "Marine and Wilderness Camps." In regards to your requests for additional information about youth who were on probation at a marine or wilderness camp and reported as being on runaway status, youth reported as being injured in an assault, substantiated abuse and neglect allegations, and reports of serious injury requiring medical treatment, please see Attachments 1-4, respectively.

In regards to your requests for other information regarding marine and wilderness camps, beginning in January 2018, additional health care protocol training was provided to assist staff and youth with reducing accidental injuries. In addition, all marine and wilderness camp contracts were amended in April and May 2017 to include the addition of outcome measures. The outcomes measures tool was implemented in September 2017 and has been collected monthly since October 2017.

The Committee's next questions relate to secure facilities. The Department has identified that a common situation where "staff injuries caused by juveniles" occurs is during the course of a physical restraint. To address this and other related concerns, the Department's Use of Force policy was updated in 2017 and a new training program for security staff was implemented. This training program, Handle with Care Behavioral Management Training, is used in numerous juvenile justice settings throughout the country and was approved by the SC Criminal Justice

Academy in April 2017 as part of the Basic Training curriculum for juvenile correctional officers at DJJ. This training includes verbal intervention techniques as well as personal defense system techniques (defensive countermeasures) with use of the primary restraint technique and take downs.

During the first year of implementation of the Handle with Care Behavior Management Training, ninety-one percent of correctional staff at the Broad River Road Campus (over 200 persons) completed the training. DJJ believes that the lower "ratio of staff injuries to juvenile assaults on staff" at BRRC can be attributed, at least in part, to the implementation of this training program. Correctional staff at the evaluation and detention centers are being trained in Handle with Care as well (56% trained as of March 2018), and DJJ anticipates that as a greater percentage of these staff complete training, the ratio of injuries to assaults at those facilities will decrease as well.

In addition to Handle with Care, the agency has implemented/enhanced other aspects of trainings available to security staff which are designed to enhance staff competencies and contribute to the prevention of incidents and injuries. These trainings include Ethics, Professionalism and Making Key Decisions; Essentials of Effective Interpersonal Communication; Trauma-Informed Care; Suicide Prevention and Crisis Intervention; Supervision of Juveniles in Secure Residential Facilities; Emergency Procedures; Safety, Security and You; and Contraband Control and Search Procedures. Security staff at the Juvenile Detention Center are also required to attend Basic Detention training at the SC Criminal Justice Academy.

DJJ also implemented a Code Blue system for fast response from Public Safety, which serves to de-escalate the youth so force is not necessary, thereby reducing staff injuries. Another enhancement that has contributed to decreased injuries/incidents at BRRC is the implementation of a rover (extra staff) on each pod that floats between each unit to provide breaks and any assistance that the unit staff may need. Also, the Intensive Treatment Unit (ITU) was implemented in 2016 at BRRC to provide additional services and treatment for juveniles identified as being aggressive or assaultive. Information about the ITU program is a component of the Juvenile Disciplinary Process training for all new Juvenile Correctional Officers. Finally, in an effort to positively affect the agency's overall culture, DJJ is implementing two of Franklin Covey's trainings – The Speed of Trust and The 7 Habits of Highly Effective People (which will include '7 Habits on the Inside' for juveniles). Both of these trainings will focus on critical competencies that will help enable staff and youth to be more engaged, more committed and accountable for positive change – not only within the organization, but personally.

In regards to your request for additional information regarding reported data on "staff assault on juveniles; juvenile injuries caused by staff; [and] allegation of juvenile sexual abuse" at secure facilities, please see Attachments 5-7. Recruiting and retention of qualified officers continues to be a challenge for DJJ, especially in rural areas like where CEC is located. DJJ continues to host and participate in job fairs and also submitted a budget request for next fiscal year that included increased salaries for correctional staff so that DJJ could remain competitive with other agencies in attracting and retaining security staff. CEC experienced a temporary decline in staffing in early 2018, which may have contributed to the occurrence of incidents. Additional officers have been hired since that time and begin Basic Training in May 2018.

Your final inquiry concerns "Recent Events." In March 2018 there were four incidents at agency facilities that involved more than four juveniles. On March 4, 2018, five juveniles were involved in an incident where a juvenile was assaulted on one of the pods at the Coastal Evaluation Center. This case was investigated and submitted to the local solicitor pending approval of criminal charges. On March 5, 2018, seven juveniles were involved in an incident where a juvenile was assaulted on the recreation court at the Juvenile Detention Center. This case was investigated, and one juvenile refused to meet with an investigator and the victim declined to proceed with the investigation. On March 10, 2018, seven juveniles were involved in an incident where two juveniles were assaulted on one of the units at the Juvenile Detention Center. This case was investigated, and the victim declined to proceed with charges/prosecution. On March 31, 2018, six juveniles were involved in an incident where two juveniles were assaulted at the Midlands Evaluation Center. The case was investigated and submitted to the local solicitor for prosecutorial review of charges.

Thank you to members of the Committee for your support of DJJ as we continue to enhance services provided to youth and communities across South Carolina. I trust you will find the above information and attachments responsive to your follow-up requests. If I can answer any additional questions, please do not hesitate to contact me.
