# EXECUTIVE OFFICE

#### Office of Environmental Programs

- Staff of the Office of Environmental Programs participated in 64 comprehensive reviews of FERC Hydroelectric Project proposals on 23 licensed projects as related to applications, water quality certifications, study plans, study reports, natural resource management plans, monitoring plans and compliance reports. Significant FERC accomplishments included:
  - The relicensing of the Keowee-Toxaway Hydro Project which will provide a new habitat enhancement program, fish entrainment reduction, trout habitat monitoring, funding for headwater stream restoration, protection of priority species, land conservation on 2,865 acres, funding for additional land conservation, funding for Sassafras Mountain tower, additional recreational amenities at public access sites and a low-inflow protocol to conserve water during droughts.
  - The transfer of \$2.1 million to DNR from Duke Energy under the Catawba-Wateree Comprehensive Relicensing Agreement to support acquisition of the Liberty Hill WMA and other fish and wildlife enhancements in the Catawba-Wateree River Basin.
  - Establishment of the 2017-27 Work Plan agreement with Duke Energy under the Bad Creek MOU which will provide \$1.4 million to DNR for fisheries management at Lakes Keowee and Jocassee over the next 11 years.
- Staff participated in 62 interagency meetings to discuss permitting issues and represent DNR interests related to aquatic habitats, water quality and impacts to specific species. These meetings coordinate comprehensive reviews of significant state and federal permit and certification requests for alterations to wetlands and other aquatic habitats.
- Approximately 1,075 comprehensive environmental reviews were conducted, and science based comments provided to state and federal regulatory agencies related to community development projects using Federal Community Block Fund Grants, impacts Waters of the U.S. in accordance with public notices through the Clean Water Act, National Environmental Policy Act, S.C. State Mining Act, Coastal Zone Management Act and S.C. Navigable Waters Act as well as DNR Natural Resources Trustee activities on all SARA/CERCLA, RCRA, and OPA actions that have the potential to affect fish and wildlife resources. Our objective in all environmental reviews is to protect natural resources, including fisheries, wildlife and rare, threatened and endangered species that could be impacted by proposed projects.
- Staff reviewed 18 proposed mitigation banks and followed approximately 27 existing mitigation banks through the interagency review team providing input and guidance in the process of permitting mitigation banks. Each mitigation bank can require multiple reviews and site visits resulting in an additional 150 comprehensive reviews.
- Staff participate in and chair the Coastal Pesticide Advisory Committee which includes state and federal agencies, research institutions and private entities for the purpose of reviewing issues related to pesticide use in the coastal zone and how it may impact fishery resources.
- Staff chair the S.C. Geologic Survey STATEMAP Advisory Committee providing recommendations on priority geologic mapping across the state based user needs, economic interests and other parameters.
- Bob Perry was selected by peers to represent multiple co-authors to present on Management and Sustainment of South Atlantic Coastal Impoundments for Waterbirds and Other Wetland Wildlife in a special, invited session entitled Conservation and Management of Tidal Wetlands for Fish and Wildlife in the Face of Changing Environmental Conditions at the 2016 Annual Conference of the Southeastern Association of Fish and Wildlife Agencies held in Baton Rouge.
- Our office participated in a workshop with DOT and Federal Highways and the regulatory agencies toward the development and implementation of an Advanced Mitigation Partnership between DNR and highway agencies; that partnership is now active and productive.
- Coordination with DOT began on the acquisition of the Jackson Tract (118.54 acres) adjacent to Henderson Heritage Preserve to restore Bridge Creek and two of its tributaries for impacts associated with the widening of S-126 (Belvedere-Clearwater Road) in Aiken County.
- Coordination with Mercedes Benz of Charleston and its agents began on the acquisition of an inholding tract in the Francis Marion National Forest to be preserved and subsumed into the National Forest for impacts associated with the expansion of the Sprinter Van Production Facility in Berkeley County.
- We participated in the development of a critical action plan and legislative recommendations for future management of the Pinewood Landfill, arguably the nation's most toxic landfill located near Pinewood, SC and Lake Marion.

- Coordination with DOT continued on the acquisition of Gunter's Island (approximately 6,100 acres) for mitigation to impacts associated with Interstate 73. These efforts included assisting DOT submit a revised mitigation plan for the project. After acquisition of this property DOT will donate the tract to DNR, and it will be incorporated and dedicated as a part of the Little Pee Dee Heritage Preserve.
- Working with CSX Railroad and its agents, DNR acquired the King Tract (100 acres), a strategic in-holding at Marsh Wildlife Management Area, as mitigation for wetland impacts associated with rebuilding a rail trestle over the Pee Dee River between Florence and Marion counties. This acquisition was subsumed into Marsh WMA.
- Working with Dorchester County Landfill and its agents, DNR is set to acquire by donation the Good Hope Tract (203 acres) on the Edisto River for inclusion into the WMA program. The U.S. Army Corps of Engineers issued a permit to Dorchester County Landfill which funded the acquisition by Lowcountry Land Trust, to allow donation of the property to DNR in early 2017.
- Working with the Conservation Fund, the Office of Environmental Programs continues to explore strategies to restore streams and wetlands on the Tall Pines Tract in Pickens County, with the long-term objective of acquiring the tract (1,250 acres) and establishing public use.
- Working with The Nature Conservancy and American Rivers we began a partnership in a science-based collaboration, the Pee Dee Clean Water Study Group, to protect water quality in the Pee Dee River Basin; this project has significant potential to generate millions of dollars for fish and wildlife enhancement and landscape habitat protection.
- Working with the U.S. Army Corps of Engineers we developed a draft of a long-anticipated General Permit covering
  most of the activities DNR performs that have potential impacts to Waters of the United States. This GP will be public
  noticed in early 2017 and be available for staff use shortly thereafter, saving considerable time, funding and gaining
  operational efficiency at the field level.
- Working with IT staff our staff developed a dock on the DNR website featuring the activities of our office as well as
  information and links to available resources. See: <u>www.dnr.sc.gov/environmental</u>

#### Boating Access and Engineering Section

- The DNR's Boating Access and Engineering Section is responsible for major maintenance and renovation of some 440 boating access facilities statewide.\_
- Completion of one (1) new boating access facility in York County.
- Renovation of three (3) existing boating access facilities in Charleston, Georgetown and Horry Counties.
- Design and Construction of a large steel bulkhead wall at an existing boating access facility in Aiken County.
- Design and Construction of an additional fishing pier in Hampton County.
- Eight (8) new boating and fishing access projects were initiated in six (6) counties and are currently under development.
- Survey and design was completed in partnership with Santee Cooper for a fishing access facility in Berkeley County.
- Completion of designs for ADA upgrades to fire alarm systems at three (3) SCDNR facilities.
- Topographic surveys were completed for seven (7) new boating access and capital projects.
- Completed conceptual floor plan designs for proposed new SCDNR office at State Farmers Market site.
- Provided technical assistance to SCDNR Divisions in evaluating damages and estimating repair costs to agency properties as a result of Hurricane Matthew.



- Provided engineering and contracting support for capital projects for repairs of damages resulting from October 2015 flood.
- Construction management was provided by Engineering Section staff for a \$1.1 million renovation of the Waddell Mariculture Center Office and lab.
- Contract and construction management was provided by Engineering Section personnel for the repair/replacement of two (2) 14" diameter seawater intake lines at the Waddell Mariculture Center.
- A 25,000 acre boundary survey of WMA property in Marion County was completed by Engineering Section staff.
- An 8,000 acre boundary survey in the Jocassee Gorges WMA was completed by Engineering Staff.
- Numerous (10 to 15) small boundary surveys were completed by Engineering Section staff in support of Wildlife & Freshwater Fisheries and Land & Water Divisions.
- Accomplished the hiring of a Professional Engineer as well as a surveying assistant to fill 2 of 4 existing vacant positions. Filling of the engineering position with a licensed PE will ensure continuity in the program in future years.

#### Special Assistant to the Director

• Continued to follow-up on accessibility needs at DNR facilities identified in the Self Evaluation and Transition Plan developed under the Americans with Disabilities Act.



• Continued to coordinate and guide the maturation of the SC Quail Council, and assist the WFF Division in the establishment of 4 Focal Areas for implementation of the SC Bobwhite Initiative. Also a group was organized in conjunction with Tall Timbers and Quail Forever and one meeting held to discuss establishment of a funding arm for the SC Bobwhite Initiative.

• A partnership was formed with the U.S. Forest Service and Quail Forever to fill a biologist position in support of the Indian Creek bobwhite Focal Area. One of two Natural Resources Conservation Service contribution agreement biologist positions was also filled to support the SC Bobwhite Initiative.

• The Special Assistant to the Director completed the second year of a two-year term as Chair of the Atlantic Coast Joint Venture (ACJV) Management Board. The ACJV is a habitat partnership in the 17 Atlantic states from Maine to Florida, and Puerto Rico.

- The Special Assistant to the Director also continued to represent the agency on the South Atlantic Landscape Conservation Cooperative Steering Committee, and accepted an appointment to the SALCC Executive Committee. The SALCC includes parts of six states from southern VA to Florida, and is part of a broader network of 22 cooperatives across North America and the U.S. Pacific and Caribbean islands. Each regional LCC is designed to foster shared conservation action among multiple public and private agencies and organizations.
- SCDNR partnered with Clemson University to complete a study to evaluate the economic impact of natural resource related activities to the South Carolina economy. More than \$33 billion of economic activity is attributed to SC's natural resources sector annually.
- The annual meeting of the Clemson University-SCDNR Cooperative Agreement Coordinating Committee was organized in collaboration with the Clemson Department of Forestry and Environmental Conservation. The Special Assistant to the Director also served on Clemson's James C. Kennedy Waterfowl and Wetlands Center Advisory Board.
- The Special Assistant to the Director accepted an appointment as Chair of the Association of Fish and Wildlife Agencies Resident Game Bird Working Group, which includes a seat on the U.S. Committee of the North American Bird Conservation Initiative.
- Represented SCDNR on the National Bobwhite Conservation Initiative Management Board.

### Office of Media and Outreach - Palmetto Sportsmen's Classic, Camp Wildwood, Social Media, South Carolina Wildlife Magazine, Graphics, Litter Prevention, Video, Public Information, Diversity Outreach

- Marketing campaigns for 2016 consisted of 100 Deadly Days and the Apprentice Hunting License
- Partnered with the National Shooting Sports Foundation to capture shooting range locations throughout the state.
- Partnered with National Shooting Sports on pilot apprentice license campaign
- Partnered with the South Carolina Association of Tourism Regions on the development of a statewide promote of natural resources and outdoor recreation.
- Partnered with the South Carolina Association of Tourism Regions and the Department of Parks, Recreation and Tourism on the development of a fishing insert for the Annual Visitor's Guide.
- Coordinated efforts with Guy Harvey Magazine on the production of the first South Carolina specific issue to be . distributed March 2018.

### Palmetto Sportsmen's Classic

- The Palmetto Sportsmen's Classic's net profits increased 23.7% from the previous year. A profit of \$184,360 was raised for the Harry Hampton Fund.
- Overall, operating costs for the 2016 show were down. Advertising, entertainment, and rental of the property all went down. In 2015, the overhead for the Palmetto Sportsmen's Classic was approximately 53%. This year, we cut the overhead down to 46%. The dramatic decrease was due to the decrease cost in expenses coupled by an increase in vendor revenue.

### Camp Wildwood

- For the first time in Camp Wildwood history, we were able to fill all campers spot's by April 1st, 2016. By June we had a waiting list of over 20 campers, another first.
- Quick look at camper evaluation (75% 2016 campers responded)
  - 98% of responding campers evaluated their experience as either "Time of your life!" or "Excellent". (79.0% and 19% respectively)



- 85% responded "Yes" to the following question: 0 "After attending Camp Wildwood, do you think you are more likely to purchase a hunting and/or fishing license?" Camper's ages range from 14 – 17 years old.
- 74% responded "Yes" to the following question: "In the next 12 months, do you think that you will purchase a hunting and/or fishing license?"

#### Social Media

- Facebook: Our SCDNR Facebook Page had our first "Viral" post (see picture attached). During the aftermath of hurricane Matthew we posted a before and after pic of Palmetto Blvd, Edisto Beach, SC. Stats: Over 1.3 million views, 2,400 reactions and over 14,000 shares.
- Instagram: Over the course of 2016 our DNR Instagram account tripled the number of followers. Currently we have 13,700+ followers.



- I worked ESF-15 for Hurricane Matthew for 17 days and SCDNR got a lot of push due to my photos (SCEMD, press conferences, aerials, damage, flooding) being shared on social media and by multiple agencies for different uses
- A video I put together about SCDNR officer efforts during Matthew was shared multiple times and received more than 19K views on Facebook
- The aerial cell phone footage I shot of Matthew flooding in Mullins received more than 17K views on Facebook
- Cell phone footage I shot of Charleston traffic during Matthew received more than 18K views on Facebook
- Multiple SCDNR events (Wateree Field Day, gopher tortoise release, Austin Sheheen Sr. Natural Resources Area dedication, Wateree River Correctional Institution Fishing Rodeo, mobility impaired hunt, 2016 NASP World Championship) were photographed and shared on social media

#### Public Information – Lowcountry

- Created and began publishing the SC Natural Resources Blog. Since going live in August, the SCNR Blog has been steadily gaining new readers. In December, the blog garnered unique 1,144 visits and 2,185 page views. In addition, nearly 8,000 people have signed up to receive monthly "newsletter" updates on the articles and information posted on the blog.
- I completed training to become a GovDelivery Administrator. We (OMO staff and others) have worked with IT to implement GovDelivery, providing us with a way to send targeted e-mail messages on a variety of SCDNR related topics and programs to people who have affirmatively asked to receive those e-mails, and also to media outlets. This is a huge leap forward in our communications ability.

#### **Diversity Outreach**

- Maintained the SCDNR Spanish website. The average requests per pages went from 43,883 in 2015 to 158,846 in 2016. Added over 55 news and articles through 2016.
- Attended Hispanic Festivals and outreach events, reaching more than 6,000 participants in 2016.
- Supported 14 SCDNR events offering bilingual capabilities.
- Maintained and promoted the Spanish YouTube channel, the videos views averaged over 1,150 in 2016 alone.
- Maintained and promoted the Spanish Facebook page. We have over 620 followers and an averaged reach of 10,000 people.



- Maintained partnerships with National and International agencies. In 2016, we also gained support for our outreach efforts from Horry Georgetown Technical College, Central Carolina Technical College and the University of South Carolina.
- Introduced the SCDNR Hispanic Outreach Program to other state and natural resources agencies through 10 presentations at national level conferences and summits.
- Worked with the SCEMD public information office to aid in the emergency response through Hurricane Matthew.
- The Diversity Outreach Coordinator was recognized nationally by The Wildlife Society with the 2016 Diversity Award for reaching out to minority groups and teaching them about nature-related outdoor activities.
- Received the Diversity Inclusion in the Workplace Award from the Southeastern Association of Fish and Wildlife Agencies.

## Land, Water and Conservation Division

- Established separate Surface Water and Groundwater Programs within the Hydrology Section of the Earth Science Group to better address needs for information and capitalize on staff expertise in these areas.
- Worked diligently and made major progress on the Surface Water Assessment and Modeling Project in the eight major river basins as the initial phase of The State Water Plan update in cooperation with DHEC, USGS, the CORPS and Clemson University. Model completion projected to be late February.
- Conducted 8 stakeholder meetings for the Surface Water Assessment Project (total of 15 stakeholder meetings to date for the 2 year project)
- Began water demand projections in the Savannah Basin in cooperation with the Corps of Engineers through their Planning Assistance to States (PAS) Program.
- Held two workshops on streamflow monitoring and recommended 36 new sites for streamgages.
- Made substantial progress on the Savannah River Comprehensive Study Phase II, completing the Savannah Harbor Dissolved Oxygen Model and coordinating with the Corps, TNC and Georgia EPD. Completion of Phase II expected by the end of May.
- Active in drought monitoring and began a Statewide Evapotranspiration Project with the College of Charleston and USDA Forest Service.
- Obtained a \$170,000 grant from DHEC which was used to establish groundwater monitoring wells in Sumter County and analyze for saltwater intrusion into coastal aquifers.
- Continued to work on the Aiken County Groundwater Model in cooperation with the U.S. Geological Survey.
- Began groundwater assessment and modeling of the entire coastal plain in cooperation with the U.S. Geological Survey and Corps of Engineers (PAS funding).
- Began measuring the three major aquifers to produce new Potentiometric Maps in support of the regional groundwater assessment of the coastal plain.
- 473 wells measured in cooperation with Savannah River National Laboratories, USGS and DHEC.
- Received a grant from the USGS National Groundwater Monitoring Network and added maps and tables to the national database.



- Finished new, digital 1:24,000 scale maps of the coast from Santee Point to Little River under multiple grants from the USGS Statemap Program.
- Finished work on 17, 1:24,000 scale maps across the mountain bridge area of the inner piedmont.
- Began work on a regional compilation of the Carolina Terrane in cooperation with the University Of South Carolina to produce information for updated earthquake hazard analysis and economic development.
- Received a \$160,000 grant from EPA to study possibility of land subsidence related to groundwater withdrawal in Georgetown County.
- Established a combined Hydrology/Geological Survey Coastal Program at Ft. Johnson with Dr. Will Doar as team leader.
- Worked to expand the coastal saltwater intrusion network, adding seven new monitoring sites.
- Worked on both the Murrells Inlet to Capers and the ACE Basin Coastal Vulnerability Projects to demonstrate physical change on the shoreline.
- In cooperation with Coastal Carolina University, produced an offshore map from Winyah Bay to Little River.
- Measured the surface elevation table network along the coast quarterly.

- Received a \$450,000 grant from the U.S. Bureau Of Offshore Energy Management (BOEM) to analyze both regional and state offshore sand resources in cooperation with MRD, Georgia and North Carolina (Skidaway Institute of Oceanography and East Carolina University)
- Facilitated and cost shared with SCDNR wildlife biologists to restore or improve habitat on SCDNR properties by controlling invasive aquatic vegetation on 2087 acres.
- Santee Coastal Reserve-helicopter application to control 1500 acres of phragmites on Santee Coastal Reserve impoundments to improve habitat.
- Samworth- helicopter application to control 296 acres of white marsh grass.
- Hatchery- helicopter and boat application to control 104 acres.
- Donnelly- helicopter and boat application to control 43.5 acres.

- Flood Mitigation staff and Deputy Director conducted 10 open house meetings and 7 preliminary DFIRM Community Coordination meeting for updating flood maps.
- Released preliminary maps in 4 watersheds and 2 counties.
- Flood Program Manager, Maria Lamm, was elected Vice Chair of the National Association of State Floodplain Managers.

A 21 year old Sumter woman was killed when a boat struck the boat she was sitting in July 4<sup>th</sup> weekend. The defendant received 5 years in prison for failure to render aid and reckless operation.
- Aviation section documented over 100 dove fields, including 22 previously undocumented fields and 8 of those confirmed as baited fields. Documented 47 wetland sites for duck bait, resulting in 7 potentially baited sites and 1 site confirmed baited.

# Marine Resources Division

#### Research

- MRRI staff were awarded 6.4 million dollars in competitive research grants and contracts.
- Researchers partnered with >100 scientists from local, state, federal and academic institutions from around the country to help better understand South Carolina's living marine resources and habitats.
- Staff produced 100 technical reports, published 25 scientific research papers, gave 250 oral presentations of ongoing research and held 4 workshops.
- The ecosystem research group completed its 17th year of sampling estuarine habitats, with 60 trawls covering 22 miles of coastline, collecting 1,765 specimens of 36 species, and providing information to characterize the health of SC's estuarine habitats coast-wide.
- The algal research team spent 102 field days responding to the public regarding fish kills and algal blooms, collecting 18,441 samples.
- The inshore fish research team made 994 trammel net sets, 311 electrofish sets, 63 trawls and 356 longline sets, tagged 1,993 fish and processed 10,938 fish in the laboratory.
- The population genetics team processed over 10,000 tissue samples of 13 species that provided information to understand the stock structures and genetic health of fish resources in SC.
- The crustacean research and monitoring section continued its trawl survey, with 128 gear deployments at 26 stations. These surveys involved 102 staff days and collected 1760 samples to determine health of shrimp and crab populations that inform opening and closing of shrimp season. Staff also collected information on juvenile shrimp, blue crabs and horseshoe crabs at 62 stations statewide, involving 115 staff days, 160 gear deployments and the collection of 1160 samples.
- The shellfish research section implemented winter sampling efforts at more than 30 stations statewide to determine natural oyster mortality rates.
- The coastal finfish research team made 2,864 gear deployments with trawls, chevron traps, and longlines between Cape
- Hatteras and Cape Canaveral and caught 1,011,785 fish, crustaceans and sea turtles of over 350 species.
- Staff processed 35,000 otoliths for age and 20,000 reproductive samples to determine spawning condition, adding ~3.4 million data records.
- Staff made 220,000 detections of tagged fish and turtles throughout the South Atlantic Bight. Staff used these data in 7 regional fisheries stock assessments to provide guidance to managers on how to manage recreationally and commercially important species, rebuild turtle populations, guide opening and closing of harvest seasons and enhance understanding of marine resources.



#### **Fisheries Management**

- Staff provided data and participated in four regional stock assessments for South Atlantic shrimp, red snapper, triggerfish, and blueline tilefish.
- Partners and staff recycled more than 27,000 bushels (~700 tons) of oyster shell.
- State and Public Shellfish Grounds received 29,663 bushels of oyster shells, creating 2.28 acres of shellfish habitat along approximately 1.6 miles of shoreline.

- 5,210 volunteers logged 9,410 volunteer hours building oyster reefs, sampling fish, monitoring water quality and growing/planting marsh grass.
- The commercial licensing office achieved a 99.95% accuracy rate for licensing data.
- The fisheries statistics section tracked 1,324 licenses and permits for monthly reporting and collected 22,995 trip reports from commercial and recreational SC fisheries.
- Online reporting was successfully implemented for charter logbooks.
- Staff completed a cooperative agreement with the US Army Corps of Engineers to develop recommendations for an SC Shellfish Mariculture Plan.
- Staff launched a recreational harvest map web application.
- Staff conducted 4,843 interviews of recreational anglers through the Marine Recreational Information Program.
- SCDNR charter logbooks were evaluated for possible use in generating catch and effort estimates in the for-hire fishery.
- Staff submitted documentation to exempt charter and recreational fishing license holders from a federal fishing license requirement, potentially saving SC anglers \$9,000,000 in federal license fees.
- The SC Governor's Cup Billfishing Series received \$79,700 in new donations. This is the most donated in the 29-year history of the program.



- The Memorial Reef Fund provided tax receipts to donors and notification to bereaved families.
- Research demonstrated the effectiveness of the Charleston Deep Reef site for attracting imperiled species of deep water grouper as well as pelagic species.
- Thirteen artificial reef sites grew through the addition of 120,000 cubic feet of habitat.
- Two new reef habitat structures that can be built and deployed with in-house assets were created, allowing for wider distribution of reef material along the coast.
- Staff learned to operate a new side-scan sonar system, which will greatly enhance the artificial reef program's surveying and mapping abilities.
- DNR awarded a Shore-Based Angler Access Grant to the SC Dept. of Parks, Recreation, and Tourism for repair and improvements to the access road at Oyster Landing. This important beach area is used for saltwater fishing, crabbing and shrimp casting within Huntington Beach State Park in the northeastern part of Georgetown County.
- Staff conducted sampling with commercial shrimpers to assess reproductive condition of white shrimp. Biologists continued sampling commercial shrimp landings to determine counts, species composition, and stages of reproduction for the remainder of the shrimping season.
- Staff visited shrimp houses 128 times and sampled 644 pounds of shrimp to estimate species composition in the SC commercial shrimp fishery.

#### Outreach

• Boating Infrastructure Grant Program (BIG) staff completed four projects, totaling \$ 114,093 in federal funding while managing 15 active projects totaling \$ 7,292,573 in federal funding. Staff worked with industry partners to develop and submit ten new proposals totaling \$ 4,533,859 in Federal funding for FY17.

- DNR's Marine Resources Division was featured in over 250 digital, print, and broadcast media stories.
- South Carolina Coastal Resources, a blog dedicated to showcasing coastal and marine-related SCDNR stories, was launched in October.
- Five youth saltwater fishing events were held including pier tournaments and family fishing clinics.
- 583 recreational anglers tagged and released 4,088 saltwater gamefish and reported the recovery of 700 tagged fish.
- Approximately 223,000 copies of printed material were distributed to 114 vendors located throughout the coastal counties of South Carolina.
- 522 Camping permits were issued for Capers Island, accommodating 3,450 campers.
- Fenwick Island was acquired and transitioned to public use.
- A DNR volunteer workforce provided 7693 hours of service at Botany Bay Plantation NERR.
- 6,167 students and teachers from 16 counties across South Carolina participated in education programs aboard the Education Vessel Discovery and in land-based marine education programs. 85 teachers participated in workshops receiving education on coastal waters, current research, and lesson plans to support work in their classroom.
- 333 coastal decision-makers received training and tools to promote stewardship of our coastal resources.
- Over 1600 volunteers gave over 17,000 hours and drove over 92,000 miles in support of DNR's sea turtle program.
- Staff managed the 136,000-acre ACE Basin NERR (National Estuarine Research Reserve) including a dozen properties located in the lower St. Helena Sound.
- Staff worked with volunteers to monitor and protect over 6,400 nests reported on South Carolina beaches. This year marks the highest number of nests on record since standardized surveying began in 1982. Roughly 1,300 volunteers were trained and permitted to locate, protect and monitor turtle nests along the coastline.

#### Operations

- Staff monitored, maintained, repaired, and facilitated certification of fundamental equipment and systems.
- The automotive shop ensured proper and safe operation of 73 fleet vehicles and provided driver safety training.
- The safety officer inspected equipment and trained staff. Quarterly fire drills were conducted in all DNR buildings at Fort Johnson.
- Staff worked with campus partners to prepare the Fort Johnson Complex for landfall of Hurricane Matthew. After the storm, the section led assessment of damage and coordinated repairs to DNR assets.
- Charleston IT staff supported the technical needs of over 200 scientific and administrative users, over 250 computers, 54 printers and copiers, 7 servers, networking, 18 security cameras, 16 WiFi access points, and the A/V projection systems in 7 meeting rooms at DNR's Charleston, Bennetts Point, Waddell, and other coastal facilities.
- Staff improved security at Fort Johnson by upgrading the security server and camera security monitoring capabilities to include 18 cameras at DNR's facilities in Charleston.
- The DNR Charleston office network circuit was upgraded from 20 Mbps to 50 Mbps improving the productivity of all DNR staff at Ft. Johnson.
- The IT section provided in-house training for 78 DNR staff on relational database and Geographic Information System software.
- Wifi coverage at DNR's coastal facilities was extended to provide coverage for 16 buildings.
- Video conferencing capabilities were improved by securing access to "GoToMeeting" web conferencing service that provides full-featured modern web conferencing services to DNR staff in Charleston.
- The GIS office continued to operate as a cost-center providing support to a wide variety of projects.
- Having exceeded its intended service life, the Research Vessel Palmetto was refurbished. Enhancements included new engines, a generator and improvements to the gallery and crew's quarters. Structural issues were addressed.




- Issue over 1 million Recreational, commercial and management licenses, permits and tags to individuals and businesses for hunting, fishing and Wildlife Management activities.

- Developed a GIS interface for the public to view all DNR managed lands and boating access areas. This application
  allows users the ability to find DNR locations of interest utilizing google map technology for directions, while also
  providing location descriptions and relevant information such as rules & regulations, open and closing times and license

- The implementation of the GovDelivery communication solution. GovDelivery gives the agency the ability to effectively

  information from the department based on categories and topic. Future tools that will be implemented include license
  and registration reminders.

- Maintained a website that received in excess of 14,200,000 successful request for web pages.





## Wildlife and Freshwater Fisheries Division

#### Wildlife


- Celebrated the 75th anniversary of the WMA program with a special ceremony at Webb WMA and field days at Webb WMA and Wateree River HP WMA. Field days were attended by over 500 members of the public.
- Completed Liberty Hill Phase II (1,829 acres) purchase from The Conservation Fund. Established and dedicated the Austin Sheheen, Sr. Natural Resource Area at Liberty Hill.
- Prepared and maintained 44 Public Dove Fields, encompassing over 1,672 acres throughout 27 counties. These fields provided opportunity for over 3,500 adult hunters and over 250 youth hunters on opening day of dove season.



- Management and maintenance activities on WMAs and Heritage Preserves include planting of 3,202 acres of annuals, planting of 42 acres of perennials, mowing or disking of over 13,043 acres, prescribed burning of 22,546 acres, maintenance of 337 miles of firebreaks, mowing of 473 miles of dikes, re-topping of 3,114 linear feet of dikes, mowing of 828 miles of roads, grading of 667 miles of roads, re-topping of 51 miles of road with gravel, maintenance of 387 miles of trails, and maintenance of 250 miles of WMA boundary with posting of 2,794 signs.
- Replaced the pontoon undercarriage on the amphibious trackhoe and purchased two small excavators for dike and bulkhead work on coastal waterfowl projects.
- Staff handled 3,640 nuisance wildlife complaints including 963 alligator calls, 390 bear calls and delivered 221 programs to a combined audience of over 8,800 people.
- Special hunt opportunities provided on WMAs included 14 Special Youth Dove Hunts accommodating 266 youth hunters, 58 Special Youth Deer Hunts accommodating 360 youth hunters, and 9 mobility impaired hunts accommodating 205 hunters.
- Botany Bay Plantation WMA/HP accommodated 66,950 visitors and 21,212 vehicles.
- Successfully implemented the hurricane preparedness plan for Hurricane Matthew and only incurred minor damage
  to equipment and facilities during the storm; however, damage to infrastructure was significant with cost to repair
  estimated at over \$3 million dollars. Most damage was limited to impoundment dikes with significant timber loss on
  Webb and Palachucola WMAs. Staff responded quickly and efficiently to damage from Hurricane Matthew, minimizing
  and mitigating additional damage where possible, protecting human safety, and clearing WMAs so they could be
  reopened as soon as possible following the storm.
- Responded to the Pinnacle Mountain wildfire with DNR staff assisting SCFC with firefighting and coordination for several weeks. Over 10,500 acres burned with over 1,600 acres of DNR lands impacted.
- Three new wildlife biologists were hired in 2016 a bat biologist working on White-nose Syndrome and population monitoring, a research biologist on Yawkey Wildlife Center and a waterfowl biologist on Samworth WMA.
- Conducted significant bat survey and monitoring work in response to White Nose Syndrome and population declines. This included capture and banding work, acoustic surveys, cave and mine surveys and disease surveillance.
- Conducted a Golden Eagle Camera Survey project, documenting 3 Golden Eagles in the state.
- Captured 96 wild turkeys and deployed over 50 satellite transmitters for the year as part of ongoing research efforts on wild turkey breeding ecology, habitat use, and movement behavior.



- Deployed 15 automated recording units (ARUs) to record gobbling activity and chronology from March 1 June 1 as part of ongoing turkey research related to gobbling chronology and season timing.
- Developed a new partnership with Riverbanks Zoo to allow for the rearing of hatchling gopher tortoises collected at Aiken Gopher Tortoise Heritage Preserve in their facilities. Began the first year of a telemetry study aimed at gauging survivorship rates among hatchling and head-start gopher tortoises at AGTHP.
- Staff made two trips to Florida for waif tortoise pick-up, constructed two new "tortoise pens" at AGTHP and released approximately 75 hatchling, juvenile, and adult gopher tortoises on-site.
- Completed NAWCA Projects on Bonneau Ferry WMA and Broad River Waterfowl Area that resulted in significant enhancements to wetlands habitat quality and improvement of public hunting opportunity. Began a NAWCA project on Webb WMA, completed planning for a project on Bear Island WMA, and received approval for a project at Santee Delta WMA.
- Administered a bird banding program which resulted in banding of 259 wood ducks, 39 mottled ducks, and over 2000 mourning doves in support of state and region-specific research objectives and Atlantic Flyway banding goals.
- Continued participation in a multi-state Black-bellied whistling duck color banding project in which 254 ducks were banded in 2016. Ten birds were fitted with satellite transmitters. A total of 504 birds have been banded in SC.
- Completed a 55 acre longleaf pine timber thinning on Cat Island of the Yawkey Center with the new swing bridge. This is the first timber harvest there in decades.
- Control efforts and hog hunts on WMAs resulted in the removal of over 577 hogs.
- Began implementation of a coyote tagging and reward program to comply with a DNR legislative budget proviso.
- Completed the final year of alligator field surveys for a multi-year cooperative research project with Clemson University looking at alligator movements and population estimates.
- Conducted the first Gopher Tortoise population surveys utilizing Line Transect Distance Sampling to estimate population sizes at locations in both public and private ownership. Completed 5 pilot surveys and 3 full surveys, and identified 2 populations that meet Minimum Viable Population (MVP) criteria and one Primary Support Population.
- Collaborated with a solar development company to secure permanent protection via deed restriction for the Primary Support Population identified during survey efforts. This is the first population under private ownership in SC to be afforded such protection.
- Initiated a survivorship and movement study of hatchling and head started Gopher Tortoises at Aiken GTHP.
- Developed an acoustic recognizer for gopher frogs based on field recordings collected in 2014 and 2015, and surveyed all extant historic locations for gopher frogs contained in the Heritage Database in collaboration with Marshall University staff in an effort to better understand the current distribution of gopher frogs and examine extirpation in SC. We identified Gopher Frogs at 4 locations in 2016.
- Completed a comprehensive survey for Pine Barrens Treefrogs in South Carolina on public and private lands, re-surveyed locations identified by Cely and Sorrow in the 1980's, and identified additional areas of occupancy.

- Developed and initiated monitoring efforts on all four quail focal areas. A protocol was developed to monitor whistling bobwhites and other non-game birds during the spring, fall covey counts, and a modified habitat survey on the three tier one focal areas in the state. On the one tier two focal area, the National Bobwhite Conservation Initiative protocol was implemented.
- Developed and implemented an entirely new distance sampling protocol to assist with the monitoring of mourning doves throughout the state. This survey will assist the SC Department of Natural Resources manage the mourning dove population more effectively as it will provide a prehunting season population estimate each year.
- Worked with partners to fund, construct and distribute 1,100 wood duck box units.
- Collaborated with Clemson University (Kennedy Center) to design, fund and initiate waterfowl and waterbird transect surveys.



- Combined early and late migratory bird season setting process that occurred much earlier in the year and integrated migratory bird harvest information into the SCDNR Rules and Regulations.
- Collaborated with partners to initiate a study of black-bellied whistling duck nesting ecology and participated in a satellite tracking study of instrumented individuals.
- Worked with agency staff, constituency groups, and members of the General Assembly to pass Senate Bill 454 commonly called the deer management bill and began working on planning for the implementation of such.
- As requested by the legislature, completed a national survey of fish and game agencies related to methods of electronic harvest reporting and tagging for big game.
- Population estimates for seabirds were conducted by counting nests or adults at all major seabird colonies on the coast of South Carolina using aerial images. Techniques to improve accuracy of seabird nest counts and decrease disturbance to colonies were perfected. *Image J.* processing software was used to tally brown pelican, royal and sandwich tern nests. In 2016 South Carolina had 4268 brown pelican, 11,235 royal tern, and 3448 sandwich tern nests.
- Coordinated with private, federal, state, and county owned beach managers to close part of the beach for nesting seabirds and shorebirds at 30 sites. This involved 2-10 site visits at each property depending on the partnership with the land manager. Additionally, educational signs were placed at boat ramps and on some beach entrances. In 2016, 18 sites were targeted for partnering with land managers in protecting beach nesting birds. Partners (N = 93), were involved in on the ground site management. At most sites partners were staff or volunteers from the site's management organization that took a greater role in conservation in 2016 than in previous years.
- Least terns, a state threatened species, have adapted to nest on pebbled manmade structures. Pier Romeo is a long concrete pier located next to the NOAA Office for Coastal Management at the old Charleston Navy Base and no longer used for docking ships. Pea gravel was spread at the end of the pier. All openings that could be hazardous to mobile chicks were covered with hardware cloth and wooden pallets were placed to provide shade. To attract least terns, a Murremaid Sound System was employed to play the calls of a least tern colony and least tern decoys were placed in the gravel. This work was accomplished with 30 volunteers from NOAA and USFWS Ecological Services under the supervision of the SCDNR Coastal Birds Project staff. A small colony of least terns nested on this site the first year of this project, thus the project will expand in 2017.
- Completed a two year project to assess the distribution of the black rail, a very small and secretive marsh bird, in the coastal region of South Carolina. Conducted surveys at over 500 points and succeeded in finding black rails on several properties, including in impounded marshes that are managed by SCDNR to provide winter habitat for waterfowl. Presented results from this project during the Black Rail Symposium at the international Waterbird Society conference. Coastal South Carolina has emerged as an important portion of the range for the eastern subspecies, which is currently undergoing a federal status assessment.



- Documented record high numbers of wood storks nesting in South Carolina. During annual surveys, 2,512 wood stork nests were counted. Monitored nesting success at a subset of colonies. Worked with private landowners and public land managers to improve quality of nesting habitat. With abundant and diverse wetlands that provide relatively reliable food sources during the breeding season and post-breeding season, South Carolina is playing a key role in the recovery of the species.
- Conducted MAPS (Monitoring Avian Productivity and Survivorship) on Webb Center in Hampton County and in Richland County. The effort on Webb was year 10 of 10.
- Collaborated with Clemson University in an investigation of loggerhead shrikes to determine distribution, habitat preference and population trends.
- Translocated 8 pairs (16 birds) of red-cockaded woodpeckers (RCWs) to Donnelley WMA in Colleton County. This was the first reintroduction to an area with no birds on SCDNR property. Three pairs came from the Poinsett Bombing Range in Sumter County and 5 pairs came from Sandhills NWR in Chesterfield County. This was a significant collaborative effort by SCDNR, the USFWS and other personnel.
- Continued to manage the Safe Harbor Program for RCWs. There are now 175 properties enrolled and South Carolina continues to have more RCWs on private property than any other state within the range of the species.
- Completed 96-acre addition at Jocassee known as Galloway Tract in Pickens County. Completed 91-acre addition at Bear Island in Colleton County.
- Completed 589-acre addition at Pitts WMA known as Adair Tract in Laurens County.
- Assisted Law Enforcement with 131-acre acquisition of Indigo Club in Richland County.
- Assisted Law Enforcement with 2-acre acquisition of LE Office in Kershaw County.
- Investigated approximately 25 potential land acquisitions. Five projects are ongoing and will be completed in 2017.
- A Forest Legacy grant in the amount of \$1,005,000 was obtained for an addition to Chestnut Ridge.
- A National Coastal Wetlands Conservation grant in the amount of \$1,000,000 was obtained for South Fenwick Island.
- A NCWC grant in the amount of \$850,669 was reprogrammed for South Fenwick.
- SWG funds in the amount of \$623,000 were obtained to fund 8 research projects.

#### **Freshwater Fisheries**

- The Freshwater Fisheries hatchery system produced and stocked 11,503,948 fish weighing 131,861 pounds into public waters.
- The hatchery system produced 14 species for stocking into public waters.
- Fish were stocked into 136 water bodies at 190 locations involving 1,444 stocking events.
- Regional operations provided 375 pond management consultations by phone.
- Regional staff reviewed and provided technical comments on 33 environmental permits.
- Regional staff conducted population surveys and inventories were conducted on 23 lakes and reservoirs and 20 rivers and streams.
- Regional staff maintained 124 fish concentration areas in public waters.

- Section staff responded to 28 reported fish kills.
- Twenty-five schools participated in the trout in the classroom program support with partnership from Trout Unlimited.
- Support was provided to youth bass clubs in 47 schools involving approximately 577 students.
- Staff supported the operation of 20 kids fishing rodeos in cooperation with the Law Enforcement Division which were attended by 2,901 participants.
- With the cooperation of DNR certified volunteer fishing instructors, 31 family fishing clinics were provided to 631 participants.
- Fishing tackle loaner sites were maintained at 30 locations across the state providing equipment for 696 users involving 1,241 rod loans.
- The Freshwater Fisheries Section held the 4th Annual Youth Bass Fishing Championship on Lake Murray with participation from 42 schools and 148 youth anglers.
- Statutory amends were made to the recreational American eel limits to insure compliance with the coast wide management plans established by the Atlantic States Marine Fisheries Commission for American eel.
- Statutory amendments were completed to the laws dealing with the use of sterile grass carp for vegetation control in South Carolina to clarify the availability of this management options for private ponds.
- Fish habitat enhancement programs were continued in Lakes Hartwell, Moultrie and Marion.
- With the support of the Office of Environmental programs a general permit application was submitted to the U.S. Army Corps of Engineers to allow the DNR to conduct fish habitat enhancement activities in lakes and reservoirs across the state.
- The St. Stephen Dam eel ramp allowed for the passage of 4,556 juvenile American eels during 2016
- The sonic receiver array in place across the coastal rivers of South Carolina (approximately 300 receivers) was maintained and monitor and continues for provide critical information on the migration patterns of Atlantic and shortnose sturgeon.
- The St. Stephen fish lift, though hampered by mechanical failures twice for extended periods during the season, passed 3,285 blueback herring, 41,375 American shad, and 3,785 other species (13 different species).
- A study was initiated to evaluate the total mortality and exploitation of striped bass in the Lower Saluda River.
- A study was initiated to evaluate the fishery enhancement potential of Stevens Creek Reservoir.
- Launched the FIT (Fisheries Intensive Training) Program. This is a freshwater fisheries specific in-service training program for junior staff with in the Section.
- Continued efforts to build relationships with the sport fishing industry and manufacture in South Carolina through attending the ICAST 2016 as an exhibitor, participating in the American Sportfishing Association's 2016 Industry Summit and hosting the second annual DNR-Sport Fishing Industry Summit with South Carolina based companies.
