- Definition of the term "maintenance" and examples of what type of work fall into the two categories of maintenance discussed by Christy Hall during the meeting and any other categories of maintenance;
- Chart that explains which pieces of the pie charts in the SCDOT 2015/16 Budget Submittal relate to Maintenance work; Operational and Capacity Improvement Projects, etc.;
- Breakdown of each bond including outstanding debt, interest rate, maturity date, etc.;
- Breakdown of payroll including a listing of each SCDOT employee, the employee's annual salary, and the total annual cost of that employee to the agency; and
- The following for each CTC: current governance structure and expenditures for the last five years.
