Discussion of the Study of the Department of Transportation

IV. This was the third meeting with the Department of Transportation ("DOT") held to provide the agency and the public an update on the status of the oversight study of the agency; allow DOT to provide information about their budget process and allow Subcommittee Members to begin asking questions about the agency's budget process.

Subcommittee Chair Henderson began by providing an update on the status of the oversight study. She then swore in all the individuals present on behalf of DOT, including: Karl McCottry, Assistant Human Resources Director; Jim Feda, Director of Maintenance; Jim Warren, Deputy Director of Finance and Procurement; Christy Hall; Deputy Director of Engineering; Mark Lester; Deputy Director of Intermodal Planning; Allen Hutto, Government Relations.

Next, Chair Henderson asked DOT to provide a brief overview of their budget and Jim Warren, Deputy Director of Finance and Procurement began the discussion. Subcommittee Chair Henderson, Representative Norman, and Representative Newton asked various questions throughout the discussion. Based on the question, DOT determined which of their representatives would answer. Of the DOT representatives, the following answered questions: Jim Warren, Christy Hall and Mark Lester.

The Subcommittee Members requested further details from DOT regarding the following, which DOT stated they would be happy to provide within a day or two:

- DOT's definition of the term "maintenance" and examples of what type of work fall into the two categories of maintenance discussed by Christy Hall during the meeting and any other categories of maintenance;
- Chart that explains which pieces of the pie charts in the SCDOT 2015/16 Budget Submittal relate to Maintenance work; Operational and Capacity Improvement Projects, etc.;
- Breakdown of each bond including outstanding debt, interest rate, maturity date, etc.;
- Breakdown of payroll including a listing of each SCDOT employee, the employee's annual salary, and the total annual cost of that employee to the agency; and

• The following for each County Transportation Committee ("CTC"): current governance structure and expenditures for the last five years.

At the close of the meeting, Chair Henderson mentioned some of the items the Subcommittee will want DOT to discuss during the next meeting, which included: further details about CTC and their relationship with DOT as well as additional details regarding the DOT budget, including, but not limited to, salaries and bonds.
