- 37 counties (80.4%) responded to the survey
- 32 responding counties (86.4%) indicated that they conduct municipal elections for some or all municipalities in the jurisdiction.
- 25 responding counties (67.5%) indicated that the county conducts elections for all municipalities in the jurisdiction.
- 7 responding counties (18.9%) indicated that they conduct elections for some municipalities in the jurisdiction.
