I filed this written response to a review being completed of this agency. SCDEW sought to illegally denied job opportunities for Clarence Jenkins with a false application of "Barred From Applying and Does Not Meet Minimum Qualifications" from July 19, 2013 to expired December 30, 2018 which was discriminatory. They also applied false classification NEPOTISM which is illegal in this state that caused harm when seeking employment.
