





## SC OSHA Employees






### **SC OSHA Expenditures**



Total Expenditures: \$40,507,054




### Wages and Child Labor Enforcement Employees



## Law Change Recommendations

- § 41-15-220 Amend to allow for publication in newspapers with electronic circulation to enhance accessibility for the public and employers.
- § 41-15-260 Amend to provide a compliance mechanism for warrant process and sanctions for non-compliance.
- § 41-15-270 Amend to provide a compliance mechanism for subpoena process and sanctions for non-compliance.



### Law Change Recommendations


- § 41-15-280 –Amend to clarify that the citation will be issued with the penalty, and provide the agency discretion to stay the deadline under certain circumstances.
- § 41-15-300 Repeal to reduce redundancy and streamline statutory provisions.
- § 41-15-520 Amend to clarify the actions taken upon receipt of a public employee complaint.



### Wages and Child Labor Enforcement

#### **GOAL**

Improve and protect the safety and health of South Carolina workers while ensuring employers' compliance with state law



Ensure lawful treatment of employees under state law by investigating complaints alleging violations of the Payment of Wages Act and Child Labor Laws

Advice and training provided by OSHA Legal: Novel issues, Policy changes, Law changes



### Law Change Recommendations

- § 41-13-25 (Child Labor) Clarify penalty options for first offenders.
- § 41-10-30 (Wages) Provide alternative means of employee access to wage statements (i.e. use of current technology).
- § 41-10-40 (Wages) Revise method of payment to allow inclusion of different forms of payment.
- § 41-10-80 (Wages) Revise penalties to enhance compliance mechanisms for violations.








### Office of Immigration Compliance Employees




