Ms. Sulkowski offered welcomes to new members and thank-yous to all, including long-time members, turning the agenda over to her colleague from the Alzheimer's Association, Ms. Taylor Wilson.

Introductions and Business:

Ms. Brewton also welcomed reviewers for grants. Ms. Megan Byers, Dr. Melissa Bailey-Taylor, Dr. Sara English, and Dr. Jessica Broadway have volunteered to help with the grant reviewing process.
- f. Ms. Brewton turned the meeting over to Dr. Maggi Miller, to speak on the Alzheimer's registry. Dr. Miller shared a general overview of the registry and how it serves South Carolina. Information was also shared regarding funding that will enable the SC registry to work with two other state-wide registries, through a five-year grant, working together to develop a conference (early next year) and training series. Dr. Miller also encouraged council members to share expertise with the registry.
- g. Ms. Wilson introduced Ms. Emma Kennedy, who introduced the BOLD program, its objectives and goals, and Ms. Eboni Whitehurst, who will be the project manager for the program, which will include a statewide public health campaign, "Take Brain Health to Heart."
- h. Ms. Taylor Wilson introduced the idea of partnering with SCAN, to strengthen the support network for persons living with Alzheimer's Disease and other dementias and their formal – and informal – caregivers

INTRODUCTION AND NEW BUSINESS

Ms. Byars has agreed to serve as Secretary for the Council.

South Carolina Alzheimer's Network (SCAN) Plan

Ms. Wilson introduced guests of SCAN and shared the possibility of partnering with them to help fulfill the duties of the ARCC Council.

Presentation of the SCAN plan presented by Dr. Milano. Dr. Milano discussed the challenges of getting adequate care for those living with Alzheimer's disease and other related disorders (ADRD), and their families and caregivers. Scan would serve as a network for the state. Other topic discussions:

- Limited clinicians in SC, and in US
- SC dubbed as a "neurology desert", as well as a "geriatrician desert"
- Discussed barriers of clinical trials, not enough research centers
- Discussed models of other states that have a similar SCAN program
- Discussed the importance of collaborations, funding, communication, training, networking, creating "hubs"(clinical centers)
- Primary Care needs to be a major part of the program
- Telemedicine
- Possibility of AAA's being centers

Discussion about the lack of access to healthcare in the PEE DEE Region and other rural areas.

Dr. Carroll discussed the importance of ADRD centers working cooperatively.

Ms. Eboni Whitehurst discussed the BOLD initiative and how it will complement the ARCC and the SCAN plan, and that public health needs to be involved. Ms. Whithurst shared that a strategic plan consultant will be hired to help with the State Plan. She also urged Council to give feedback on the State recommendations.

Dr. Milano thanked the Council for the opportunity to present.

JUNE MEETING PLANS

Ms. Wilson discussed having the June meeting on same day as Governor's press conference. Official day and time TBD. Doodle poll will be sent out. She also would like to have subcommittees meet once before full Council meets. Ms. Taylor shared that the ARCC needs technology for a forum (i.e. keeping documents, calendar of events). She also asked the Council to seek grants for ARCC or for their organizations.

SC ALZHEIMER'S DISEASE REGISTRY UPDATE

Dr. Miller reported that the 2021 Data is complete, waiting for final approval. Data should be on their website (U of SC Arnold School of Public Health, Alzheimer's Disease Registry) in two weeks. One-pager of the data should be available in a couple of weeks. Dr. Miller also stated that she could get Map Data for the SCAN program.

OTHER BUSINESS

Dr. Foster shared that funding opportunities for Alzheimer's disease related to COVID are available. Funding plans for persons who have long Covid.

Dr. Carroll shared that the brain bank is conducting research on those (brains) who had Long Covid.

Ms. Brewton shared that the ACL Community grant will be announced soon, the grant is funding is up to \$100,000. She also reminded the Council about the ARCC grant.

Ms. Wilson reminded members to submit recommendations for the State Plan, Doodle Polls for subcommittees will be sent. She thanked the members for their support.

CALL TO ORDER

Ms. Taylor Wilson, Chair, called the meeting to order at 12:05 p.m., read the FOI statement/Americans with Disabilities Compliance Pledge, and welcomed all council members and guests to the meeting.

APPROVAL OF MINUTES

Dr. Carroll motioned to approve the March 11, 2022 meeting minutes, Megan Byers, seconded. Minutes were approved.

INTRODUCTION AND NEW BUSINESS

Ms. Wilson announced that Dr. Dodge has resigned from the Council, having served since 1994. Director Munn will present an appreciation plaque to Dr. Dodge at a later date.

State Strategic Plan

Ms. Wilson announced that there would be more subcommittee meetings in preparation of the State strategic plan. The Weather's Group was selected to help with the strategic plan. Ms. Wilson introduced Katie Zenger and Rita Drinkwine from the Weather's Group. Ms. Zenger and Ms. Drinkwine discussed some of their approaches to assisting and building a coalition. Ms. Wilson committed on what and how the Weather's Group will help with the 5-year funding flow from CDC.

South Carolina Alzheimer's Plan (SCAN) Update

Dr. Milano introduced team and presented preliminary results from the Plan Primary Provider Survey. The survey is still being conducted, ending June 30, 2022.

- 96.7 % of Adult Primary Care Practices are actively involved with providing care for Alzheimer's patients
- Dementia support most needed is the management of behavioral issues
- Most critical barrier to provide effective care is the lack of specialty and ancillary resources to assist with diagnosis and management
- Next steps, continue to collaborate with statewide stakeholders, develop detailed care model for SCAN
- The survey supports the need for a different Alzheimer's disease care model in South Carolina

Dr. Foster added that this is an opportunity for improvement and the importance of working with PCPs to make them aware of the range of research opportunities to ADRD patients. Dr. Foster discussed the need for more specialists.

Remarks from Director Connie Munn

Director Munn thanked the Council for their support. Pictures were taken with Council members and guests.

Subcommittee Updates

Andrew Boozer (Community Programs, Resources and Caregiver Support) reported on the revised plans, idea to include law enforcement. Mr. Boozer also reported on the virtual library. Ms. Wilson reminded members that the Google library could be found on Google docs.

Denise Kish ((Professional Care In-Home and Facilities (LTC/HCBS), long-term care has workforce issues.

Emma Kennedy (Chair, Public Health: Early Detection/Diagnosis and Brain Health), reported on continuation of funding, Brain Health To Heart messaging, toolkit ready by July 2022, and work on the strategic plan.

Dr. Carroll (Chair, Research and Evaluation) reported on the strategic plan recommendations and the development of the ADRC. Ms. Wilson discussed the importance of the development of the Alzheimer's Disease and Research Center (ADRC) and thanked Dr. Carroll for his involvement with implementing the ADRC.

Brain Challenge Pilot Project

Ms. Wilson announced that on June 27 the mayor of Charleston will challenge faith-based institutions to implement the key components of brain health (exercise, eating healthy, learning something new, and socialization).

ARCC 2022-2023 Grant Recipients

Sheila Lewis gave a report on the grantees, which include the following: Alz Svs of Greater Beaufort, Leeza's Care Connection, Lexington County Sheriff's Department, MapHabit, Inc., Midlands Community Development Corporation, Mother DeVeaux Adult Daycare, Newberry County Council on Aging, Respite Care Charleston, SC Christian Council, Inc., St. James South Santee Senior and Community Center, and Straight Road International.

OTHER BUSINESS

Jennifer Brewton announced that the SCDOA was awarded the Master Plan for Aging learning contract from CHCS. Several community partners, UofSC being one of them, have agreed to collaborate with the SCDOA to help advance a Master Plan for Aging.

The SCDOA is looking to apply for funding for the No Wrong Door System for the state.

New Dementia Specialist position to open soon. This position will be grant funded through the American Rescue Plan (ARP) for two years.

Ms. Wilson announced that Doodle Polls would be sent out for subcommittee dates.

CALL TO ORDER

Ms. Taylor Wilson, Chair, called the meeting to order at 10:00 a.m., read the FOI statement/Americans with Disabilities Compliance Pledge, and welcomed all council members and guests to the meeting.

APPROVAL OF MINUTES

Dr. Carroll motioned to approve the September 16, 2022 meeting minutes, Ms. Moody, seconded. Minutes were approved.

PROCESS REVIEW AND LEVEL SETTING

The Weather's Group facilitated the meeting. Ms. Zenger informed the members that we were in the final phase for direction of the plan. Subcommittees have been meeting from June 2022 to December 2022 and that we were six weeks away from finalizing the plan.

VISION, MISSION, VALUES REVIEW + APPROVAL

- "Vision-All people impacted by Alzheimer's Disease and Related Dementias have the opportunity to live the highest quality of life." Discussion on wording to include "people at risk" or "those who may be impacted".
- Mission-Catalyze statewide collaboration to promote high-quality dementia services and a coordinated and equitable continuum of care across South Carolina for all people affected by Alzheimer's Disease and Related Dementias.
- Value-Dignity, Integrity, Equity, Community, Information.

DEFINING SUCCESS

The members were broken into groups. Feedback (just to name a few) was given on the following strategies:

- Education (the importance of educating providers, the community, legislators, minimizing disparities, care providers, minimizing stigma of ADRD).
- Advocacy & Policymaking (example- taking a grassroots approach, educating legislators, continued awareness of Alzheimer's State House Day).
- Access & Connection to Care (virtual care needed, state funding needed, ADRD clinics needed statewide, collaboration needed across the state, incentives needed to attract talent to SC, role of faith-based community).
- Caregiver Support (resources needed for caregivers at time of diagnosis, resources for those caregivers who are in crisis coping with behaviors related to ADRD, telehealth access, financial support needed, workplace protection for caregivers, respite, expand financial needs).

COUNCIL BUSINESS

Ms. Wilson and Ms. Brewton presented plaques to Dr. Dodge and Ms. Moody in recognition of their retirements and years of service to the ARCC Council. Dr. Dodge has served for 16 years, Ms. Moody, 10 years.

Ms. Zenger stated that the strategic SC Statewide 5-year plan to address ADRD will wrap up by February 1, 2023 and implementation will take place afterwards.

There being no additional business, Ms. Wilson adjourned the meeting.
