Joint Financial Report for a Solicitation Campaign²²

Professional solicitor companies and commercial co-venturers must file a joint financial report with the Division of Public Charities within 90 days of the conclusion of a solicitation campaign, or within 90 days of the anniversary of a campaign lasting more than one year. The joint financial report must be signed by both the professional fundraiser and the charity, and include the following information: (a) gross receipts from the campaign; (b) itemization of expenses; and (c) amount paid to the charitable organization.
