Notary Public Commissions³⁷

Notary public commissions have a duration of 10 years, and are eligible for renewal provided that the notary maintains the statutory requirements. The application fee is \$25.00 (for both new and renewal applications). If a notary application is not complete or the applicant does not meet the statutory requirements for a notary, the application must be rejected by the applicant's Legislative Delegation or Secretary of State.
