Notices of Solicitation and Fundraising Contracts²¹

Professional solicitor companies, professional fundraising counsel, and commercial co-venturers must file copies of their fundraising contracts with the Division of Public Charities at least 10 days prior to beginning any solicitation activity or activity contemplated by the contract in South Carolina. Professional solicitor companies and commercial co-venturers must file a Notice of Solicitation along with their contract, which clearly states the nature of the solicitation campaign, dates of the solicitation campaign, and terms of payment and remittance under the contract.
