Public Charity Annual Financial Report and Extension Requests9

Registered charitable organizations must file an annual financial report with the Division of Public Charities using one of the following: (a) IRS Form 990; (b) IRS Form 990-EZ; (c) IRS Form 990 PF; or (d) the Secretary of State's annual financial report form. There is no filing fee to submit the annual financial report.

Annual financial reports are due four and a half months after the end of the charitable organization's fiscal year. A charitable organization can request up to a six month extension to file their annual financial report.
