Special Purpose District Notification Form⁶

Special purpose districts are districts created by an Act of the General Assembly or pursuant to general law which provide a governmental power or function, such as fire protection, sewerage treatment, water or natural gas distribution, or recreation. Special purpose districts are required to file a notification form with the Secretary of State by December 31st of every even-numbered year. The form must be signed by the county auditor in each county in which the special purpose district is located.

If a special purpose district fails to file the required notification, the Secretary of State may determine that the district is nonfunctioning and notify the governing body of the county or municipality with a certified copy of the letter to any of the last known members of the governing body of the public service district. Thereafter, the district may not be registered with the Secretary of State and it must be declared inactive. In addition. the governing body of the county or municipality shall withhold any fees, taxes, or interest collected for a special purpose district until the special purpose district complies with the notification requirements. The Secretary of State may investigate failure to file notification forms and disclose information.
