

Q17 How familiar are you with the services provided by the South Carolina Department of Vocational Rehabilitation?






Q18 Have you had any direct personal interaction with the South Carolina Department of Vocational Rehabilitation in the last five years?

Q19 Overall, what is your opinion of the South Carolina Department of Vocational Rehabilitation?



	Subject: Enhancing Employment Opportunities for Adults with Intellectual Disabilities through Vocational Rehabilitation (Voc Rehab) Partnerships with the Disability Provider Network - Aligning South Carolina with National Best Practices Dear Honorable Members of the Government Efficiency & Legislative Oversight Committee, I am writing to express my deep concern regarding the current employment outcomes for adults with intellectual disabilities who receive support from South Carolina's Vocational Rehabilitation (Voc Rehab) program. In my personal experience, I fail to see students exiting school who qualify for disability and special needs supports acquire gainful, competitive employment through current VR services. While I appreciate the efforts of Voc Rehab, the number of successful job placements for this population remains critically low, indicating a need for substantial improvement. Adults with intellectual disabilities possess valuable skills and a strong desire to contribute to their communities through meaningful employment. However, they often face unique challenges in navigating the traditional job market. Current Voc Rehab strategies, while well-intentioned, do not consistently provide the specialized support and tailored services necessary for their success. I believe a significant and impactful solution lies in fostering stronger partnerships and contractual agreements between Voc Rehab and the Disability Provider Network. The Disability Provider Network possesses extensive expertise in working with individuals with intellectual disabilities, understanding their specific needs, and offering specialized supports. Contracting with the Disability Provider Network would create a "win-win" situation for all stakeholders: Increased Job Placements: The Disability Provider Network has established relationships with local businesses and a deep understanding of the supported employment model. Some concerns: The services and experiences offered can be very different. The failure to

educate the public about their purpose often trickles down, missing the very people they are charged to help. There is a lack of continuity of service delivery, lack of creativity to their

programming supports, lack of understanding by the employees who work there, lack of education/ outreach to businesses in South Carolina about people with disabilities, lack of concern for employment for people with Intellectual and Developmental disabilities, lack of knowledge, supports, opportunity and interest for those residing in rural areas of South Carolina. The employee turnover is very high contributing to poor outcomes for people with disabilities. It is a very guarded, confusing system which can be very intimidating to the people they are tasked with assisting. In turn this leads to a lack of opportunity or no opportunity at all. Imagine you make an appointment with your local office or you are invited to their office. you are met with difficulty to access: such as locked doors, intercom systems, pressing access buttons to accessible doors that are not operating, you are verified by checking with person you are to see. The staff decide when you are permitted access, all of this is done before you physically have access. You are than forced to produce identification which they actually can take or not to confirm identity. You then must wait for the person who will be seeing you. Upon arrival, the receptionist informed the VR counselor of our presence. However, when the counselor arrived, she immediately questioned my presence and purpose in a manner that felt inappropriate. Despite the receptionist signaling that the window was open, the counselor proceeded to ask, "Who is she?" and "Why is she helping him?" She also inquired why I had asked for her contact details (phone number, email, and VR ID) when assisting my client with setting up the appointment. These questions could have easily been addressed in a respectful manner directly with me, avoiding any unnecessary discomfort. Instead, the counselor closed the window without realizing that we could still overhear her. Her approach was unprofessional, and the tone of the interaction was discourteous. Afterward, the counselor called my client and his mother back for their appointment. The client's mother explained that her son had a medical appointment scheduled for the following Friday, and based on the results, there might be additional appointments. In response, the VR counselor informed us that a case could not be opened because the client was under doctor's care and would need a release to work form. While I understand the importance of ensuring proper documentation, I believe the application appointment should have proceeded, and if the client were unable to work in the future, services could have been suspended at that time. There is a lack of communication between DDSN and SCVRD for those on HCBS Medicaid waivers. Diversity, Equity, and Inclusion (DEI) knowledge for VR staff is necessary beyond any doubt when connecting to any People with Disabilities, including their respected gender identity to acknowledge their feeling of safety. The Information Technology Training Center is old and has not been in use for several years. I am concerned a key occupation field is being left behind at a critical point to provide an accessible way to learn for people looking to work.

In Florence County, I was first told that services were not available to anyone under the age of 16, because NO ONE in the Florence office is given anyone UNDER the Age if 1 Any services, even though the law the mandates that 15% of their VR budget go specifically to Pre-Employment Transition services! Then, when I got the VR state ombudsman involved, he tried everything he could think of to try and provide my son the services he is legally entitled to receive, but one can not make something appear from nothing! So, when there simply are no people to offer pre-ETS services, no Pre-ETS programs to be had, or even the very beginning thoughts of how to try and find, solicit or offer such services in a community, an employee who is simply charged with making people do what that ought to be doing, who is in Columbia, can not create out of thin air, services and people which simply don't exist. So, try as he might I finally told the ombudsman I released him of his duties to try and help me as there was nothing he could do to help me. I also contacted Disability Rights of SC. After having me go through all of the appropriate channels of "higher ups" expressing my grievances, I finally realized that they too were not willing or able for whatever reason to formerly sue or take corrective measures in my behalf, so they were interactive at making anything happen for me a we'll. I was told that they were aware that these services were not being provides as they should be and that they were actively "negotiating" with the various players involved to try and come to a compromise that all could agree on...when I heard this, I was left feeling all the more confused, as I did not know governmental agencies had the freedom and flexibility to "negotiate" the terms when it came to whether or not they were or were not going to meet the legal mandates set forth by congress??? I didn't know they had that right??? So, this disturbed me and bothered me. All in all I also was left very upset realizing that the money we could be spending to properly train the largest minority group in our country (yes, the disabled population!), who are American citizens, who want to work, who would be tax paying, loyal employees and would add so much to the communities they served! Why nobody sees this population of Americans as the most valuable untapped resource we have in America, I just don't understand??? They are eager, willing and devoted!
