As agencies allocate significant resources to fulfilling annual reporting requirements, the House Legislative Oversight Committee and Department of Administration worked together to incorporate requirements of the annual restructuring report with the annual accountability report. Notably, integration of these reports was a frequent request in agency feedback to the committee about its process, and annual accountability reports are filed by agencies the committee has identified it will review as well as some agencies the committee has identified it may review.
