- II. Representative Robert Q. Williams attempts to ask questions on behalf of Representative Marvin R. Pendarvis regarding the need for three additional recommendations. Chairman Newton requests that he hold those questions until Representative William M. "Bill" Hixon makes those recommendations to the committee.

- III. Representative Hixon submits his motion to add additional recommendations and approve the subcommittee study of SC Housing.
- IV. Representative Hixon answers Representative Williams question about the need for the additional recommendations. Representative Williams also asks whether the additional recommendations are consistent with what has been done at other agencies.
- V. Representative Williams questions the agency on whether they welcome the Inspector General's office and the Department of Administration to play a role in the hiring process. Executive Director Bonita Shropshire responds on behalf of the agency.
