## Further Discussion of the Economic Development, Transportation, Natural Resources, and Regulatory Subcommittee's Study of the Department of Transportation

I. As the Committee's previous discussion of the Department of Transportation study was cut short when the House of Representatives went into session, Chairman Newton stated this meeting provided an

- opportunity for the Committee to continue its discussion of the Department of Transportation study.
- Secretary of Transportation Christy Hall was present at the meeting and II. responded to various questions. Representative Williams had questions pertaining to a maintenance shops; promotion of frontline or maintenance workers; roadside grass mowing; and facility upkeep. Representative Finlay had questions pertaining to at-will employment and the length of time required for DOT to terminate the employment of an employee for poor work performance. Representative Bowers had questions about traffic signal locations in Jasper County and event along Interstate 95. Additionally, Representative Bowers made an observation that DOT disagreed with some of the Legislative Audit Council's recommendations and findings. Representative Norman had questions about DOT's drugtesting policy. Representative Felder had questions about the statewide implementation of a road maintenance model that had been pioneered in Rock Hill. Representative Taylor had questions about the ways in which the statewide budget troubles in 2010 and 2011 affected DOT's employment of engineers compared to its employment of maintenance workers. Chairman Newton asked how DOT ensured that its Act 114 maintenance prioritizations were based on up-to-date data. Representative Smith had questions about the status of the "Malfunction Junction" project and the road funding bills under debate in the General Assembly.
- III. Representative Henderson summarized and responded to member questions about the recommendations of the Economic Development, Transportation, Natural Resources, and Regulatory Subcommittee in the Subcommittee's Study of DOT. Several members made statements about the study process including: Representative Williams; Representative Henderson; Chairman Newton; Representative Finlay; and Representative Clary.

Representative Henderson moved that the Committee approve the Economic Development, Transportation, Natural Resources, and Regulatory Subcommittee's Study of DOT. A roll call vote was held, and the motion was passed.
