Attendance

- I. The Education and Cultural Subcommittee meeting was called to order by Chairman James E. Smith, Jr., Thursday, June 23, 2016, in Room 108 of the Blatt Building. Representative Joseph H. Jefferson, Jr. was also present. Representative Gary E. Clary was not present for the brief meeting, but met the other Subcommittee members at the School for the Deaf and the Blind's Braille Production Institute at Leath Correctional Facility following the close of the meeting.

Discussion of the South Carolina School for the Deaf and Blind

- I. Chairman Smith explained that the purpose of the day's meeting was for the Subcommittee to learn about the School for the Deaf and Blind's outreach services, and said that the Subcommittee would tour the facility at which the School produces Braille translations of textbooks for blind and visually impaired children in South Carolina schools.
- II. Chairman Smith said that the Subcommittee would next meet with the School in July, and that it would hear testimony about the School from the public at that meeting.
- III. The meeting was adjourned, and the Subcommittee travelled to the Braille Production Facility of the School for the Deaf and Blind.
