In March 1993, I started work with the Public Service Commission as a staff attorney. In 1999, I was named Deputy General Counsel and in 2003 was named Executive Assistant to the Commission. During my tenure with the Public Service Commission, I represented the Commission Staff in cases before the Commission and drafted pleadings, briefs, and proposed orders. I also advised the Commission as a body and Commissioners individually on matters of law and issues arising on proceeding involving jurisdictional utilities. In October 2004 I joined the Office of Regulatory Staff as General Counsel. In this capacity, I advise agency management on legal matters related to the agency's jurisdiction and operations; work on procurement matters and contracts; represent the agency in proceedings before the Public Service Commission and courts; draft pleadings, briefs, proposed orders, and legal documents; and provide legal advice to the ORS staff members.

During my tenures with the Public Service Commission and with the Office of Regulatory Staff, I have worked on cases and matters involving regulated public utilities in South Carolina. The cases and issues have concerned all of the regulated utility industries, including electric utilities, natural gas utilities, water and wastewater utilities, telecommunications utilities, and motor carriers. As an attorney representing first the Commission Staff and more recently the Office of Regulatory Staff, I have worked with issues and responded to matters involving accounting, finance, economics, and to some degree engineering.
