In February 2019, I was elected to the Public Service Commission from District 2 and have served continuously since being elected. As a sitting Commissioner, I have dealt with issues in all of the areas listed above (energy, telecommunications, consumer protection and advocacy, water and wastewater, finance, economics, statistics, accounting, engineering, and law). Having worked in the area of public utility regulation

for the past thirty-two years, first as an attorney and recently as a PSC Commissioner, I have encountered and dealt with issues in the areas listed.

In March 1993, I started as a staff attorney with the Public Service Commission. In 1999, I was named Deputy General Counsel and in 2003 was promoted to Executive Assistant to the Commission. During my tenure with the Public Service Commission, I represented the Commission Staff in cases before the Commission and drafted pleadings, briefs, and proposed orders. I also advised the Commission as a body and Commissioners individually on matters of law and issues arising in proceedings involving jurisdictional utilities.

Following Act 175 of 2004, I left the Public Service Commission in October 2004 and joined the Office of Regulatory Staff as General Counsel. In that capacity, I advised agency management on legal matters related to the agency's jurisdiction and operations; worked on procurement matters and contracts; represented the agency in proceedings before the Public Service Commission and courts; drafted pleadings, briefs, proposed orders, and legal documents; and provided legal advice to the ORS staff members.

During my tenures as an attorney with the Public Service Commission and with the Office of Regulatory Staff, I worked on cases and matters addressing regulated public utilities in South Carolina, including energy (electric and natural gas), water and wastewater, telecommunications, and motor carriers. Cases included, but were not limited to, rate cases, certification and licensing proceedings, and consumer issues. I also handled appellate cases concerning matters in water and wastewater, telecommunications, and electric industries. As an attorney representing first the Commission Staff and later the Office of Regulatory Staff, I also worked with issues and responded to matters involving accounting, finance, economics, and engineering.

As a Commissioner, my primary responsibility is to decide or rule on matters that come before the Commission for decision. To be effective in my decision-making, I must be prepared on the cases and issues to be decided so that I may formulate my position and be able to discuss the pending matters with other Commissioners.

I prepare for a hearing by studying pleadings and prefiled testimony and reviewing applicable law. During a hearing additional facts or explanations come to light, therefore attendance at the hearing is important. After the hearing, additional work, such as reviewing the transcript and proposed orders, is helpful in reaching a decision.

A number of cases and actions of the Commission do not require a hearing, and it is my responsibility to be prepared on those matters also. Reviewing pleadings and filings on those non-hearing matters are necessary to understand the issues to make a reasoned decision. Preparation for hearings and for Commission Business Meetings takes time, but that work and time are necessary to discharge the responsibilities of decision-making.

Another job function is review of orders before issuance. When I served as Vice Chair of the Commission from July 2020 through June 2022 and Chair of the Commission from July 2022 to June 2024, I reviewed most orders before issuance. I continue to review many of the orders before issuance.

When elected to the Public Service Commission in 2019, there were several cases pending on which I had worked or had knowledge of issues gained during my employment at the Office of Regulatory Staff. I recused myself from those cases. In several cases that were pending while I was employed the Office of Regulatory Staff, I disclosed my prior employment to the parties and their attorneys and offered to recuse if any party had any concern with me sitting on the case. Disclosure of the issue and receipt of responses were handled by an attorney on the Commission Staff so that anonymity was afforded to all parties to ensure that a party or parties could be comfortable with asking for my recusal without me knowing which party or parties requested recusal. In these cases, no party objected to me sitting on the case

In any case where a conflict or potential conflict may be an issue, I will carefully review the matter or issue and disclose information on the question of recusal to the Commission and to the parties and their attorneys as required by the Code of Judicial Conduct. If recusal is warranted, I will recuse myself from the matter.
