I have filed timely reports to the State Ethics Commission over my 38 years in office and when they switched from paper filing to electronic filing in 2010, I did have some problems with quarterly filings being logged in 2012, 2013, 2017, 2020 and 2021 time frame and paid a \$900 penalty. I have had no penalties since 2021.

 - In June of 1998 I lost a primary for the Chairmanship of County Council to Karen Floyd. Fortunately, I was in the middle of my term, so I continued serving and it turned out to be a blessing by not winning. I was able to focus on recruiting great companies to Spartanburg, the Upstate and SC.

I am involved with every aspect of the company from sales, engineering, manufacturing, shipping and our field operations.
