The College and University Trustee Screening Commission is pleased to announce the start of its candidate screening and qualification process. In this initial phase, the Commission will screen the following seats, with additional seats to be screened in subsequent rounds once this first phase is complete.

All application packet material can be found on the College and University Trustee Screening Commission Website. To access the website please go to www.scstatehouse.gov. From there click on the Committee Postings and Report Tab at the top of the page. Scroll down to the Joint Committees section and click College and University Trustee Screening Commission link. Scroll to the bottom of our webpage and you will see a section called Required Forms. Each of these forms must be completed by each applicant who desires to apply for a seat. The application packet must contain all of the required forms and be hand signed where there is a signature required. The final application packet must be submitted in person to the Commission.

The list of required forms that must be filled out and submitted are as follows:

1. Letter of Intent
2. Personal Data Questionnaire
3. SLED Release
4. DMV Release
5. Credit Release
6. Statement of Economic Interest
7. Acknowledgement of Application
