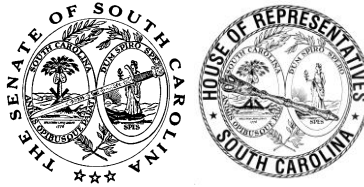

It is required by law that any person who wishes to offer as a candidate for a board position must notify the Legislative Screening Committee **in writing** of his/her intent to offer **for the specific seat**. For the at-large seats, a candidate must reside in South Carolina. For seats designated as congressional district seats or judicial circuit seats, candidates must reside in that congressional district or judicial circuit. For purposes of this committee - residence is determined by driver's license, voter registration, payment of 4% personal property tax and income tax filing.
