

Thank you for inviting RS Bell Architects, LLC to submit this preliminary revised cost estimate to Sumter County for a Fitness Center at the Sheriff's Training Center at the North Main Campus.

Below please find an outline of the project design scope and a proposed Architectural / Engineering design fee:

1. Project Design Scope:

- The proposed facility is approximately 1700 square feet. Single story, slab on grade, wood frame with brick veneer, sloped metal roofing. Interior spaces would include a large open space for exercise equipment, three changing rooms, and washer/dryer area. Site work is limited and only as needed for the building pad. No new parking.
- Estimated construction cost: 1700 square feet at \$225 per square foot = \$382,000,00

2. Architectural / Engineering Fees:

- A/E fees - 8% of estimated construction costs = \$ 30,000, 00

3. Total Project Cost \$ 412,000.00
