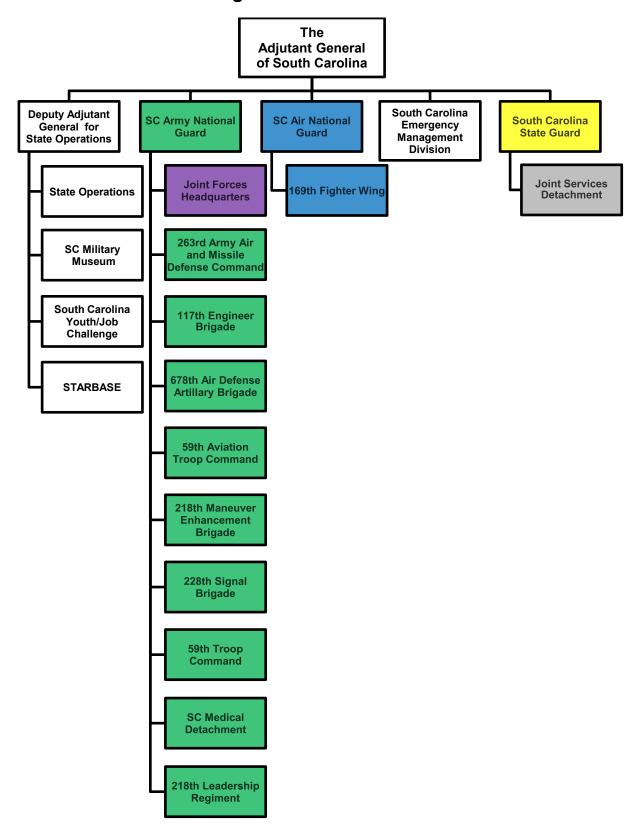

Agency Information and Summary of Budget and Provisos

The Office of the Adjutant General has responsibility for over 234 facilities statewide (62 Readiness Centers, and 172 other facilities and buildings), employs 484 State employees (as of 01 Jul 2023), and is the parent State Agency for a number of subordinate organizations which include:

- SC Army National Guard
- SC Air National Guard
- SC State Guard
- SC Emergency Management Division
- SC Military Museum
- SC Youth/Job Challenge Programs
- STARBASE Swamp Fox
- Joint Services Detachment

These organizations have a total strength of over 13,000 Service Members, State and Federal employees, and volunteers.

The Agency's 2023 State Budget was \$15.7M and its 2024 Budget is \$18.1M. However, in FY 2023 the Agency provided over \$561.02M in total direct economic impact to the State's economy, and an additional \$79.67M in total direct economic impact outside of the State (over \$640.69M total).

- Maintain and grow relevant force structure in the South Carolina National Guard
- Establish a consolidated joint, interagency, intergovernmental, multinational Emergency Operations Center concept of operations

Allocation of funding to support the State match and additional costs required to fund the expansion of the State Emergency Operations

Description

Center (SEOC).

In August 2023, the Agency (SCEMD) received \$7.5M in Federal funding from DHS/FEMA's EOC Construction Grant Program. SCEMD is projected to receive an additional \$7.0M in Federal funding in August 2024. The total project cost is estimated to be \$20.7M.

	Recurring	The costs of construction have increased over the past three years and are projected to reach a total 30% increase by FY25. The Agency is currently appropriated \$2.55 million of Recurring Operating Budget for Armory Revitalizations. This request would raise the recurring Armory Renovations budget level to \$5.8 Million. With this recurring funding and Federal matching funds, the Agency will be able to more efficiently address current and on-going facility revitalizations.

Proviso Requests Information:

Delete - 100.5. - Educational Seminar Revenue

<u>Proposed Text:</u> All revenue earned from educational seminars shall be retained by the agency to be used for the printing of materials and other expenses related to conducting the seminars. The balance of funds shall be reported annually to the General Assembly.

Amend - 100.14. - Disasters Expenditure Status Report

<u>Proposed Text:</u> The Emergency Management Division of the Office of the Adjutant General shall prepare a quarterly report on the status of the expenditure of the funds appropriated in the current fiscal year or in a previous fiscal year FEMA Match <u>for all open federally</u> <u>declared disasters</u> for the 2015 Flooding, for Hurricane Matthew, and for the Pinnacle <u>Mountain Fire</u>. The quarterly report must include, but is not limited to, expenditure by category of work by state/local and by county and shall be submitted to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee beginning September 30, 2018.

Delete - 100.16. - Natural Disaster FEMA Match

Proposed Text: The Office of Adjutant General, Emergency Management Division shall be authorized to utilize existing fund balances to provide the non-federal cost share to state and local government entities for work that is eligible under the Federal Emergency Management Agency Public Assistance Program for Hurricane Irma and Hurricane Florence. Existing fund balances may not be used to provide the non-federal cost share to private non-profit entities.

The Office of Adjutant General, Emergency Management Division is directed to use existing fund balances for the 2015 Flood disaster (Presidential Disaster Declaration DR-4241) to reimburse counties and municipalities with unreimbursed non-federal cost share from the 2014 Ice Storm disaster for storm cleanup expenses incurred during and after states of emergency declared by Executive Orders 2014-06 and 2014-11 and Presidential Disaster Declaration DR-4166. Counties and municipalities must submit an application for such funds by July 31, 2018.

The \$500,000 authorized by Proviso 100.21 in Act 264 of 2018 for grants for non-profit entities may be carried forward and used for the same purpose in Fiscal Year 2022-23. The Emergency Management Division shall prepare a report listing the name of the grant recipient and the amount received and submit the report to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by January 15, 2023.

Add - New - Armory Operations Carry Forward

Proposed Text: The funds appropriated for Armory Operations: Other Operating Expenses may be carried forward from the prior fiscal year and expended for the same purpose in the current fiscal year.

Add - New – South Carolina Military History Foundation Support

Proposed Text: From the funds authorized or appropriated for State Military
Department operations, the Adjutant General may authorize Agency personnel to
support and assist the South Carolina Military History Foundation, a state chartered
and federally recognized tax exempt 501(c)(3) association, in its missions to
support the South Carolina Military Museum and to promote the education of the
citizens and visitors of the State of South Carolina.

Add - New - Retention of Revenue By The South Carolina Military History Foundation

Proposed Text: The Office of the Adjutant General and the South Carolina Military

Museum Board may enter into agreements with the South Carolina Military History

Foundation, a tax exempt 501(c)(3) nonprofit entity organized under the laws of this

state, to utilize Agency resources to generate revenue from activities at the South

Carolina Military Museum or elsewhere, including but not limited to program fees,

professional services, donations, food service, exhibits and exhibit components.

The agreements must specify that the Foundation may not charge program fees to

students of any South Carolina public or private elementary school, middle school,
high school, home school, alternative home school, or an association for home

schools who are touring the museum or accessing the Museum's programs as part
of a school function. The agreements must also specify that these revenues will be
segregated from the other income or revenues of the Foundation and that those
revenues will be used solely to support the Museum.

Add - New - Safeguarding Tomorrow Revolving Loan Fund

Proposed Text: Upon award of a Federal "Safeguarding Tomorrow through Ongoing Risk Mitigation Act" capitalization grant, the South Carolina Emergency Management Division (SCEMD) is authorized accept the grant, and to establish and manage the South Carolina Safeguarding Tomorrow Revolving Loan Fund in accordance with the provisions of the Federal Act and applicable State laws, regulations and policies.

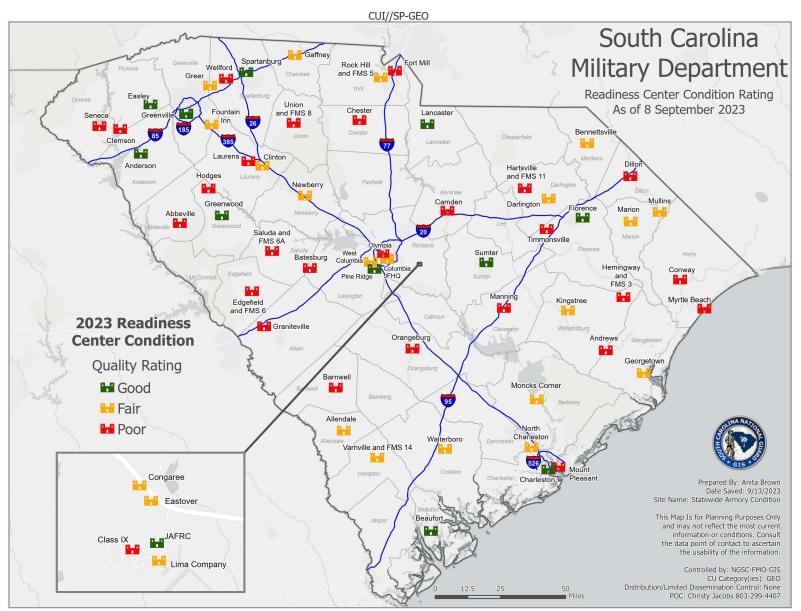

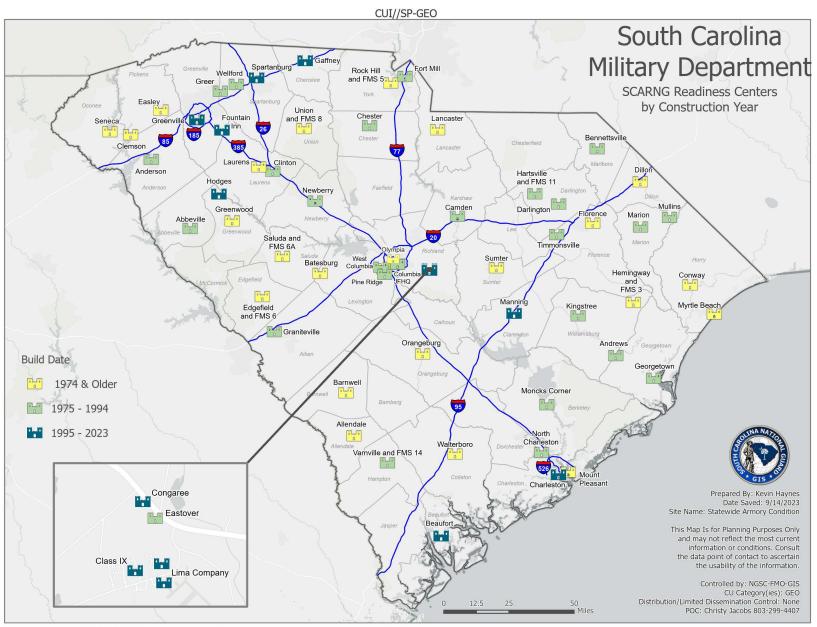

- During FY23, the Office of the Adjutant General demonstrated its ability to meet its response and recovery mission requirements by responding to and/or coordinating assistance efforts for two tropical storm event severe winter weather events (Hurricane Ian and Tropical Storm Nichole) and six EMAC support missions (Montana, New Mexico, Kentucky, Mississippi, California and Texas).
- In addition to serving as the State Coordinating Agency for the State responses, SCEMD continued to support on-going recovery operations from the 2015 Severe Flood, 2016 Hurricane Matthew, 2017 Hurricane Irma, 2018 Hurricane Florence, 2019 Hurricane Dorian, 2020 February Severe Weather and April Tornadoes, the 2020-2021 COVID Pandemic, and 2022 Hurricane Ian. Since 2014, SCEMD has processed \$1.3B in eligible Public Assistance (PA) reimbursements (for response costs and public infrastructure repairs/rebuilding) and more than \$71M in pre- and post-disaster Hazard Mitigation Grant Projects.

The Construction and Facilities Maintenance Office (CFMO):

- Completed \$1.2M in designs for renovations of Laurens and Union Readiness Centers with planned construction in FY24.
- Initiated \$1.2M in designs for renovations of Wellford and Hartsville Readiness Centers with projected construction in FY 25.
- Completed addition of female restrooms at Walterboro and Hartsville Readiness Centers at a shared State/Federal cost of \$697K.
- Began addition of female restrooms at Wellford, Abbeville, and Batesburg Readiness Centers at a shared State/Federal cost of \$953K.
- Completed replacement of the Hemmingway Readiness Center roof with a shared State/Federal cost of \$900K.
- Initiated \$303K design to renovate the Olympia Armory (State Guard) with a projected construction cost of \$4.2M in FY24.

- During FY23, the Youth and Job Challenge Programs operations continued to be impacted by COVID. The Programs conducted ongoing adjustments to their job processes and procedures to ensure the safety of the cadets and Staff.
- The Youth Challenge Program is a community-based, quasi-military structured educational program.
 - During FY 22-23, the Youth ChalleNGe Program graduated 100 cadets who earned 53 GEDs.
 - Since its inception in 1998, the Program has graduated 5,111 cadets with 1,907 earning their GED.
- The Job Challenge Program provides hands-on job skills training through college trade courses as an optional follow-on program for selected Youth Challenge Program graduates.
 - During FY 22-23, the Job ChalleNGe Program graduated 35 cadets.
 - Since inception in 2016, the Program has graduated 16 classes with 338 graduates.

- STARBASE Swamp Fox, a DoD sponsored Science, Technology, Engineering and Math (STEM) program for 5th grade students is designed to augment, enhance, and reinforce the State's educational curriculum and standards. The Program acts as a catalyst for encouraging students' future interest and studies in STEM subjects and career focus.
 - In school year 2022-2023, the Program continued to experience challenges due to continuing issues resulting from the COVID pandemic, short notice cancelations, and school districts' shortages of bus drivers.
 - In spite of these challenge, STARBASE Swamp Fox provided inperson instruction to 1,200 students with 15 schools participating from 8 school districts.
 - As a result of these on-going challenges, STARBASE Swamp Fox was re-designated as a "One Class" program for the 2023-2024 School Year.

- The South Carolina Military Museum continued its mission to preserve the legacy of the Palmetto State's military history, build community partnerships, expand the facility footprint, and improve the visitor experience.
- In FY 23, the Museum's visitor numbers surpassed 13,500 which is the Museum's largest recorded attendance to date.
- The new on-site and off-site education programs have impacted over 2,500 people. New digital resources included events and updates on a new Museum Education website and downloadable lesson plans from Teacher Pay Teachers. In February, the Museum launched the new "STEMsquad Kids Club" which currently has 180 youth members from 27 cities around the State.
- During FY23, the Museum's website traffic included over 15,800 unique visitors, and, from April-May 23, the Museum's internal Facebook post boosting campaign saw a total of 83,806 impressions.

- Continued marketing efforts through billboards, television and radio advertisements, and a digital media presence.
- Launched a digital newsletter campaign with over 1,100 subscribers in January 2023 which generated a 44% open rate.
- Provided SC related artifacts for an exhibit at the SC Department of Veterans Affairs, and installed a new permanent exhibit on 20th Century weapons.
- Established a Veterans Oral History Project in affiliation with the Library of Congress which was followed by the start of quarterly Lunch and Learn series.
- Opened a temporary exhibit entitled Skytrails, South Carolina
 Airfields: Then and Now which showcased several loaned items
 from individuals in the aviation community and was featured in the
 Columbia Star newspaper.
- Dedicated and renamed Gallery I in honor of long-time donor and friend of the museum, Charles Cauthen.

- The SCARNG continued its mission is to generate mission ready units able to fulfill both its Federal and State missions and ensure relevance through the adaptation of its force structure to meet the challenges of the 21st century.
- Approximately 10% of the SCARNG was engaged worldwide in both the Continental US and 5 foreign countries including Kuwait, Djibouti, Kosovo, Germany and Colombia. The SCARNG was also involved in various CONUS-based missions such as support to the 10th Mountain Division's WARFIGHTER Exercise at Ft. Drum, NY, air defense support to the National Capital Region and the U.S. Army European Command, and operations on the Southwest Border.
- In September 2022, the SCARNG mobilized 94 personnel and forward positioned high water vehicles to locations in Charleston and Georgetown Counties in anticipation of potential flooding resulting from Hurricane Ian. Fortunately, the impacts were not as severe as anticipated and the mission ended after three days.

- In June-July 2023, the SCARNG deployed 150 Soldiers to Texas to provide EMAC support for border protection. The 1-118th IN deployed the first personnel to Texas on 30 June with the end of the mission occurring on 31 July.
- From 01 July 2022 30 June 2023, the SC National Guard Funeral Honors teams conducted 2,119 Military Funerals. These funerals were in support of Service Members from all branches of the Armed Forces and other Service Components.
- The SCARNG remained ready for quick reaction to any DSCA event by conducting two large scale exercises in concert with other State and Federal agencies.

- The 169th Fighter Wing continued to provide continual support of the Aerospace Control Alert Mission, defending east coast air space in support of North American Aerospace Defense Command (NORAD). Additionally, the Wing provides the Governor with defense assistance to the State's homeland security office, and disaster preparation and response support for DSCA activities.
- During FY 22, SCANG personnel deployed across the Pacific Theater of operations in support of two multi-national exercises.
- As part of the SPP, the Wing continues to support SC's State
 Partner, the Republic of Colombia, with interactions in Colombia and
 supporting operations in the U.S.
- The SCANG completed resurfacing of the McEntire JNGB runway.
 During the resurfacing project, the 169th Fighter Wing conducted all aircraft operations from the Columbia Metropolitan Airport.

- The Wing hosted high school Junior Reserve Officers Training Corps teams from around the State for the "Top Gun" drill meet competition which welcomed over 300 cadets to McEntire JNGB.
- The SCANG is currently executing \$46M in construction projects on McEntire JNGB with an additional \$43M in projects in the contracting process. Over the next 10 years plans include over \$170M in upgrades to McEntire JNGB facilities.

- In May 2023, the SC State Guard provided Cybersecurity training both in-state and one out-of-state location (Delaware) in response to a request by the Delaware Air National Guard.
- In June 2023, the SCSG conducted a training exercise at North Field in North, SC with training scenarios including responding to hurricane/tornado damage and damage resulting from a subsequent earthquake, responding to a mass casualty incident, and conducting coordination with local authorities.
- During FY 2023, the SCSG also conducted 16 Honor Guard missions across the State at locations including Fort Jackson, Murrells Inlet, Varnville, Anderson, Beaufort, Manning, and North Charleston. One out-of-state request for Honor Guard support was conducted at Calabash, NC.

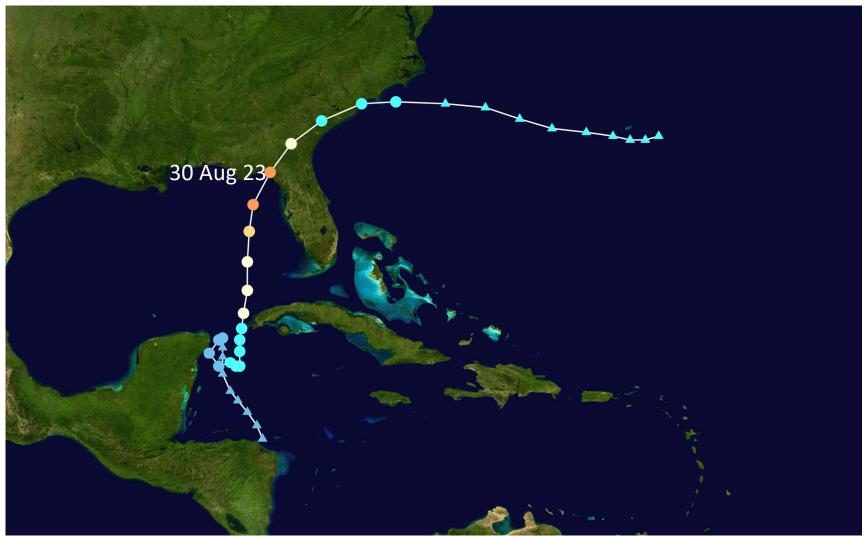

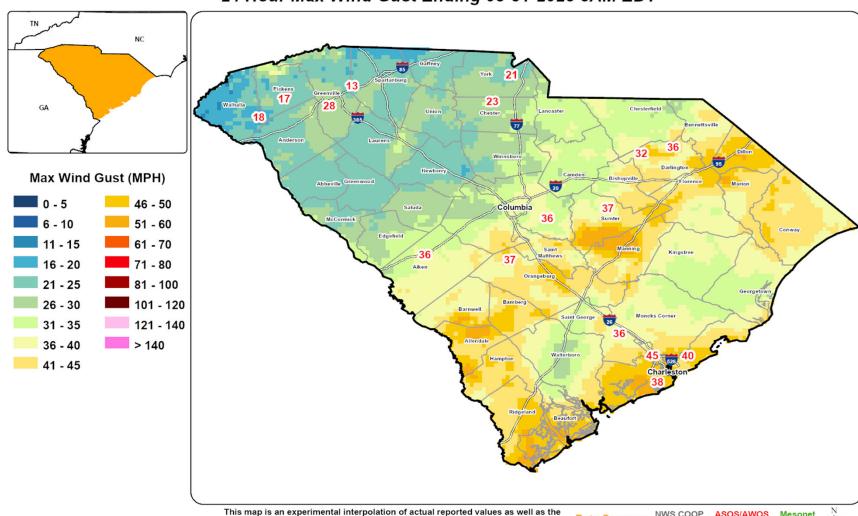

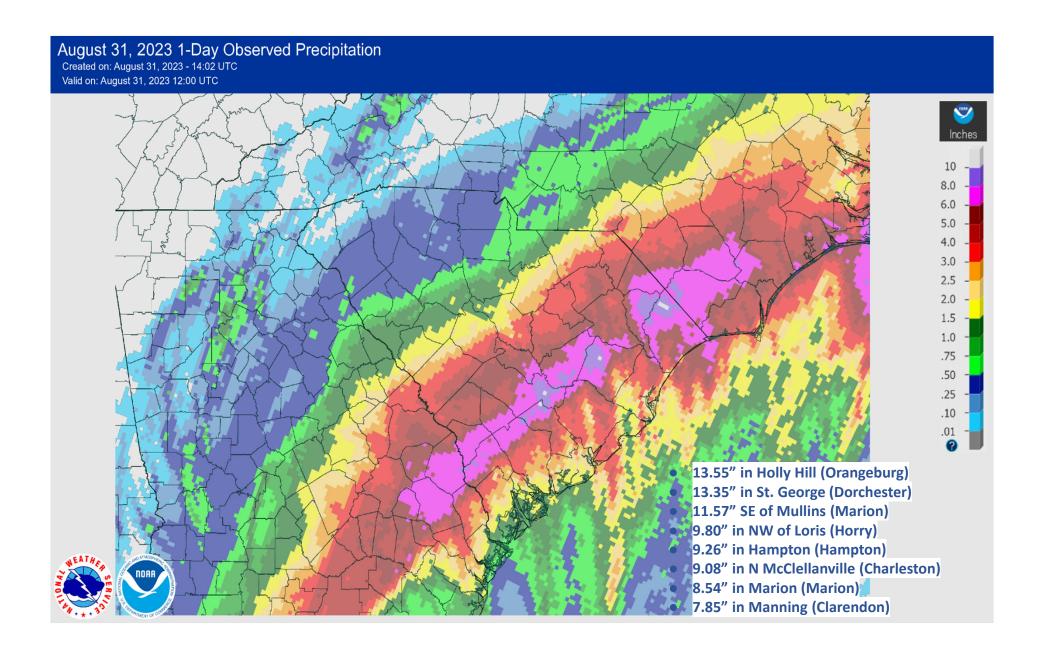


24 Hour Max Wind Gust Ending 08-31-2023 8AM EDT
