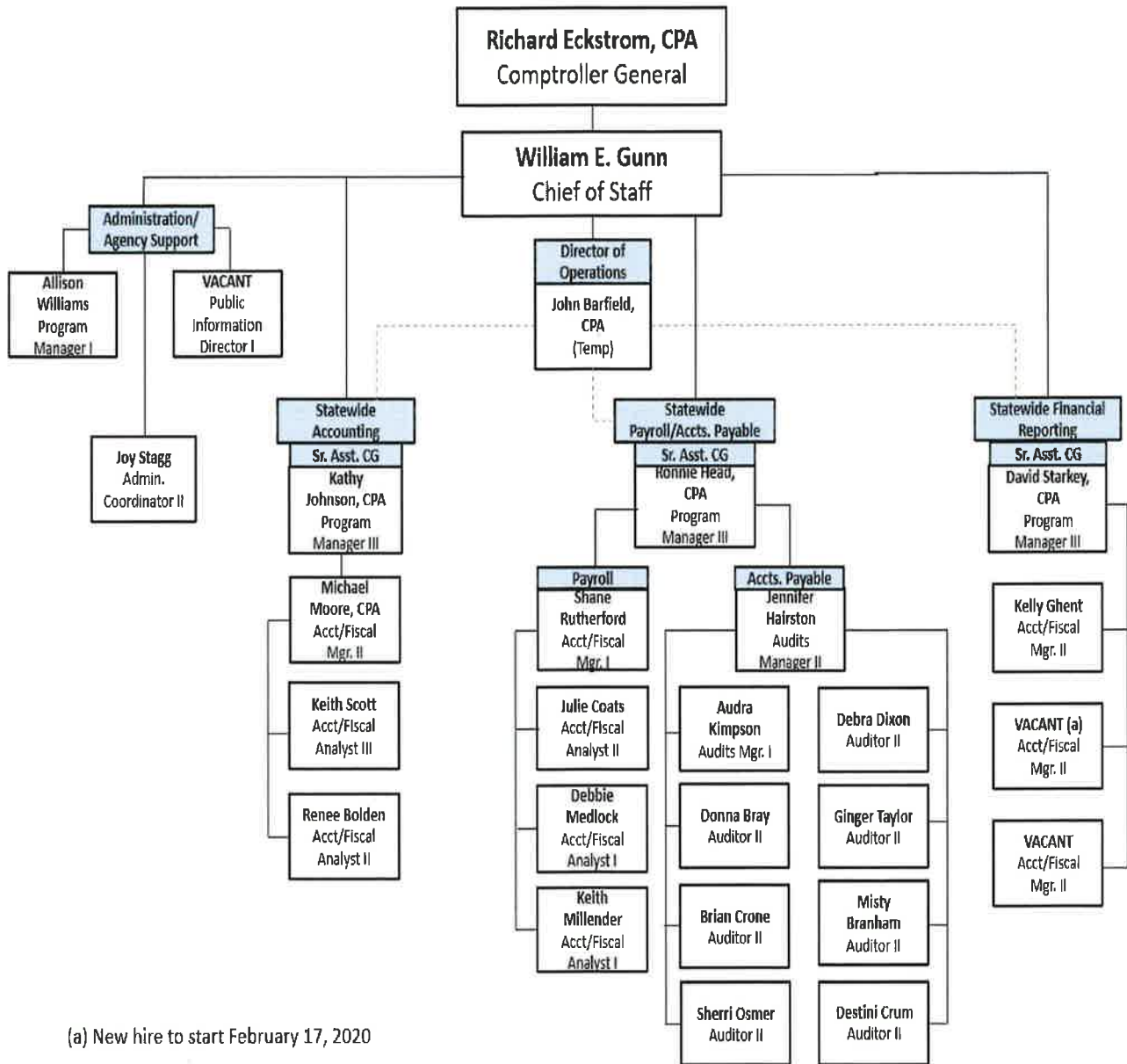

Office of the Comptroller General Overview

Budget Request:

- We are not requesting a budget increase. However, we request that our agency's funding be maintained at current levels.
- We are requesting that the following provisos be amended:
 - 118.1 (SR: Year End Cutoff), to revise the dates for the closing of the state's books for fiscal 2020-21
 - 1A.7 (SDE-EIA: Disbursements/Other Entities), to remove the Comptroller General's Office from the proviso as our office is no longer involved
 - 82.3 (DMV: DPPA Compliance Audit), to remove the Comptroller General's Office from the proviso as our office is no longer involved

Agency Overview: The Comptroller General's Office (CGO) serves as a professional services support agency for state government. As such, it leverages the "back office" capabilities of all other state agencies. Specifically, the CGO consists of five program areas (divisions) providing the support services described below:

- **Statewide Payroll/Accounts Payable:** Process state payroll, vendor payments, and other disbursement requests for state agencies to support agencies in serving the public.
- **Statewide Accounting:** Provide centralized accounting services for state agencies to support them in serving the public.
- **Statewide Financial Reporting:** Produce the state's comprehensive annual financial report (CAFR) in a timely, accurate, and understandable format for use by credit rating agencies, underwriters, investors, and other key customers and stakeholders.
- **Other Services/Online Outreach:** Provide financial transparency and other information to stakeholders and service on key panels supporting internal and external state functions.
- **Administrative Services:** Manage the divisions, programs, and operations of the CGO and support other collaborative initiatives to assist in serving the public.

Agency Mission and Vision:

- **Mission:** To support other state entities with essential services that include payroll, vendor payments, accounting support, general ledger maintenance, and statewide financial reporting, and to continuously monitor and improve these essential services to enable state government to better safeguard the financial resources entrusted to it and more responsively serve the citizens of South Carolina.
- **Vision:** To be state government's centralized source for transparent financial information leading to more open, accountable, and responsive government.



SUMMARY

The Office of Comptroller General would attempt to absorb a 3% general fund reduction by delaying the filling of a vacant position in our Statewide Accounting Services division. The previous employee to hold the position earned an annual salary of \$64,874, plus employer costs for retirement \$13,371 and FICA \$4,963 for a total cost to the agency of \$83,208.

By further delaying the filling of this position, it would lessen the capacity of our Statewide Accounting Services division to achieve its overall goal in accordance with the agency's FY 2018 – 2019 Accountability Report. This goal calls for the division to provide centralized accounting and support for the State's financial activities in accordance with the program structure mandated by the S.C. General Assembly by providing accounting direction and support to other state agencies.

AGENCY COST SAVINGS PLANS

The Office of the Comptroller General continuously strives to reduce costs and save. We do this by delaying the filling of vacant positions, and filling positions at a lower salary.

As a contingency, we would delay filling a position in our Administrative Services Division, which would reduce agency costs about \$70,000. However, these funds will be needed to fill this vacant position.

SUMMARY

This fee helps support our Statewide Payroll staff, which is a staff of four, that process payroll for state employees.

These four employees ensure that retirement, deferred compensation, bonuses, special payments, special voluntary deductions (premiums for insurance products not offered by state government, elective credit union deposits, tax liens, and court-ordered wage garnishments), and regular compensation is processed correctly and timely for approximately 45,000 state employees. They are also responsible for issuing approximately 56,500 W-2s annually, and depositing state and federal tax withholdings.

To reduce or lose this fee, would significantly impact our ability to perform these vital functions in a timely manner.
