

Secretary of State's Office Mission Statement

The mission of the Secretary of State's Office is to provide innovative technology to enhance the transaction of business in the state, to serve the business community and members of the public with prompt and efficient customer service, to protect the charitable donors of South Carolina, and to fulfill all other statutory duties of the office.

Budget Request Summary

I. Other Funds Authorization Increase - \$165,000

- The office is seeking an increase in spending authority to self-fund several information technology initiatives rather than requesting a large capital request. The requested amount is required to accomplish the statutorily mandated duties and mission of the Secretary of State's Office, including the enforcement of the Solicitation of Charitable Funds Act, SC Code §3-56-10, et seq.
- ➤ An increase of \$165,000 operating will be spread throughout the programs in the agency.
 - This would include application support for the information technology throughout the office.
 - In addition, necessary information technology projects which would increase the number of permanent records maintained in a digital format would be initiated.
 - Furthermore, continued enhancements to the charities web application is necessary to provide increased functionality for public users and staff.

II. Other Funds Retirement, Health, and Pay Allocation - \$49,650

- > The requested funding would support all divisions of the agency which are staffed by employees whose compensation is supported by other funds. Therefore, all goals and strategies the office seeks to meet would be impacted by the fulfillment of this funding request.
- The Secretary of State's Office has 14 FTEs supported by other funds. This funding request would support the 2.5% Pay Plan Allocation. With increasing rates, the Secretary of State's Office needs an increase in its other funds authorization in retirement, health, and dental to cover the employer portion.

III. New FTE – Charities Division – Administrative Assistant - \$45,000

- > The Secretary of State's Office has the responsibility of enforcing the Solicitation of Charitable Funds Act.
- ➤ In FY 2020-21, 15,985 charitable organizations registered or filed annual applications for exemption. This is a 13% increase over the previous year, along with a 25% increase in annual financial reports and extensions.
- As a result of continued collection of fine revenue for violations of the Solicitation of Charitable Funds, the office remitted over \$200,000 in fine revenue to the General Fund.
- An Administrative Assistant FTE is needed for the Division of Public Charities in order to meet the challenges of this increase in volume, in fulfilling statutory requirements, and providing customer service to assist individuals and charitable organizations filing with the agency.

Secretary of State's Office Accountability Report Fiscal Year 2020-2021

- In FY 2020-21, the Secretary of State returned \$13,356,429.11 to the State General Fund, while receiving state appropriations of only \$1,246,839.
- The Secretary of State's Office is integral in the transaction of business in the state and duties of the office are mandated by statute.
- Failing to accomplish our goals and objectives would have a detrimental impact on business and the economy in South Carolina, since articles forming, amending, and dissolving businesses are filed in the Secretary of State's Office.
- The customers we serve include individual members of the public, business entities, nonprofits, charitable organizations, lending institutions, the legal community, accountants, state agencies, and members of the legislative and executive branches of government.

Accountability Report Highlights

- In FY 2020-21, IT staff finished the second phase of the Charities Division Enhancement project, which upgraded the internal side of the application.
- As the COVID-19 pandemic continued into FY 2020-21, the Secretary of State's Office saw an increase in the usage of online applications. For example, online adoption for business filings rose from 81.4% at the end of FY 2019-20 to 90% in FY 2020-21.
- In FY 2020-21, the Secretary of State's Office opened 32 counterfeit investigations, and participated in in investigations which led to 2 arrests, 15 cease-and-desist orders, and the seizure of \$2,068,920 in counterfeit merchandise. As a result of the efforts from the Secretary of State's Office working with the US Department of Homeland Security, the Investigations Division was able to assist with the interception of \$455,265 in counterfeit goods before they were circulated in South Carolina.
- The Secretary of State's Office is responsible for Uniform Commercial Code Article 9 secured transaction filings and the agency saw a significant increase in the number of these business fillings during FY 2020-21. The number of Uniform Commercial Code filings increased by 12% percent from the previous year, from 117,819 filed in FY 2019-20 to 132,271 filed in FY 2020-21.
- The number of corporate filings increased by 58% percent, from 98,077 filed in FY 2019-20, to 155,449 filed in FY 2020-21. The total number of business filings for FY 2020-21 was 287,720, up 33% from the 215,896 filed in FY 2019-20.
- In FY 2020-21, 15,987 charitable organizations registered or filed annual applications for registration exemption with the Secretary of State's Division of Public Charities. Of these registration filings, 71% were filed using the Secretary of State's Online Charities System.
- The Charities Division also filed 4,178 professional fundraiser registrations, fundraising contracts, and joint financial reports. The Charities Division assisted 18,470 customers via telephone.
- The Secretary of State's Office collected \$402,995 in fine revenue for violations of the Solicitation of Charitable Fund Act in FY 2020-21. This was a 5% increase over the previous fiscal year.
- In FY 2020-21, the Secretary of State commissioned 18,776 notaries public. As of June 30, 2021, there are 147,179 commissioned notaries public in South Carolina who play an important role in the prevention of fraud.

The office is seeking an increase in spending authority in order to self-fund several information technology initiatives rather than requesting a large capital request. The requested amount is required to accomplish the statutorily mandated duties and mission of the Secretary of State's Office, including the enforcement of the Solicitation of Charitable Funds Act, SC Code §3-56-10, et seq. An increase of \$165,000 in operating will be spread throughout the programs in the agency. This would include application support for information technology throughout the office. In addition, necessary information technology projects that would increase the number of permanent records maintained in a digital format would be initiated. Continued enhancements to the charities/raffles/professional fundraiser web application would also be possible.

The Secretary of State is responsible for the enforcement of the Solicitation of

Charitable Funds Act. The addition of one other funded FTE would assist the Public Charities Division with the enforcement of the Solicitation of Charitable Funds Act. In FY 2020-21, 15,985 charitable organizations registered or filed annual applications for exemption. This is a 13% increase over the previous year. Annual financial reports and extensions for charitable organizations increased 25% to 22,060. The agency continued to collect fine revenue for violations of the Solicitation of Charitable Funds Act, and as result, remitted over \$200,000 in fine revenue to the General Fund. The addition of one FTE would assist the Public Charities Division in fulfilling statutory requirements and providing customer service to assist individuals and charitable organizations filing with the agency.

	Service delivery to customers would be directly impacted by the reduction of an FTE. The 3% possible future cut would require moving a state-funded position to an other-funded position. It would also prevent the office from filling any position that becomes vacant. This reduction in staff would impact the agency's ability to serve customers.

The Secretary of State's Office continues to reduce costs to taxpayers by working with the state portal, NIC SC (formerly SC.gov), to provide online filing applications to our customers, such as the Uniform Commercial Code (UCC) and Business Filings Online applications. No multi-million dollar capital requests were made for either project; thus, the services were provided at no cost to the taxpayers. During FY 2022-23, the office will continue to work with NIC SC to expand the online filing options on the business filings, search and document retrieval application and make enhancements to the UCC online search and filing application. The Secretary of State's Office is an integral part of conducting business in the state and constantly works to provide customers the best possible online solutions while saving taxpayers money.

Additionally, most fees collected by the agency have not been increased for several decades and therefore have not maintained pace with inflation.
