AGENCY OVERVIEW

Agency History

The South Carolina Department of Archives and History (SCDAH) was established in 1905. It evolved from the Public Records Commission of South Carolina, which was appointed in 1891 to obtain copies of South Carolina records from the British Public Records Office, and the South Carolina Historical Commission, which was created in 1894 to acquire further historical documents and was given additional record-keeping duties in 1905. Today the agency is governed by the South Carolina Commission of Archives and History.

Mission

The agency's mission is to preserve and promote the documentary and cultural heritage of the state through the state archives, historic preservation, and education programs.

Major Program Areas

The agency has two operational divisions: **Archives and Records Management**, and **Historic Preservation (State Historic Preservation Office)**, and an Administrative Division.

The **Archives and Records Management Division** operates the State Archives and Research Room, where the agency preserves and houses over 40,000 linear feet of the state's most valuable historic documents dating from 1671 to 2017 and makes them available to the public for research purposes at 8301 Parklane Road in Columbia. The hours of operation for the Research Room are Tuesday-Saturday, 8:30 AM to 5:00 PM. Research Room staff members are available on Mondays from 8:30 AM to 5:00 PM to assist patrons by telephone and email. Additionally, the Archives and Records Management Division is responsible for the State Records Management Program, through which SCDAH works with other state agencies and local governments to properly manage their records with the goal of identifying and preserving for public access those records of historical/archival value. The Records Management Program also operates the State Records Center on Laurel Street in Columbia, which saves state and local government agencies over \$3,000,000 annually by storing, free of charge, up to 90,000 linear feet of non-permanent records for over fifty state agencies and commissions.

The **Historic Preservation Division**, also known as the **State Historic Preservation Office**, encourages and facilitates the preservation of South Carolina's irreplaceable historic and prehistoric places. It manages the National Register of Historic Places in South Carolina as well as review and compliance for other federally-mandated preservation programs as dictated by the National Historic Preservation Act of 1966. In addition, the State Historic Preservation Office operates the State Historical Marker Program.

AGENCY ACCOMPLISHMENTS FY 24-25

During FY 2024-25, the SC Department of Archives and History (SCDAH) continued to make significant progress in its ongoing mission to preserve and promote South Carolina's documentary and cultural heritage. Through its Archives and Records Management Division, SCDAH continued to expand agency outreach, while improving services for customers and stakeholders. This was made possible through ongoing enhancements and additions to SCDAH's digital repositories, including the South Carolina Electronic Records Archives (SCERA), Online Records Index (ORI), and the South Carolina Historical Property Record (SCHPR). The agency's Historical Services Division, which includes the State Historic Preservation Office (SHPO), continued to pursue its mission to encourage and facilitate the responsible stewardship of South Carolina's irreplaceable historic and prehistoric places. The division reduced customer response times, a process facilitated by the further digitization of all grant, tax credit, and review and compliance applications in compliance with federal directives. SCDAH's Administrative Division continued its work to address the increasing competition for meeting and event rentals that has resulted from a growing number of local rental venues. To address the increased competition for the rental market, the agency has reevaluated and revised its rental rates, while also planning for the expansion of its outdoor meeting space as an important design element of its enlarged exhibit hall. The agency also has sought to increase retail sales through the agency's gift shop and through the sale of merchandise at trade shows within the state. These accomplishments, and those listed below, are emblematic of an agency endowed with an enthusiastic, focused, and professional staff, which is constantly searching for ways to improve processes, better serve the people of South Carolina, and preserve the Palmetto State's rich documentary and built history.

Archives and Records Management Division FY 24-25

Archives

- Hosted 1,955 Research Room visits from 1,396 patrons and answered 4,640 queries from researchers (telephone 2,760; email 1,839 and letters 41);
- accessioned 1,116.18 cubic feet and 7,912.78 MB of records, 3 rolls of microfilm, 413 volumes and processed 729.45 cubic feet and 1,383.19 MBs of records;
- Scanned 201,802 historical documents, 297 audio cassette tapes and digitized 70 microfilm rolls;
- Educated 756 members of the public and state/local officials through 26 facility tours and 9 speaking engagements;

- Captured and provided access to state agency websites through the continued use of the non-profit website Archive-it. In all, the agency crawled 118 state agency websites and retained 251.4 GB of data;
- Ingested 58,507 MBs (62,835 files) of state agency and county government records into the South Carolina Electronic Records Archive (SCERA);
- Web page views: Main page 209,351; Research and Genealogy page 10,640; and On-Line Records Index 34,755.

Records Management

- Transferred 3.43 million pages of historically significant records (paper, microfilm and electronic) from state and local government offices to the Archives for permanent retention;
- Transferred 6.01 million pages of state agency paper records to the State Records Center for security storage;
- Authorized the destruction of 135.1 million pages of non-permanent state and local government records;
- Prepared 154 retention/disposition schedules representing 879.4 million pages and 12.4 million MBs of state and local records;
- Fielded 2,284 contacts with state and local government officials regarding records management;
- Approved 98.8% of retention schedules within two weeks of submission; and
- Implemented records retention schedules for 50% of state agencies and 15% of local governments.

Cost Avoidance

- By working with state and local governments to set retention limits for records and by providing storage in the State Records Center for inactive, limited-term records from state agencies, the division achieved cost avoidance to the state of \$1,211,919.

Historical Services Division FY 24-25

- Celebrated the unveiling of the 2000th State Historical Marker at Finley High School at a dedication event in Chester on October 18, 2024 attended by Governor Henry McMaster. Opened the exhibit "["Know Your State and Make It Known: The South Carolina Historical Marker Program"](#)" on December 5, 2024. Approved 58 new historical marker texts in 29 of the state's 46 counties (63%). Of the approved marker texts, 53% focused on African American history and historic places.

- Awarded [18 planning grants](#) and [6 stabilization grants](#) in the third application round of the [Historic Preservation State Grant Fund](#) program totaling approximately \$1.5 million. Worked with applicants to begin these projects, and also to finish projects from prior rounds such as the Bull Swamp School in Orangeburg County and Walnut Grove Plantation in Spartanburg County.
- Selected 4 projects to receive a total of \$104,000 in subgrants from the federal FY 2025 Historic Preservation Fund. Closed out the federal grant (\$1,946,485) to address damages to historic properties from Hurricane Irma.
- Facilitated the investment of \$154.5 million in historic buildings through completed federal (16) and state homeowner (9) [historic tax credit projects](#). Average project review time was 9.0 days.
- Held three meetings of the State Review Board for the [National Register of Historic Places](#), approving 20 nominations to the National Register of Historic Places (up from 14 last year). Of these, 40% had significance for African American history. Staff evaluated 563 archaeological sites and 1,104 architectural resources for National Register eligibility.
- Completed the NPS Underrepresented Communities grant (\$50,000), which resulted in adding eight properties in South Carolina with significance in African American history to the National Register of Historic Places.
- Reviewed 1,871 compliance project information submittals (number of requests have increased 30% over the past 2 years). Requests from SCDES-BCM doubled in the past year. Signed one Programmatic Agreement and eight Memorandum of Agreements to mitigate adverse effects to historic properties. Made 26 site visits related to compliance projects and another 28 architectural assistance site visits. Provided support to SC EMD and FEMA related to hurricanes Debby and Helene.
- Facilitated training for 58 individuals from four Main Street communities on historic preservation with Main Street South Carolina. Offered seven sessions at the annual statewide Preservation Conference for SCPEAC Continuing Education credits for local government staff and board members. Completed evaluations of three Certified Local Government preservation programs.
- Gave presentations to a variety of audiences, including a Whale Branch High School class, USC history, public history and archaeology classes, Francis Marion public history class, SC Department of Environmental Services Bureau of Coastal Management, Arsenal Hill Presbyterian Church, SC Chapter of the National Association of Environmental Professionals, SC 250th grants workshop, SC Chapter of the American Planning Association, Pawleys Island Planning Commission, Landmarks Conference, SC Chapter of the Afro-American Historical and Genealogical Society, SC State Library, South Carolina's 6th Annual American Revolution Symposium, and the SCDNR Heritage Trust archaeology internship program.

- Provided staff support for the SC African American Heritage Commission for quarterly meetings, strategic planning, monthly newsletter, annual conference, and special projects including development of the Commission website, National Register nominations, and the Green Book project publication.
- Partnered with Preservation South Carolina and the Office of the Governor on the [annual statewide preservation awards](#) presented by Governor Henry McMaster at the State House on June 18, 2025.
- Partnered with the SC Archives and History Foundation to hold the statewide [Preservation Conference on April 25, 2025](#), with 258 registered to attend. Also assisted the Foundation with the [Preserving Historic Cemeteries workshop](#).
- Continued to work with the SC Institute of Archaeology and Anthropology to provide SC ArchSite, the state's online cultural resources GIS. The system includes information on thousands of historic places, including archaeological sites, National Register listed properties, areas surveyed for cultural resources, sites associated with the American Revolution and Civil War, and properties included in the statewide survey.
- Facilitated online and in-person staff training through the National Park Service and attendance at professional conferences.



SCDAH BUDGET REQUEST WITH BRIEF SUMMARY BY PRIORITY

Form B1-Recurring Operating Requests

Agency Priority #1: Movement of two SHPO staff members from Federal Funds to State Funds-\$0

- For several months, the Federal government delayed the release of funding for the FY25 Historic Preservation Fund (HPF), which is administered by the National Park Service, funded from revenue accrued from offshore oil and gas leases, and the source of support for the operations of State Historic Preservation Offices (SHPOs) nationwide. Although the House and Senate may continue to fund the HPF at FY25 levels, we are seeking to lighten the burden on HPF grants allocated to the SC SHPO. We therefore are requesting a transfer of two (2) FTE staff members currently funded under Historical Services classified positions from Federal Funding to State Funds. The current line item total for State funds for Historic Services Classified Positions is \$230,976, and that amount is far greater than needed for the one (1) FTE associated with that line item. There are sufficient funds in that line item for three (3) FTEs, so we are requesting that two FTEs from the Historical Services Division (SHPO) be moved from Federal classified positions to State funds.

Agency Priority #2: Additional Funding for Insurance and DTO Technology Increases-\$175,000

- SCDAH, like much of state government, has experienced a significant increase in insurance rates in recent years. Rates regarding insurance of the agency's collections for potential damage, destruction, or replacement have increased significantly along with the cost of liability insurance for persons visiting the SC Archives and History Center.
- The agency also has been forced to contract with Department of Administration's Office of Technology Information Services for a variety of services that the agency previously could have contracted with vendors to perform.

Agency Priority #3 (Non-recurring): SCDAH Exhibit Hall and Meeting Space Expansion - \$2,000,000

- SCDAH is seeking to expand its existing exhibit hall from 600 square feet to 2200 square feet to provide space for a permanent display of the state's most important records in addition to its temporary exhibit space. This expansion also will create 1600 feet of additional outdoor event space on the rooftop of the enlarged exhibit hall, which would generate additional revenue to offset construction costs.
