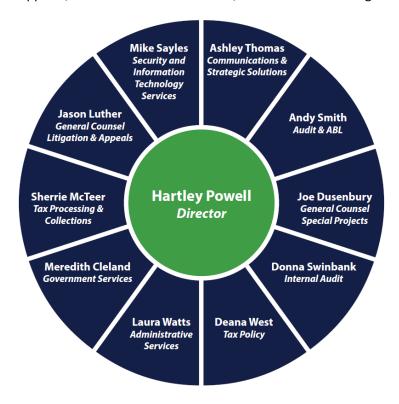

Agency Overview

History: In 1915, Gov. Richard Manning created the South Carolina Tax Commission. In 1995, the SC Legislature dissolved the Tax Commission and created a cabinet agency – the South Carolina Department of Revenue – with a governor-appointed director. The SCDOR currently administers 72 taxes and fees and collects 95% of the State's General Fund. The SCDOR has over 800 employees and 6 offices across the state.

Mission: To administer the revenue and regulatory laws of the State with integrity, effectiveness, and fairness to all taxpayers, while maintaining the highest security and protection of taxpayer information.

Major Program Areas: Tax Return Processing, Collections, Audit, Tax Policy, Litigation and Appeals, Local Government Services, and Alcoholic Beverage Licensing (ABL)
