

Christopher Olon Miller, Jr. and Hope Denae Miller's Cancer Journeys

We believe that Hope's cancer journey may have started when she was in the fourth grade. As a fourth grader, she received several diagnoses' of bronchitis and or double pneumonia, which we believe was masking a slow growing mucoepidermoid tumor in her left lung. Three years later, we moved from North Carolina to South Carolina and while running a pacer test in her seventh grade PE class, Hope started to feel sick, and the school nurse was called. That led to several doctor's visits, four bronchoscopies, and the discovery of a mucoepidermoid tumor in her collapsed and shriveled left lung. The tumor was subsequently removed along with some lymph nodes and surrounding tissue. We were excited! Hope was healed and although she would face life with one healthy lung- it was life nevertheless and one that we would get to continue experiencing with her.

We thought that our experience with pediatric cancer was over with Hope's surgery, but we were wrong. As we learned from a message that our Associate Pastor shared with the congregation not long after Hope's surgery "there were people who had climbed the mountain she and some friends were climbing and thought they were at the top, however, there was still more mountain to climb to reach the top." Forty-one days after Hope's treatment, our son CJ began suffering from high fevers, joint pain, and fatigue, and was subsequently diagnosed with acute lymphoblastic leukemia (ALL). He was admitted into the hospital that same morning and immediately began treatment at Levine's Children's Hospital in Charlotte, North Carolina. He underwent chemotherapy for 2.5 years, and unfortunately became a Type 1 Diabetic due to a severe allergic reaction to one of the chemotherapy medicines that he received.

Hope received her last cancer scan in December 2023 and was released as a patient from the Oncology Department at Levine's Children's Hospital. She has been cancer free for four years! CJ is in

Survivorship Treatment at Levine's; he goes to the children's cancer clinic for checkups every other month and must meet with the Survivorship Team once every 6 months.

Discovering Camp Happy Days

Our family discovered Camp Happy Days through our Clinical Social Worker at Levine's Children's Hospital, Juliet Galton. Juliet would send information to us about camps, and programs that would be of interest to us and could provide opportunities for our family to rest and get away from the hectic pace of life and cancer treatment. I saw that Camp Happy Days provided programming for children undergoing cancer treatment, as well as for their siblings. They were uniquely set up to provide care and counseling to both Hope and CJ as cancer survivors but also as the sibling of a cancer survivor as well.

Impact of Camp Happy Programming on the Miller Family

One of CJ's favorite memories of Camp Happy Days was attending his first Teen Weekend. As they were white water rafting, a random green plush toy airplane was seen in the water, and multiple boat crews began competing over who could win the plane. CJ also enjoys interacting with all the different people he meets at the camp, and the Teen Weekend excursions. Lastly, CJ enjoyed the food and snacks at all the Camp Happy Days events- proclaiming "the food was really good."

One of Hope's favorite memories of summer camp was the Prom. It was her first time going to the Prom and the excitement made a permanent mark on her brain. The makeup, the hair, the dresses, and even the "getting ready" was all fun. Everything was amusing and entertaining- the dancing, the food, the Photo Booth, and the bouncy house! Hope also enjoyed white water rafting for the first time at her first Teen Weekend. Although the water was freezing, she and her fellow campers, wearing wetsuits and bathing suits, rushed down the mountain and got wet. The icy water splashed on them, but they kept asking for more. It made getting sick in the end worth it as Hope will never forget the experience of white water rafting on her first Teen Weekend.

For the Miller Family, Camp Happy Days has been a continual stream of love, care, and support. We were able to go on a Family Retreat in Hendersonville, North Carolina. Rest and respite is essential when going through cancer treatment and we found out that Chris and I needed respite and rest as well as CJ and Hope. Camp Happy Days has given both Hope and CJ an opportunity to participate in outdoor activities, such as paddle boating, water-skiing, white-water rafting, camping, and zip lining, which were brand new experiences for them. Camp Happy Days also gave them an opportunity to interact with their peers while they were in virtual learning and not attending school in person. CJ is growing as a leader within the organization, serving as a Counselor In Training (CIT) for the 2023 Camp Happy Days Summer Camp, and Hope plans on joining him and becoming a CIT for the 2024 Summer Camp!

Proposal for Funding for Camp Happy Days Summer Camp, Additional Teen & Family Weekends, and New On-Site Programming 2025

Camp Happy Days' mission is to offer support and encouragement to children diagnosed with cancer and their families by providing cost-free year-round programs, special events and access to crisis resources. Our goal is to improve the physical, emotional, and psychological health of the entire family facing pediatric cancer.

We are asking for \$250,000 for the fiscal year 2024-2025 to support Camp Happy Days' programs, including our 2025 Summer Camp for 200 children with cancer and their siblings and teen and family weekend camp. Each year, an estimated 250-300 children will be diagnosed with cancer in South Carolina. While 85% of children diagnosed with cancer will survive, even survivors face numerous challenges and a future filled with fear and uncertainty. According to the American Child Cancer Organization, two-thirds of children diagnosed with cancer will experience late effects that may impair their memory and learning, growth and development, and social and psychological adjustment. These children are also at a higher risk for secondary cancers and many other health issues. One out of every four children diagnosed with cancer will have severe or life-threatening late effects. They may also suffer from high levels of anxiety, body changes such as weight gain, amputation, scarring, or disfigurement, and low self-esteem.

The requested funds will allow us to continue to reach out across South Carolina in a strategic approach to serve all children diagnosed with cancer in our state so they will be aware of the cost-free programs and resources Camp Happy Days offers. Many of these children live in more rural areas that are not near the three primary children's hospitals in the state and thus are unaware of the many services and programs available to them. We have also developed new partnerships with hospitals in North Carolina and Georgia to ensure we have reaching families near state lines. Over the last ten years, the number of individual children Camp Happy Days has served has increased by 65%.

The funds requested will support our camp's budget, increase the number of families served and provide new programming opportunities throughout the year. Our camp is budgeted at \$514,661 and covers the expenses for children to attend our week-long residential summer camp as well as our virtual camp programming. Each summer, our camp is held at Camp Bob Cooper in Summerton, SC, providing families throughout the state a central location regardless of if they are attending from the upstate or the low country. Our weekend camps budgets are over \$107,000 and provide four different weekend camp programs. In the past, we have provided a family weekend in the spring and a teen weekend before Camp. By increasing our weekend

camp budgets, we can provide an additional fall teen weekend and family weekend, allowing more families the opportunity to participate. The camps will be held throughout the state and transportation will be provided as needed to ensure families have the accessibility needed. Typically, families are provided either a bus transportation option or a gas card if needed. For many families, this is the difference on whether their child(ren) and/or family can participate in programs. We make it a priority to limit the barriers for families to attend programming that can provide crucial support and resources.

Our goal is to continue to reach and meet the needs of families battling pediatric cancer throughout South Carolina, especially in the rural areas. We seek to restore a sense of normalcy to their lives and provide opportunities for these families to connect with others who are facing similar challenges. Our objectives are to help these children and their families find a renewed sense of hope, form new supportive relationships, experience respite and relief from stress, create lasting memories, and find encouragement and inspiration as they continue their fight against pediatric cancer. Our summer camp program is a key part of achieving these goals.

The financial, medical, and psychological effects of a cancer diagnosis can impact all aspects of a family's life, including everything from their ability to buy groceries, participate in physical activities, and spend time outdoors. These limitations consequently can negatively impact a child's overall health and well-being. Due to limitations on physical activity, many become sedentary and are at risk for weight gain and weight-related issues later in life. In addition, normal social, emotional, and psychological development may be affected by the trauma of diagnosis and treatment, disruptions to school and regular social routines, and exposure to significantly increased stress on the child and the family.

Camp Happy Days' camp program seeks to address all these areas of needs for our families. Through team-building activities, counseling, and cabin chats at camp these children will meet others with similar experiences and difficulties. The bonds formed through group participation give each child a feeling of inclusion. All-camp events, like our camp prom and talent show, create an environment that fosters positive social and emotional interactions. With social and emotional needs met and skills learned from camp, children are happier and better equipped to handle life challenges and stresses. In our most recent survey, parents were asked to rate the variables related to their children's overall health on a weighted scale and against relevant criteria. The results of the survey found 79% of parents believed their child is more confident participating in physical activity after a Camp Happy Days experience. Eighty-eight percent of parents and/or caregivers agreed that they have a support system within Camp Happy Days and with other Camp Happy Days families. Parents/guardians also agreed at 86% that their family feels more hopeful and has overall benefited in their quality of life from attending Camp Happy Days programs. Eighty-eight percent agreed that their family had also benefitted from gaining a new resource or tool to help them in their cancer journey. We consider these survey results evidence of how vital CHD programming is to these children and their families.

Each year, Camp Happy Days tracks five measures that we want our campers to exhibit following camp participation. We survey the campers through self, parent, and counselor surveys. We track the measures of independence, friendship, confidence, hope, and teamwork. Over the last five years, we continue to see increases in all five measures after camp participation. Last summer, we were able to serve 189 children at our in-person camp and an additional 100 campers through virtual camp. Our virtual camp provided an opportunity to connect with campers and serve children from the safety of their homes and hospital rooms. Overall, our camp program had positive feedback on its ability to allow campers to connect with their friends and be engaged. For new families, virtual camp allowed them to meet new kids with similar experiences while also preparing parents for sending their children to camp for the following year.

"Welp, y'all have done it again! Just when we thought there couldn't possibly be any fun left to have after an amazing 1st camp experience last year, Brady came home from camp beaming earto-ear. Seriously y'all, he talked my ear off the entire way back to Charleston! Well, mostly except for the fact he had very little voice left. He excitedly told me about all the new friendships made, his amazing counselors (shoot out to Lee and Ethan), the fact that he finished the Polar Bear Plunge, the mountain of crab legs he consumed, the phenomenal inflatables, the unbelievable fireworks, his escape from the escape room, the waffle/chicken/ice cream treat at the teen lockin... and the list goes on and on and on. As always, thank you for ALL you do to create the most magical week for our kids. The friendships formed and bonds created will truly last a lifetime. As an ending note, Brady was in a real funk for about 36 hours after camp. At first, we thought he was just really wiped out from all the activity. He finally opened up that he was just really sad that it would be an entire year until he would be back at camp with all of his friends. Y'all, those are words from a 13-year-old boy. Whatever mission you set out to achieve this camp week, consider it ACCOMPLISHED. Please feel free to forward my email along to anyone who needs a pat on the back, fist bump, high five, etc." Emily, Mom of Camper

All our programs are cost-free for the families we serve, so these funds would allow us to continue to offer camp cost-free to every child who attends. This year, we will again be offering our traditional week-long camp as well as virtual camp. Staff and volunteers are working hard to create a safe and fun in-person camp experience for 200 campers this summer. The cost of sending one child to camp is approximately \$2,573. We are working year-round to raise the funds necessary to accommodate our camp and overnight programming.

Our current office has allowed us to expand our current programming, start new partnerships in the community and increase the number of children and families served through on-site programming. Last year, our programs served 1,277 families, this was an increase of 83% of families served. During this time, we provided 99 programs and events including camp and virtual camp, family weekend, three teen weekends, doodlebug and preteen events, hospital programming, virtual events, family activities, holiday giving, and much more. CHD served a

total of 3,854 children and parents/guardians which was more than double the number of (duplicated) individuals from the previous fiscal year. We expect this growth to continue as we create more program opportunities and foster new partnerships.

Last year, we started a new partnership with Amor Healing Kitchen to provide free healthy meal deliveries to families with a child currently on treatment. So far, this partnership has helped deliver 730 meals to children diagnosed with cancer and their families. Our programs team has also focused on providing increased support to children currently in the hospital. During our last fiscal year, CHD served over 230 children and families with hospital programming that brought joy, support, and opportunities for healing to children spending long periods of time in the hospital. This has been crucial in allowing us to not only serve more families but also to connect with new families in the hospital. Another area of growth was providing new on-site programming. We were able to host our Halloween event, Kit Kid Fridays with Yoga, and family events including High Tea, game night, and a tailgating event. We also provided our first preteen lock in event at the office. Overall, we served over 100 children and parents/guardians with on-site programming.

Camp Happy Days strives to provide high-quality, meaningful experiences for the children and families who participate in our programs and events. To measure the effectiveness and evaluate outcomes for this program all counselors, parents, and children receive a post-camp survey designed to measure perceived changes in a child's attitude and behavior within 45 days after camp. The information gathered is used to measure progress and identify areas where improvement in the quality of the experience and operational efficiency can be achieved. Camp Happy Days is proud to share this information about our impact and effectiveness as it is received.

"I was very nervous the first time I went to camp. I didn't know what to expect and was used to being close to my parents though my cancer treatment. The doctors and nurses at MUSC showed me pictures of camp and assured me they would be there for me. Reluctantly I went. It was the first time away from home, and spending so much time outdoors. When you are in treatment, you have to be careful so much and worry a lot. But at camp, you are safe to be a kid again and do so many things you would never have an opportunity to do at home. Tubing on the lake is my favorite. But also so many fun, and new things to do. But the friendships you make at camp are the most important part, and the hardest to explain to people who never went. Camp is a place where you can go and meet some of your best friends for life. Year after year, they provide a

break for kids who need it the most. Some of my best memories were made at Camp Happy Days! Soon I will be returning as a counselor. I can't wait to reunite with all my friends and share the week with the new kids who come." Danny, Camper

MISSION & HISTORY

Camp Happy Days' mission is to offer support and encouragement to children diagnosed with cancer and their families by providing cost-free year-round programs, special events and access to crisis resources. Our goal is to improve the physical, emotional, and psychological health of the entire family facing pediatric cancer.

- 82% of all funds raised go directly to children and families with 18% going towards administrative and fundraising expenses.
- Camp Happy Days serves more children with cancer and their families than any other nonprofit in South Carolina and is the only organization that offers these services to children with cancer and their families across the entire state.

NEED

Imagine hearing that your child or a family member's child has cancer. You can imagine the emotions that you would feel, but do you really know what it means to a parent to hear their child has cancer. For 250 families in South Carolina this year, they will hear this devastating news. The average age of a child diagnosed with cancer is only six years old, and even though most will survive, all will deal with the physical, mental, and emotional long-term. effects brought on by a cancer diagnosis. Children diagnosed with cancer are at higher risk for depression and anxiety, isolation, loss of self-confidence and independence and reduced physical activity (Journal of Cancer Survivorship, 2023). These risks can negatively impact the child's quality of life and impact the whole family. Camp Happy Days understands what these children and families go through because we have been at their side providing emotional and psychological support for over 40 years. These children and their families are a part of a much bigger family of staff, volunteers, and the community who come together for one another and fight against pediatric cancer and its consequences. We are asking for \$250,000 in funding for the 2024-2025 fiscal year. This funding will support Camp Happy Days' programs, including our 2025 Summer and Virtual Camps. We expect over 200 children with cancer and their siblings to attend in-person camp and 100 campers to participate in virtual camp. The funding will also support programs for families, teens, and young children held across the state throughout the year.

GENERAL PROGRAMS

To help address the emotional, psychological, and financial needs of these families, Camp Happy Days has developed specialized programs which are available to families without cost. Our goal is to provide hope, inspiration, respite, emotional support, and access to crisis resources for all families in SC affected by pediatric cancer. We work with the entire family to help them through the complex process of having a child diagnosed with cancer. Battling cancer during childhood can be especially destructive for the child's psychological growth and development. Research has shown the positive impact programming for pediatric cancer patients has on the child and their families' overall well-being. According to the American Camp Association, "By making minor adjustments to programs and providing children with recreational activities, they are able to receive many benefits as well as learn coping skills necessary to face the many issues brought on as a result of their diagnosis and treatment process." Our families' feedback confirms program participation has provided support and created hope for their child which is crucial when dealing with the adverse side effects of a cancer diagnosis. Our programs are designed to provide a source of comfort, support, and encouragement during this frightening and chaotic time. Our new programming planned at our office and in the hospital will allow us to continue to better serve the needs of our families.

CAMP

Camp Happy Days has been hosting an annual week-long summer camp in Summerton, SC for children with cancer and their siblings since 1982. During this week-long program, South Carolina children who are facing the hardship of cancer diagnosis, personally or through their sibling, can focus on being a kid. Children with cancer often undergo treatment causing them to miss months of school and other important events, severely limiting their peer interaction. Even their siblings may have their social and educational routines disrupted if parents and caregivers must focus on providing care for the child with cancer for an extended period. Camp provides a safe and inclusive environment for peer interaction and support. Camp activities are intentionally designed to challenge physical boundaries, encourage teamwork, provide therapeutic outlets, and boost self-confidence. Campers can engage in a variety of activities, such as the climbing wall or water sports, that may not otherwise be available to them. Camp Happy Days provides comprehensive medical supervision to protect all campers, while allowing them to feel independent. The support and relationships formed during camp provide these children with a priceless experience, and the support to take with them on the journey ahead. Camp Happy Days' number one goal is always to improve the overall health of children and families battling cancer in South Carolina. By addressing their physical, social, and emotional needs, we can help our families develop the social and emotional skills that can lead to happier and more productive lives.

- Offering therapeutic programs and activities including play and art therapy, Yoga for children, overnight lock-ins, pre-teen and teen programs, family movie nights, family day events hosted throughout the year, and so much more.
- Offer programs and events that will allow us to better serve specific populations such as siblings, teens, and parents.
- Sibling & Teen Support Groups utilizing self-expression and emotional release activities such as journaling, painting, music therapy and wellness classes. We will also incorporate opportunities for fun through games, movie nights, cooking classes yoga, and other activities these specific groups can do together.

Bereavement Programs

- Offer specific programming designed to support bereaved parents & siblings that lose a child to cancer. This population is at high risk of experiencing extreme guilt, depression, anger, resentment, and isolation.
- For bereaved siblings, we will offer therapeutic activities which include arts, crafts, games, and journaling. The goal of these activities will be communicating or working through the death of their brother or sister.
- For bereaved parents, it will allow for bonding and support as well as one-on-one care if needed.
- Host programming for the entire family unit so they can learn ways to cope through the grief process as a family.
- We will collaborate with similar organizations that provide grief programs such as Bridges of South Carolina and Camp Hands of Hope.

Parent and Sibling Programs

- Host parent day and night events, sibling day programs and overnight events.
- Our future goal is to host a siblings-only weekend and parent's weekend.



Camp Happy Days Programs Descriptions

Day Programs

Doodlebug Programs

Programs designed for children and their siblings ages 0-9 years old. Doodlebug programs are held throughout the year and allow families to engage in fun activities with other families, Camp Happy Days staff, and volunteers.

Pre-teen Programs

Programs designed for children and their siblings ages 10-13. Our pre-teen programs are held throughout the year and provide children and their siblings the opportunity to reconnect, participate in fun therapeutic activities, and bond with other pre-teens who are going through a similar experience.

Family Events

Camp Happy Days staff and volunteers host quarterly activities for CHD families to participate in together. Activities include game nights, movie nights, and family dinners.

Holiday Festival

A signature holiday program for Camp Happy Days families to gather and celebrate the upcoming holidays.

Overnight Programs

Camp Happy Days Overnight Weeklong Summer Camp

This weeklong, flagship event in Summerton, SC is for children diagnosed with cancer and their siblings, ages 5-16. This powerful, life changing experience helps children build self-esteem, courage, confidence, and trust in an incredibly active, high-energy environment designed just for them.

Family Weekends

Twice a year, Camp Happy Days host a overnight weekend programs designed for Camp Happy Days families where they have the opportunity to connect, learn, share, and experience the magic of camp together.

Extreme Teen Weekends

Teen weekends are designed for teenagers and their siblings ages 13-18. This program allows teens to interact with one another, share experiences, and engage in a variety of fun activities. Teen weekends are hosted twice a year, one in the fall and one in the spring.

Hospital Programs

Happy Hospital Days at MUSC

Camp Happy Days staff and volunteers bring the CHD experience to the hospital. Once a month, we spend the day at MUSC Shawn Jenkins Children's Hospital doing crafts and activities with the patients on the pediatric oncology unit. During a hospital stay, families can request a special visit from Camp Happy Days staff and volunteers. Families can choose to receive a nice meal, make their favorite craft, play games, or have story time.

Outpatient Clinic Visits - FACT Clinic & Brain Tumor Clinic

FACT Clinic

Camp Happy Days provides healthy snacks and activity bags 24 times a year for patients and families who attend. Follow-up After Cancer Treatment (F.A.C.T Clinic), a comprehensive clinic for long-term pediatric cancer survivors at MUSC Children's Health Summey Medical Pavilion.

Brain Tumor Clinic

Camp Happy Days brings arts and crafts activities and healthy snacks to patients and families during their clinic visit. Brain Tumor Clinic occurs monthly at MUSC Children's Health Summey Medical Pavilion for children who have recently finished treatment for a brain tumor.

Family Resources

Family Financial Assistance

To ease the financial strain that pediatric cancer puts on families, Camp Happy Days provides financial assistance to qualifying families to assist with bills, groceries, gas and other everyday needs.

Holiday Giving

Volunteers, donors, and friends of Camp Happy Days sponsor a family or a child diagnosed with cancer, to help fulfill their children's holiday wishes.

Virtual Programs

Since 2020, we have developed a variety of virtual programming that is available to all Camp Happy Days children and their siblings. Virtual programming has provided a safe space for all CHD families to interact with each other, even from afar.

Virtual Camp

Virtual Camp takes place in June each summer. Each camper receives a special themed box that includes all items needed for the entire week of camp! These boxes are filled to the brim with opportunities to bring the benefits of Camp to their home and engage and connect with their camp family Virtual Camp has not only allowed us to serve children at their homes but also to start serving children in the hospital or currently guarantined due to their treatment plan.

Virtual Doodlebug Bedtime Stories

Doodlebug Bedtime Stories take place once a month for children and their siblings ages 0-9. Each month is geared toward a different theme including a fun children's book and activity. Our goal is to connect, learn, and laugh together.

Camp Happy Days is a life-changing organization that serves children with a diagnosis of cancer and their families. Not only do they support the patient, they offer their services and support to the entire family unit and continue to provide care long past diagnosis.

Camp Happy Days is at its heart a camp for children with complex medical issues. Children with cancer and their siblings attend a week of fun filled events – cost free – every year until the age out. Each year, we open up a mini-clinic and hand out meds, wrap ankles, treat bug bites, administer types of chemotherapy, suture lacerations – the list is endless! I am amazed by what we are able to accomplish without having to remove the kids from the fun! All of our supplies are donated from members of the community or provided for by monetary donations - and without those donations we would not be able to provide the care that we do. Nurses and physicians from the community volunteer their time to come and be with the children at camp and care for them. It is a great honor and a humbling privilege for parents to give up their sometimes medically fragile children to us for a week - all so they can have an amazing week of fun – and hopefully forget for a little while that they are sick or different from other children. At camp, we see these children full of life and being their true selves. It renews our commitment to our profession and gives us the "positive vibes" we need to tackle the really hard days.

As kids age, many become counselors themselves and use their prior experiences as campers to help a new generation of campers. Camp is a life-changing, eye opening experience to say the least. I cannot imagine my life without Camp Happy Days, and I know the campers and families would agree.

Camp is a gift for everyone, but as a medical provider, I speak for the whole team when I say it is a true gift for us. We take care of these children in the hospital, when they are sick or getting treatments, and in clinic when we are hoping for good scan results after another round of chemo – we don't get to see them having fun and playing like kids should – until we come to Camp!

The entire family is served by the camp. Patients get to come and be amongst their peers who understand what it's like to be sick with a complex diagnosis. They are treated like "normal" children. Siblings who come to camp are surrounded by other kids who know exactly how it feels to have their family's life turned upside down by this diagnosis. Watching these children form lifelong relationships with their "camp family" is magical. The parents get a week of respite— no doctor's appointments, no medicines to give out, no having to go to work and worry if they will have to leave because their child is sick in the hospital. Parents tell me they look forward to this week just like the kids do — sometimes I think even more so. They work around the clock to care for their children and keep them healthy and safe, often at the expense of their

own health, self- care and relationships — Camp gives them the renewed energy and inspiration to take on another year of caring and advocating for their kids. These parents hand us their greatest gifts — their children — and say, "we trust you with our babies…now go have fun."

During the COVID 19 pandemic, Camp Happy Days found different ways to still bring camp to our patients in the hospital, in clinic and at home. They participated in different virtual activities and connected with each other everyday for a week. Everyone was very excited. The team at Camp Happy Days always looks for ways to bring a smile on everyone's face no matter the times. It makes our job a little easier.

Camp Happy Days also help with our survivorship clinic and comprehensive brain tumor clinic. When patients are more than 5 years off therapy, they transfer to survivorship clinic and they are seen until they are 30 years old. Camp Happy Days is bringing snacks and activity bags to each survivorship clinic which is twice a month. These help patients and parents a lot during busy survivorship clinic days. These activity bags are geared towards the patient to help with the anxiety of being in clinic and making it go smoother. It is great help for us and the patients.

They are constantly expanding and adding additional ways to help these families and that requires significant funding for sure. Without the generous donations and funding made to Camp Happy Days each year, these programs would not be able to be offered. They are a wonderful organization that truly strives to be available, in whatever capacity, for these children and their families.

As the Division Chief for Pediatric Hematology/Oncology and the Director of Pediatric Blood and Marrow Transplantation here at MUSC, I am privileged to work with children and families from all over our state. We are thrilled to be able to serve the children of our state as a top-ranked pediatric cancer center, recently ranked 14th in the country for outcomes by US News and World Report.

I can tell you that looking into parents' eyes and telling them that their child has cancer is a soul-wrenching task. The emotions and hurt in that moment are beyond words. A childhood cancer diagnosis is life-changing for the entire family. While treating and guiding children and families through intense therapy, it is critical that they have positive support to help them keep fighting and sustain their battle. Their childhood innocence has been quickly stripped away, and they are thrown into a world of difficult treatments.

Camp Happy Days provides that shining light of support to keep them fighting. These are children who have to miss so much of normal childhood, and the week of camp provides them a chance to simply be a child again. The simple joys of things like fishing, camp games, and fun pranks on counselors in the dining hall are enough to keep them fighting for the battle they have to face.
