

- There are 21 vacancies (a 33.8% vacancy rate) within the Continuum of Care division. Children's Advocacy has committed to filling vacancies within the Continuum of Care Division as outlined in the Annual Accountability Report.
- There is a 13% vacancy rate within the Guardian ad Litem Program as of November 30, 2023. There are approximately 20 TLE positions within the Guardian ad Litem Program. This program needs additional FTEs.
- The Foster Care Review Division (including Heart Gallery), Investigations Unit, Critical Investigations Unit and Administration are fully staffed with no vacancies as of December 31, 2023. Additional FTEs are needed for the Heart Gallery (1 FTE) and the Investigations Units.

The majority of the agency's carryforward funds are part of the Guardian ad Litem Program's budget. These funds are being used to supplement the Guardian ad Litem Program's state allocations for salaries, advertising, attorney contracts, leases, and other operational expenses. For example, the Guardian ad Litem Program procured a new case management system in FY23 with carryforward funds.



Cost Savings Plan

- A general fund reduction would be achieved by maintaining five (5) vacancies within the Cass Elias McCarter Guardian ad Litem (GAL) Program.
- Children's Advocacy is taking measures to prevent a deficit due to mid-year reductions or reduced revenues.
- In FY21, a proviso modification was granted to allow DCA greater flexibility with Guardian ad Litem Program Trust funds. This would be significant for the agency as a whole if there are budget cuts.
- The GAL Program applies for a VOCA grant each year and offsets state allocation requests through federal funding for contract attorneys and training.
- DCA will continue to explore ways to reduce costs and reinvest those savings within the agency to better serve the citizens of South Carolina.
