

2022-23 EIA Recommendations Summary

Adopted by the SC Education Oversight Committee (EOC) December 2022





Unfinished Learning from Pandemic

- Concurring with the SC Department of Education's request, using the \$30.0 million in current year surplus to update instructional materials for students, with priority placed on subject areas with new standards.
- Allocation of resources totaling \$4.8 million to identify gaps in student learning in specific math content/skills and corresponding teacher strategies to support teaching and learning.
- Increase in funding of \$20 million to support ten additional contract days for teachers in 227 Literacy Project Schools. The additional days would be used for professional learning in either reading or math instruction.
- Funding of \$15 million for LETRS (Language Essentials for Teachers of Reading and Spelling), a proven professional learning program designed to give teachers the content and principles of literacy and effective language.
- Additional funding of \$300,000 for the SC Department of Education to pilot the feasibility of requiring a passing score on a rigorous test of scientifically research-based reading instruction and intervention and data-based decision-making principles, as determined by the State Board of Education, for initial early childhood and elementary education licensure.

College- and Career-Readiness

- Pilot and implement an Artificial Intelligence (AI) high school curriculum, to include a pathway for students interested in automotive AI, using a recommended increase of \$3 million.
- Increase funding for Career and Technology Centers (CTEs) by \$5 million to purchase necessary equipment for pathway programs that are tied to industry certifications.
- A recommendation to include an additional \$100,000 in the SC Department of Education's Adult Education office to focus on career services in Allendale, Hampton, and Jasper counties.
- An allocation of \$1.5 million for a partnership between the SC Department of Education and the College Board to improve college- and career-readiness of secondary and middle school students, expanding the access to Pre-Advanced Placement courses across the state.

Teacher Recruitment and Retention

- The EOC recommends additional money be allocated from within EIA to support increasing the teacher supply stipend of \$300.
- An increase of \$1 million to the Center for Educator Recruitment, Retention and Advancement (CERRA) to expand the Teaching Fellows program.

Revisions to Current Provisos

1A.45. (SDE-EIA: Teach for America SC) Because Teach For America SC receives EIA funds in the current fiscal year, school districts that partner with Teach For America SC are required to provide to Teach For America SC by September first annually, information on the prior year's academic achievement of students who were directly taught by Teach For America corps members. The information must be in a format that protects the identity of individual students and must include state assessment data as appropriate. The Department of Education is directed to provide de-identified student-level summative assessment data to the Education Oversight Committee that can be used to evaluate the effectiveness of all EIA-funded programs or initiatives that provide direct services to schools or school districts. The data-sharing agreement entered into by the two agencies must define how the summative assessment data will be analyzed to determine the impact of the EIA-funded program or initiative and how the analysis will be shared with the Department of Education and with the General Assembly pursuant to Sections 59-6-10 and 59-6-110.

1A.21. (SDE-EIA: Accountability Program Implementation) To support implementation of the accountability program, the Education Oversight Committee may carry forward unexpended Education Accountability Act funds authorized specifically for the administration of the Education Oversight Committee. For the current fiscal year the Education Oversight Committee may carry forward prior year EIA Education Data Dashboard funds. South Carolina Community Block Grants for Education Pilot Program funds not awarded by the grant committee. These funds must be used for an independent common evaluation of each awarded grant to ensure high quality programs that maximize a return on the states investment.

New Recommended Provisos

To maximize the effectiveness and to minimize cost, the Commission on Higher Education is required to collaborate with the Education Oversight Committee and the SC Department of Education to develop and build out the online educator report card by expending up to \$350,000 in funds carried forward from the 2022-23 fiscal year into the 2023-24 fiscal year by the Education Oversight Committee for implementation of the Education Data Dashboard.

1A. Of the funds appropriated for assessment, the Department of Education will expend \$300,000 to pilot the feasibility of requiring a passing score on a rigorous test of scientifically research-based reading instruction and intervention and data-based decision-making principles, as determined by the State Board of Education, for initial early childhood and elementary education licensure.



The existing proviso allows the EOC carry forward authority for the Community Block Grants, a program which is no longer in operation within the agency. With the assistance of Procurement staff at the SC Dept of Administration, the EOC has initiated a Request for Information (RFI) for the Education Data Dashboard, trying to identify partners and vendors for the project. Recognizing that the procurement will take time this fiscal year, the EOC requests that this funding be permitted to carry forward into the next fiscal year.

Amending the current proviso would allow the agency to carry forward the Education Data Dashboard funds, recognizing that the procurement time period will not allow the expenditure of the bulk of the funds this fiscal year.

	The agency receives no General funds, so there would be no impact. Any reduction would occur in the agency's administrative budget.

	The EOC receives a base appropriation amount of \$1,293,242 of EIA revenues. Of this amount, Proviso 1.106 in the 2022-23 Appropriations Act directs the EOC to pilot an Education Dashboard; the agency received \$3,500,000 in EIA funds for that purpose. Funding of \$1,000,000 also is received in the agency budget, and is to be distributed to Save the Children by proviso.
	\$500,000, by proviso 1A.46, is allocated to the SC Autism Society.
	The EIA base recurring balance, \$1,293,242 would absorb any three percent reduction. The EOC would use its contingency fund to offset any shortfall in EIA revenues. Annually, the EOC sets aside 10 percent of the funds appropriated in a contingency fund to absorb any mid-year reduction in EIA revenues or to offset unexpected expenses. There would be no impact on service delivery.
	The increase of \$3,500,000 to the EOC budget is for the agency to pilot an Education Data Dashboard, increasing the opportunity for education data to become actionable among various stakeholder groups. We have initiated a Request for Information with SC State Procurement at present. This project will necessitate the addition of two new FTEs to the agency, which will require additional funds to be moved into the Personal Service budget lines.
SUMMARY

With the addition of the Education Data Dashboard pilot, the EOC's operating budget is approximately \$4,793,242. The agency already operates very efficiently and plans to continue this practice as the duties of the agency expand. The EOC plans to bring in two FTEs for the dashboard, but the intention is to use agency resources. We are planning to turn all available space in our office into office space and utilize an empty office in the Brown Building for storage.

AGENCY COST SAVINGS PLANS

Currently, the agency is reducing costs by procuring several evaluations using other state entities (currently contracted with Clemson University on Kindergarten Readiness Assessment review) or utilizing the services of retired district superintendents.

To further reduce costs, the agency contracted with the Department of Administration to perform financial and reporting functions in Fiscal Year 2020-21. In early 2021, the EOC added Human Resources and Benefits services to its shared service agreement with Department of Administration. This shared service arrangement continues to reduce expenses by allowing staff to dedicate resources elsewhere.

METHOD OF CALCULATION	The Department of Administration began providing finance and accounting services, procurement services, budgetary services to the EOC at an annual cost of \$30,600 in FY 2019-20. When the agency's parttime business manager resigned, the EOC did not believe that it could hire another parttime employee to perform these functions, and instead would have had to hire a fulltime employee, an Accountant/Fiscal Analyst I, at an estimated annual cost of \$61,700, which includes salary, fringe benefits and operating expenses. Therefore, the savings to the state are estimated at \$31,100. In October 2020, DOA agreed to add Human Resources and Benefits services to the EOC's shared service agreement at no additional cost to the agency. This Shared Service arrangement has been beneficial to the agency, allowing staff time to be devoted to other agency activities.

The Education Data Dashboard, which the EOC is required to produce under proviso, is currently in the procurement phase. There is no current agreement in place or savings to report; however, the ongoing talks are in the spirit of making wise use of State funds to support all State-led initiatives.

AGENCY'S DISCUSSION AND ANALYSIS

The last three years have presented us with an unprecedented set of challenges in public education. Yet, we see progress and cause for hope as we navigate the changes to the education landscape. The most recent release of test scores results from the 2021-22 school year shows that South Carolina students are on the road to recovery, having rebounded to pre-pandemic levels in English Language Arts. While pre-pandemic levels of achievement are far from the destination of proficiency for all students, the recovery in a critical area is noteworthy.

Achievement and growth scores in math are concerning. Over 40 percent of eighth graders scored *Does Not Meet* on the mathematics portion of SC READY, indicating that they are two grade levels behind their peers meeting standard. Students of color and students who live in homes that lack financial resources fare even worse. We acknowledge that many students and families are struggling; equipping schools to make informed decisions will assist in continuous improvement and lead to better student outcomes. The children are our inspiration to do the work we do – we believe in their potential, and we want every child to have the opportunity to succeed. Our goal is to provide an environment where there are no barriers to any child's success and opportunities exist for every student to achieve college and career success.

Strategy I: Report Facts

To support all stakeholders in making informed decisions for the continuous improvement of schools and student outcomes, the EOC will advocate for, access, and use a comprehensive, quality, statewide data system

Objective A: Enhance the EOC's direct access to comprehensive, quality, statewide data for reporting information

- Advocate for EOC staff to have secure, administrative-user access to Student Information System data
- Institute processes for EOC staff to have co-equal access to files that contain student-level data used for accountability
- Establish quality control processes to ensure accurate accountability reporting
