Under the Every Student Succeeds Act (ESSA) the US Department of Education allows states to retain three percent of funds for direct student services. This new provision has allowed the agency to utilize existing federal funds to provide these services to students and target areas of high need. Additionally, the agency has worked to better blend state and federal funding to maximize services to districts and students, thus requiring less additional funding from the state. Further, the agency is working to streamline requirements and obligations of districts in order to ensure that both the agency and districts have the opportunity to spend less on overhead which will allow for more funding to get to the classroom. While this is not a reduction in current levels of state funding, it is a better utilization of existing tax dollars that our citizens are paying to the Federal Government.
