District Initiatives

Recruiting and Retaining High Quality Educators

- Limestone University established an M.Ed. Program which may serve as an opportunity for educators teaching at charter schools authorized by LCA to earn a master's degree as well as endorsements.
- Limestone University in partnership with the Association, will provide this opportunity at no expense to participating LCA certified teachers.

Policy Issues

Charter Act

LCA supports changes to the Charter Act that will:

- Clarify the transfer process and the role of the State Department of Education in that process
- Include a neutral third party to hear appeals on transfer requests, such as the Administrative Law Court
- Includes a clear registration process for higher education authorizers, establishes monitoring and oversight of charter authorizers and clearly articulates steps that may be taken by either the State Department of Education or the State Board of Education when there is a reason to revoke an entity's ability to serve as an authorizer
- Mandates that all authorizers clearly establish sanctions, short of revocation, that may be used when a school is out of compliance in their policies, which must be approved by their board.

Background Checks

- The Governor vetoed Proviso 1.99. His veto message raised concerns that state law does not currently require or authorize school districts or schools to complete a background check supported by FBI fingerprints non-certified educators.
- We are working with SLED to ensure that language is updated so that these background checks may be completed on all educators employed.
