<b>PROPOSED PROVISIO TEXT</b>	<p><b>1A.25.</b> (SDE-EIA: Professional Development) Of the funds appropriated for professional development, up to \$500,000 may be expended for gifted and talented teacher endorsement and certification activities. The Department of Education <del>must</del> <u>shall</u> provide professional development on assessing student mastery of the content standards through classroom, formative and end-of-year assessments. <u><b>Additionally, funds shall be used for the provision of professional development for computer science standards, early literacy and learning and school safety.</b></u> The Department of Education also must post on the agency’s website the South Carolina Professional Development Standards and provide training through telecommunication methods to school leadership on the professional development standards. The department is authorized to carry forward and expend professional development funds for the same purpose.</p>
